### Note 1: Description of Plan

The following description of the VerHalen, Inc. Profit Sharing and Salary Savings Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution profit sharing plan covering substantially all nonunion employees of VerHalen, Inc. (the "Company"), who have three months of service and are age 19 or older. Prior to January 1, 2024, the minimum age requirement was 21 years. Upon satisfying eligibility requirements, an employee is eligible to participate on the first day of the following calendar quarter (January 1, April 1, July 1, and October 1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The investment committee is responsible for the oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### Contributions

Each year, participants may elect to contribute to the Plan up to 100% of their eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Rollovers are not matched. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect another deferral rate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Each year on July 1, deferral elections for all participants will automatically increase by 1%, up to a maximum of 10%, unless a different election is made.

Effective January 1, 2024, the Company makes safe harbor matching contributions. Prior to January 1, 2024, the Company made discretionary matching contributions. The Company may also make discretionary profit sharing contributions. For 2024, the Company made safe harbor matching contributions equal to 50% of the first 6% of eligible compensation that a participant contributed to the Plan, which totaled \$499,585. Also for 2024, the Company made a discretionary profit sharing contribution equal to 2% of eligible compensation that a participant contributed to the Plan, which totaled \$317,903. Participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year to be eligible to receive the Company's discretionary profit sharing contribution.

#### Participant Accounts

Each participant's account is credited with the participant's voluntary contributions, Company matching contributions, and allocations of (a) Company discretionary profit sharing contributions, (b) plan earnings or losses, and (c) forfeitures of terminated participant's nonvested accounts. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Effective January 1, 2024, participants are vested immediately in their Company contributions plus actual earnings (losses) thereon. Participants who were no longer active employees of the Company as of January 1, 2024 remain vested in the Company contribution portions of their accounts under the vesting rules in place prior to that date. In addition, participants become fully vested upon death or disability.

Prior to January 1, 2024, vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings (losses) thereon, was based on years of continuous service. Participants become vested at 10% upon attaining the first year of credited service. Participants then vested at a rate of 20% per year, beginning with the second year of credited service. Participants became fully vested after six years of service. Participants were considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during a plan year.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have two loans outstanding at any given time. Note terms range from one to five years, or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account or other security if the note is for the purchase of a primary residence. The notes bear interest at rates ranging from 3.25% to 8.50% at December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

Plan benefits are available at normal retirement (age 60), disability retirement, death, or termination of employment with vested interests. Participants may elect to receive benefit payments in the form of a lump-sum distribution or in installments. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. Forfeited nonvested accounts totaled \$290 at December 31, 2024 and \$7,785 at December 31, 2023. These accounts can be used to reduce Company discretionary matching and profit sharing contributions or to pay plan expenses, with any remaining balance reallocated to participants. During 2024, forfeited accounts of \$47,748 were used to offset Company discretionary matching contributions.

#### **Secure 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are included in administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses and Investment Management Fees**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses.

Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other administrative expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### **Subsequent Events**

The Plan as evaluated subsequent events through July 28, 2025, which is the date that the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Stable value collective trust fund:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value ("NAV") of units of the bank collective trust, which is based on the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidation will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company ("Matrix"), the Trustee of the Plan.

### Note 5: Party-in-Interest Transactions

OneAmerica Retirement Services, LLC ("OneAmerica") is the recordkeeper of the Plan and, therefore, fees paid to OneAmerica qualify as party-in-interest transactions. Fees paid by the Plan to OneAmerica for recordkeeping services were \$43,685 for 2024.

Nicolet National Bank ("Nicolet") is the Plan's investment advisor. Fees paid to Nicolet qualify as party-in-interest transactions and totaled \$50,726 for 2024.

Certain fees incurred by the Plan are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated August 19, 2020, which states the non-standardized pre-approved plan document as then designed is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and profit sharing contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
