## INDEPENDENT AUDITOR'S REPORT

To the Investment Committee and participants of the  
Anverse, Inc. Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Anverse, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### 1. Description of Plan

The following description of the Anverse, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Anverse, Inc. and Georgia Museums, Inc. (collectively, the Company). Employees become eligible to participate upon attaining the age of 21 and having completed three months of service. Newly eligible employees are automatically enrolled in the Plan on the first day of each month with an initial pre-tax deferral contribution of 6%, unless the employee elects otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Reicon Management, LLC (Reicon) is related to the Company through common management. Reicon maintains its own benefit plan, Reicon Management, LLC Retirement Savings Plan (the Reicon Plan). A person is considered an employee of the Company or Reicon based on the location of his or her job and is allowed to participate in the applicable benefit plan. If a change in job location causes an employee to change employers and therefore also cause a change in benefit eligibility, the Company can transfer the participant's existing account to the other plan. For the year ended December 31, 2024, \$2,092 was transferred out of the Plan and into the Reicon Plan. There were no transfers from the Reicon Plan to the Plan for the year ended December 31, 2024. The Plan allows for predecessor employer service to be considered credited service for purposes of eligibility in the Plan. The previous employers that predecessor employer service applies for are Reicon Management, LLC, Georgia Museums, Inc., Reicon Capital, LLC, and DTate.

#### Contributions

Each participant may make pre-tax and/or Roth contributions of up to 50% of eligible compensation and may make after-tax contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus up to an additional \$7,500 catch-up deferral for participants who have reached at least 50 years of age by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective October 1, 2024, participants may also make voluntary, non-deductible, after-tax contributions of up to 100% of eligible compensation. In 2024, a participant may have total contributions to the Plan in the amount of \$69,000, or \$76,500 if eligible for catch-up contributions.

The Company may make discretionary matching contributions. For the year ended December 31, 2024, the Company approved a matching contribution amount of \$0.50 for each \$1 contributed by the participant up to the first 6% of the participant's total eligible compensation. The Company may also make discretionary non-elective contributions.

Participants must be employed as of the last day of the Plan year to be eligible for any discretionary non-elective contributions. For the year ended December 31, 2024, the Company did not make any discretionary non-elective contributions.

The Plan document allows In-Plan Roth rollover conversions, for any participant who is still employed. The In-Plan Roth conversions can be any portion of their account which is fully vested, not part of an outstanding loan balance, not currently distributable, and not designated as Roth contributions.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, earnings or losses on the investments in their account, and is charged with transaction fees for services received by the participant and certain administrative expenses. Participants direct the investment of their account into various investment options offered by the Plan. The Plan also offers a self-directed brokerage account as an additional investment option for participants. As of December 31, 2024, no participants have elected to enroll in the self-directed brokerage account. Participants may change their investment option on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Participants vest 20% per year in the Company's contributions beginning with the completion of their second year of service and are fully vested after 6 years of service.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have 2 notes outstanding at any time. The notes are secured by the balance in the participant's account. At December 31, 2024, notes had fixed rates ranging from 3.25% to 8.50% for the term of the note, not to exceed 5 years unless used for the purchase of the participant's primary residence. Principal and interest are paid through payroll deductions. All notes must be repaid immediately after termination of employment or death. During 2024, deemed distributions of loans totaled \$5,120. Notes receivable from participants qualify as party-in-interest transactions.

### **Payment of Benefits**

On termination of service due to death, disability, termination of employment or retirement, a participant, or their beneficiary, whose vested balance exceeds \$5,000, may elect to receive payment of the vested interest in their account in a lump-sum distribution. If a participant terminates employment and has a balance of less than \$5,000, the participant will automatically

receive a lump-sum distribution equal to the value of their account. In-service withdrawals are also permitted for participants who have attained age 59½ or for certain hardships situations.

Effective November 12, 2024, the Plan implemented new optional withdraw provisions for eligible participants related to the SECURE 1.0 Act and SECURE 2.0 Act. Specifically, the optional withdraw provisions allow for withdrawals related to certain qualified births or adoptions, emergency expenses, federally declared disasters, and domestic abuse victims.

### **Forfeited Accounts**

Forfeited non-vested account balances totaled \$1,059 and \$3,900 as of December 31, 2024 and 2023, respectively. These accounts may be used to pay administrative expenses or to reduce future Company contributions. During 2024, the Company used forfeitures of \$13,053 to offset Company contributions. No forfeitures were used to pay for administrative expenses in 2024.

### **Administrative Expenses**

The Company pays certain administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses. Participants pay a flat fee of \$5 quarterly for administrative expenses of the Plan related to recordkeeping services. These expenses related to recordkeeping services are paid to a service provider of the Plan qualify for party-in-interest transactions. Certain transaction fees are charged directly to the participant. Investment related expenses are included in net change in fair value of investments.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company's discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the administrative committee. Company discretionary non-elective contributions are payable to the Plan after approval of the administrative committee.

### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on those investments. Interest income is recorded when received.

### **Notes Receivable from Participants**

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make notes receivable repayments and the plan administrator deems the notes receivable to be in default, the notes receivable balance is reduced, and a benefit payment is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

### **4. Investments**

Plan investments include mutual funds, a money market fund, and a stable value fund managed by Fidelity. Fidelity is the Plan's qualified institution; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Investments are exposed to various risks, such as market, interest rate, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, etc. It is at least reasonably possible that changes in their fair values will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund which trades daily at the net asset value (NAV) per share of the fund (Level 1).

The stable value fund has redemption restrictions that limit the timing of withdrawals. Participant directed withdrawals may be made on any business day, provided that the exchange is not directed into a competing fund. Transferred amounts must hold a non-competing investment option for 90 days before funds may be transferred to a competing fund. In addition, redemptions of the stable value fund directed by the Plan must be preceded by twelve months written notice to Fidelity.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company's contributions.

### 6. Income Tax Status

In May 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized PreApproved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management). The Internal Revenue Service has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt and has no income subject to unrelated business income tax. The Plan's returns for the past three years are subject to examination by taxing authorities and may change upon examination.
