We have performed audits of the financial statements of JVM Realty Corporation Employees' 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of JVM Realty Corporation Employees' 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, sponsored by JVM Realty Corporation (the Company or Plan Administrator), is a defined contribution plan covering all employees, except for nonresident aliens, employees covered by a collective bargaining agreement and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility**

Each employee becomes eligible to participate in the Plan after attaining the age of 21 and completing two consecutive months of service for deferral contributions and six months of service for matching contributions. The Plan provides for enrollment to eligible employees the first of every month for deferral contributions and the first day of the first, fourth, seventh and tenth month of calendar year for matching contributions.

**Contributions**

Participants may make contributions to the Plan, including pre-tax and Roth contributions, up to the maximum annual contribution allowed by the Internal Revenue Service (IRS). The Plan also allows contributions representing distributions from other qualified plans (rollover). Participants who attain the age of 50 during the Plan year are permitted to make catch-up contributions, as defined in the Plan Document.

Participants are automatically enrolled into the Plan at a default rate of 3% upon satisfying the eligibility requirements. Participants have the option to change their deferral percentage or opt out of participation at any time.

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of eligible compensation plus 50% of the next 2% of eligible compensation.

The Plan allows the Company to make an additional discretionary matching contribution as determined by the Company. There were no discretionary matching contributions made during 2024 or 2023.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings. Allocations are based on the investment election percentages selected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Vesting And Forfeitures**

Participants are fully vested in their contributions and the Company's safe harbor matching contributions plus earnings thereon at all times. Participants vest in Company discretionary contributions 20% after two years of service, and 20% per year thereafter for each year of credited service. Participants become fully vested after six years of credited service. In the event of the participant reaching normal retirement age (age 65), death, or becoming disabled, the participant will become fully vested.

Forfeited balances of terminated participant nonvested accounts are used to reduce Company contributions. Forfeitures used to reduce Company contributions totaled \$11,263 during the year ended December 31, 2024. No forfeitures were used to reduce Company contributions during the year ended December 31, 2023. As of December 31, 2024 and 2023, there were \$728 and \$716, respectively, in forfeitures available to offset future Company contributions.

**Payment Of Benefits**

Upon termination of employment, attainment of normal retirement age, death or disability, a participant can elect distribution of the vested amount in their account as of the valuation date. The value of a participant's vested account balance shall be distributed in a lump sum or annuities, as soon as administratively feasible.

**In-Service Withdrawals**

Participants may take an in-service withdrawal upon reaching age 59-1/2. In addition, participants who experience a qualifying financial hardship may withdraw all or part of their account resulting from elective deferral contributions. Hardship withdrawals will be approved only if they conform to the Plan provisions and established Internal Revenue Code (IRC) safe harbor provisions.

**Administrative Expenses**

The Company has elected to pay substantially all of the administrative expenses of the Plan, except for loan and distribution fees, which are paid by the participants requesting such transactions. Investment related expenses are included in the net change in fair value of investments in the statement of net assets available for benefits.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use Of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Investment Valuation And Income Recognition**

Investments, other than fully benefit-responsive investment contracts, are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion on fair value measurements.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investment in the Empower Investments Fixed Account - Series Class I is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management has evaluated subsequent events through the date the financial statements were available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Financial Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Empower Annuity Insurance Company of America and Empower Trust Company (collectively Empower), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

**4. Fair Value Measurements**

The Plan follows accounting rules that establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Investment Contracts With Insurance Companies

The Plan is invested in a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the account. Contract value, as reported to the Plan by Empower, represents contributions plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on an agreed-upon schedule with the issuer and is reset on a semi-annual basis. During 2024 and 2023, the average crediting interest rate was 1.41% and 1.23%, respectively.

Certain events may limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Party In Interest Transactions**

Transactions with parties in interest include a guaranteed investment contract managed by Empower. In addition, certain participants have outstanding loans with the Plan. These transactions qualify as party in interest transactions allowable under ERISA.

**8. Income Tax Status**

Effective October 1, 2022, the Plan was restated with a cycle 3 pre-approved defined contribution plan document sponsored by TSC, Inc. TSC, Inc. received an opinion letter from the IRS dated June 30, 2020 as to the pre-approved plan's qualified status. The Company has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
