We have performed an audit of the financial statements of Reed & Reed Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

1. Description of Plan

The following description of the Reed & Reed Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. According to the Plan documents, individual participants direct investment options.

The Plan is a defined contribution plan sponsored by Reed & Reed, Inc. (the Company). All employees are eligible for participation in the Plan upon completion of six months of service and attainment of their twenty-first birthday. Once eligible, employees may enter the Plan semi-annually. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended January 1, 2024 to allow employees to become eligible for the Plan upon completion of 30 days of service. Once eligible, employees may enter the Plan monthly.

Contributions

Each participant may contribute a minimum of 1% up to a maximum of 100% of compensation, as defined by the Plan. The Company matches 100% of employee contributions up to a maximum of \$7,500 per participant per year. The Company made a profit-sharing contribution of \$600,000 for the year ended December 31, 2024. Company contributions vest using a six-year schedule. These contributions vest at a rate of 20% for each year after attaining two full years of service.

Employees are automatically enrolled into the Plan at 3% upon meeting eligibility requirements unless they elect not to participate in the Plan.

Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution or withdrawal and allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

With the exception of amounts distributed from rollover contributions, no amounts may be distributed to participants from their accounts prior to their termination of employment or their attainment of age 59½. Distributions from rollover contributions and those made before a participant attains age 59½ are limited to two in any 12-month period. Distributions may be taken as a lump-sum, annuity, or installment.

Forfeitures

Participants who terminate their employment prior to becoming 100% vested forfeit their nonvested account balances. These benefits plus interest accumulated thereon are left in the Plan to either offset the Company's contributions, pay administrative expenses, or be reallocated to participant's accounts. During 2024, \$19,660 was utilized to pay administrative expenses and \$3,312 was utilized to fund Company contributions. The remaining balance of forfeited nonvested accounts was \$9,801 and \$3,442 as of December 31, 2024 and 2023, respectively.

2. Summary of Significant Accounting Policies

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses paid by the Plan are primarily fees for third-party record-keeping services. The Company pays all other administrative costs.

Subsequent Events

Management has considered transactions or events occurring through July 25, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Investment Contract with Insurance Company

The Plan is invested in a Principal Life Insurance Company (Principal) guaranteed interest accounts contract. Principal maintains the contributions in a general account. The guaranteed interest accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at fair market value as reported to the Plan by Principal. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed interest account contract is not a fully benefit-responsive contract because participants are charged surrender fees if the balance invested in guaranteed interest accounts is withdrawn prior to the maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and is established as of the last day of the initial deposit year. Such interest rates are reviewed annually for resetting. The crediting interest rate ranged from 0.56% to 5.10% for 2024.

4. Fair Value Measurement

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is the description of the valuation methodologies used for assets at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Guaranteed interest accounts: Fair value represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Pooled separate accounts: Valued at net asset value (NAV) of the underlying asset in each separate account. The NAV is multiplied by the number of mutual fund shares owned. The number of shares owned in the underlying mutual fund reflects all contributions and disbursements traded through the end of the prior day to reach the value of the shares held by the separate account. While the underlying asset values are quoted prices, the NAV of separate accounts does not have readily determinable fair value, therefore, pooled separate accounts are valued using NAV as a practical expedient and excluded from the fair value hierarchy table below. Pooled separate accounts typically can be redeemed on a daily basis.

The U.S. Property pooled separate account includes mortgage loans which are backed by the associated properties. These underlying real estate investments have inputs derived principally from or corroborated by observable market data by correlation or other means.

Mutual funds: Valued based on quoted market prices of shares held by the Plan at year-end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is part of a non-standardized pre-approved profit-sharing plan (the pre-approved plan) designed by Principal. The Internal Revenue Service has determined and informed Principal by a letter dated June 30, 2020 that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since Principal received the determination; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants become fully vested in their accounts.
