

I called in and spoke with a woman at the IRS who said I need to still file the 5500 and include a reasonable cause letter for why we are filing late, so we can explain our circumstances. At the time that the filing was due, we were in the process of switching to a new plan provider due to our current provider not upholding responsibilities required of them. We did not have a person of contact for the plan provider and there was very little communication from that side. They were supposed to file our Form 5500 for us and did not do that nor did they reach out regarding the filing. I have tried to contact them but have had a very difficult time getting someone on the phone that can help.
