Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hill, Barth, & King, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements


Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Hill, Barth, & King, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Hill, Barth & King, LLC 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General:

The Plan is a defined contribution plan covering all employees of Hill, Barth & King LLC who have one year of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to participate in elective deferral after 90 days of service.

Contributions:

Each year, participants may contribute an amount equal to a dollar amount or percentage of pretax annual compensation not to exceed the limits imposed by IRS Code Sections 401(k), 402(g), 404 and 415, as defined in the Plan. Roth elective deferrals are permitted under the Plan. Participants may also contribute amounts representing distributions from other qualified plans.

Effective January 1, 2019, the Plan was amended to provide for Safe Harbor provisions, which requires the company to contribute 3% of employee's compensation, as defined in the plan document. The company also makes discretionary contributions of 25 percent of the first 6 percent of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the company. Contributions are subject to certain limitations.

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All contributions and investment earnings are participant directed.

Vesting:

Participants are immediately vested in their contributions and the company's discretionary matching and safe harbor contributions plus actual earnings thereon. Vesting in the company's profit-sharing contribution plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their account balance or \$50,000 reduced by the highest outstanding balance of plan loans during the prior one-year period. Loan transactions are treated as a transfer to (from) the investment fund from (to) a Participant Notes fund. Loans are repaid through payroll deductions over a maximum term of five years, except for qualifying home buyers for which the term is up to 30 years. Generally, interest charged on participant loans will be a fixed rate equal to the prime rate upon the inception of the loan plus 1%. The Plan allows for two loans.

Payment of Benefits:

Participants may receive a distribution of their vested account balance when employment is terminated. Distributions to deceased, disabled, retired, or terminated participants are made as soon as administratively possible.

Distributions from the Plan are made exclusively in the form of a single lump-sum payment in cash.

Forfeited Accounts:

Forfeited nonvested accounts will be used to reduce future employer contributions. There were no significant forfeited nonvested accounts at or for the years ended December 31, 2024 and 2023.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

NOTE B - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits:

Benefits are recorded when paid.

Administrative Expenses:

Most administrative expenses are paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties:

The Plan provides for various mutual fund investment options in stocks, bonds and fixed income securities as well as allowing participants to self-direct brokerage accounts. Investments are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Subsequent Events:

Management evaluated all activity of the Plan through the date of the auditors' report, which is the date the financial statements were available to be issued and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

NOTE C - FAIR VALUE MEASUREMENTS (CONTINUED)

FASB ASC 820 requires the Plan to classify its assets and liabilities based on valuation methods using three levels. Level 1 inputs are based on quoted prices in active markets for identical investments. Level 2 inputs are based on significant observable market inputs, such as quoted prices for similar investments and quoted prices in inactive markets. Level 3 inputs are based on significant unobservable inputs that reflect the Plan's determination of assumptions that market participants might reasonably use in valuing the investments. The valuation levels are not necessarily an indication of risk or liquidity associated with the underlying investments. Investments without readily determinable market values which are valued based on Net Asset Value (NAV) as a practical expedient are not required to be classified in the hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the NAV of shares held by the plan at year end.

Money market funds and equity securities (Self-directed brokerage accounts): Valued at the closing price reported on the active market on which the individual securities are traded.

Common/Collective trusts: Consists of the MetLife GAC-25053 CL 0 Stable Value Fund, which is valued based on net asset value per common share of the investments. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The investment objective is the safety of principal and accumulated interest for participant-initiated transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE F - TAX STATUS

The Plan adopted the Ascensus Inc. Prototype Non-Standardized Flexible 401(k) Profit Sharing Plan and entered into a trust agreement with Ascensus Trust. The Internal Revenue Service has determined and informed Ascensus, in a letter dated June 30, 2020, that the form of the prototype plan is acceptable under applicable sections of the IRC. Although the Plan has been amended since adopting the prototype plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the plan is qualified, and the related trust is tax-exempt.

NOTE G - PARTIES-IN-INTEREST TRANSACTIONS

Ascensus is the contract administrator of the Plan and was paid administrative fees of \$68,121 and \$61,449 for the Plan years 2024 and 2023, respectively.

The plan sponsor, Hill, Barth & King LLC, provided other administrative services at no cost to the Plan for the years ended December 31, 2024 and 2023.
