We have performed audits of the financial statements of The Colson Medical LLC Employees' Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE A - PLAN DESCRIPTION

The following description of The Colson Medical LLC Employees' Retirement Plan (the "Plan") provides only general information. The Plan is sponsored by Colson Medical, LLC (the "Company"), and was established effective April 1, 2003.

General

All employees designated by the participating employers' adoption and merger agreement are eligible to participate in the Plan. Eligibility to participate in the Plan commences on the first day of the month after 30 days of service (as defined by the Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan's trustee and asset custodian is Fidelity Management Trust Company ("Fidelity").

Contributions

Participant contributions are voluntary. Participants are entitled to make after-tax contributions and pre-tax contributions as follows: after-tax contributions equal to a whole percentage, not to exceed 30% of eligible compensation; pre-tax contributions equal to a whole percentage, not to exceed 60% of eligible compensation; and participant contributions whether pre-tax contributions, after-tax contributions or a combination thereof, which may not in the aggregate exceed 60% of eligible compensation. Eligible compensation is as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The participating employers can make two types of contributions to the Plan - the matching contribution and the retirement contribution. The participating employers' matching contribution, \$2,555,832 in 2024, is made in an amount not to exceed 50% of the participants' contributions that are eligible for matching. This matching contribution may not exceed 50% of 6% of the participants' eligible compensation. The retirement contribution of \$4,313,997 made for the 2024 Plan year is discretionary, as determined by each participating employer.

The participant's retirement contribution was based on eligible compensation earned during 2024. The participant's matching contribution was based on pre-tax contributions deducted during 2024.

The Plan has an automatic enrollment feature for all employees not already participating in the Plan into the elective deferral portion of the Plan. The automatic enrollment rate is a 3% participation rate (with a 1% annual increase thereafter) and the default investment is the Fidelity Freedom Fund. Each employee has the opportunity to opt out of this automatic enrollment online.

Each participant has the right to direct the investment of his or her account into the various investment options offered by the Plan in increments of 1%.

All contributions are subject to certain Internal Revenue Code ("IRC") limits.

Investment Options

Participants can select from various fund options offered by the Plan. Participants may change their investments daily.

Participant Accounts

A separate account is maintained for each participant. Each participant's account is credited with the participant's contributions and the participating employers' matching contributions, and an allocation of (1) discretionary participating employers' retirement contributions, (2) Plan earnings (losses) and (3) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions and earnings thereon are always fully vested.

Effective April 1, 2021, a participant's portion of participating employers' contributions (participating employers' matching contributions and participating employers' retirement contributions) and net income (loss) thereon becomes vested based on completed years of vesting service at the following rates: 20% per year of completed service, and becoming 100% vested on the fifth year of completed service. Prior to April 1, 2021, a participant's portion of participating employers' contributions (participating employers' matching contributions and participating employers' retirement contributions) and net income (loss) thereon became vested based on completed years of vesting service at the following rates: first through second years - 10% per year; third through sixth years - 20% per year, and becoming 100% vested on the sixth year of completed service.

Notes Receivable from Participants

Participants may borrow from their rollover, after-tax and pre-tax accounts and from the earnings portion of their matching account. The maximum loan available is limited to 50% of such participants' vested accounts, but in no event shall the loan be less than \$1,000 or more than \$50,000, reduced by the highest outstanding balance of loans during the one-year period. Participants can only have one outstanding loan at a time. The loans are secured by the balance of the participant's account. The interest rate of the loan is set by the participating employers using the prime rate plus 2%. The interest rate is fixed throughout the duration of the loan. Interest income is recorded on the accrual basis. Loans are repaid in equal installments through payroll withholding over a period not to exceed five years for a general loan and 10 years for a real estate loan.

Payment of Benefits

The Plan offers four types of withdrawals: non-hardship (retirement or termination of service), hardship, age 59½ and age 73. Each withdrawal type has specific requirements for eligibility, as defined in the Plan agreement.

The normal form of payment for a terminated participant is a cash lump-sum payment with spousal consent.

Forfeitures

Forfeitures in participants' matching and retirement accounts are used to reduce the participating employers' contributions and to pay administrative expenses. Forfeitures in the amount of \$375,315 and \$307,172 were available at the end of 2024 and 2023, respectively. In 2024, forfeitures reduced Company retirement and matching contributions by \$411,000. In 2024, \$75,981 of forfeitures were used to pay administrative expenses.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note C for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is accrued as earned.

Net realized and unrealized appreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses associated with the Plan are paid by the Plan.

NOTE C - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the FASB guidance are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

Mutual funds - Valued at the published market price per share or unit.

Collective trust - An investment formed from the pooling of investments by institutional investors. The Plan's interest in the Fidelity Managed Income Portfolio ("MIP") collective trust is valued by the trustee based on the Net Asset Value ("NAV") of shares held by the Plan at year-end as practical expedient fair value. The fund allows for daily liquidity with no additional days' notice required for redemption for participant-directed transactions at the constant NAV of \$1 per unit. Were the Plan to initiate a full redemption of the Fidelity MIP, the investment advisor reserves the right to temporarily delay withdrawal from the trust for up to 12 months in order to ensure that securities liquidations will be carried out in an orderly manner. There were no unfunded commitments of the collective trust as of December 31, 2024 and 2023.

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - TAX STATUS

The Plan adopted a volume submitter prototype plan sponsored by Fidelity Management & Research Company. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan has since been amended and restated, but the Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by applicable taxing authorities. The Plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's Company contribution account balance will become fully vested.

NOTE F - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are in investment funds managed by Fidelity, the trustee of the Plan, or its affiliate. These transactions qualify as party-in-interest transactions as defined under ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE H - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Form 5500 continues to record the Fidelity MIP value at the adjusted fair value based on the trust's audited financial statements, whereas the accompanying financial statements record this fund at the constant \$1 NAV.
