## Notes to Financial Statements

### Note 1: Description of Plan

The following description of the Penzeys, Ltd 401(k) Plan and Trust (the Plan) is provided for general informational purposes only. For a more complete description of the Plan and Plan investments, participants should refer to the Plan document and individual investment prospectuses. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### General

The Plan is a participant-directed defined contribution plan sponsored by Penzeys, Ltd. and affiliated employers (the Sponsor). Standard Retirement Services, Inc. (The Standard) serves as the custodian of the fully benefit-responsive investment contract and is also responsible for the Plan's recordkeeping. Reliance Trust Company acts as the Plan custodian for all other investments.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Eligibility

After reaching age 18 and completing one year of service, most employees—excluding leased employees—are eligible to participate in the Plan. A year of service is earned after 750 hours of service within your first 12 months, or in any subsequent Plan year.

In line with SECURE 2.0, long-term part-time employees who work at least 500 hours in three consecutive years (or two years starting in 2025) may also become eligible to participate.

#### Contributions

Each year participants may contribute a portion of their compensation, as defined by the Plan, not to exceed the maximum allowable by the Internal Revenue Service (IRS). Participants may also contribute distributions from other qualified plans (rollovers).

The Sponsor may make discretionary matching contributions. In 2024 and 2023, the Sponsor made discretionary matching contributions equal to 100% of eligible compensation contributed by the participant up to a maximum of \$1,000.

### **Note 1: Description of Plan (Continued)**

#### **Funding**

The Sponsor remits participant and Sponsor discretionary matching contributions to the Plan as soon as practical after amounts are withheld from participant wages.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Sponsor's discretionary matching contribution, and an allocation of the Plan's investment earnings (losses) and expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and all Sponsor contributions, plus actual earnings (losses) thereon.

#### **Investment Options**

The Plan is intended to satisfy the requirements under Section 404(c) of ERISA, and therefore, provides that participants may choose to direct their contributions and all of their account balances among the Plan's investment alternatives. All investments are participant-directed.

#### **Notes Receivable from Participants**

Participants may receive a note from their account balance with a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

A participant who terminates employment, or qualifies for withdrawal due to death or upon reaching age 59½, is entitled to receive his or her account in a lump-sum or partial payment. If a terminating participant's account balance does not exceed \$7,000, it will be automatically rolled over to an individual retirement account as soon as administratively feasible. Account balances exceeding \$7,000 are paid at the participant's discretion. Under certain circumstances, participants may qualify to receive a hardship distribution.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the accompanying financial statements and notes. Actual results could differ from those estimates and are subject to change in the near term.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value except for the fully benefit-responsive investments contract (FBRIC). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under terms of the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan.

#### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

#### **Administrative Expenses**

Expenses directly attributable to a participant's transaction are deducted from the participant's account. Certain expenses of maintaining the Plan are paid by the Plan. Plan expenses paid directly by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

There have been no changes in the methodologies used in 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end registered mutual funds. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Fair value is estimated by the issuer of the common collective trust using the NAV per unit which is based on the fair value of the underlying investments. Investments in common collective trusts can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Guaranteed Investment Contract with Insurance Company

The FBRIC provides a guarantee of principal and interest which is guaranteed by the general account assets of The Standard. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value. The crediting interest rate is set using a process determined by the issuer, but it may not be less than 1.00%. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The issuer may terminate the contract with 30 days advance notice for reasonable cause which could result in a market value adjustment. The Plan administrator believes the occurrence of any event that may limit the Plan's ability to transact at contract value within participants is not probable.

### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right to discontinue its contributions or terminate the Plan subject to the provisions of ERISA.

### Note 6: Tax Status

The Sponsor adopted a non-standardized pre-approved plan offered by The Standard. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7: Party-In-Interest Transactions**

Plan investments in common collective trusts and the FBRIC are managed by affiliates of Reliance Trust Company and The Standard. These transactions, as well as administrative expenses and notes receivable from participants, qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA regulations.

### **Note 8: Risks and Uncertainties**

The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and overall market volatility, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Note 9: Information Prepared and Certified by the Custodians**

Certain information disclosed in the accompanying financial statements and supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, interest and dividend income and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company and The Standard, the custodians of the Plan.
