We have performed audits of the accompanying financial statements of Connex Credit Union Inc. 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Connex Credit Union Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan for the employees of Connex Credit Union Inc. (the “Company” or “Employer”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan, which was established effective January 1, 1986, allows for participant contributions which are self-directed into available investment funds and provides for participant loans. All employees who have completed three months of service as defined by the Plan Document and have attained age 20 are eligible to participate in the Plan on the first day of the following quarter. For purposes of salary deferrals, employees are eligible after 30 days of service beginning on the first day of the following quarter.

Contributions

The Plan is funded through employee and Employer contributions to retirement funds managed and operated by Fidelity Management Trust Company (“Fidelity”), the Trustee. Participants may elect to tax defer amounts as allowed under the Plan and Internal Revenue Code (the “IRC”). Current tax law limits each employee’s annual pretax deferral to \$23,000 plus an additional \$7,500 for those participants over 50 years old for all tax deferred retirement plans in which they participate. Unless the employee elects otherwise, the Plan sponsor will automatically withhold a percentage of the employee’s eligible compensation and that amount shall be deemed the employee’s deferral election.

Company matching contributions may be made to the Plan equal to a uniform percentage of employee salary deferrals. The Company will match 100% of the first 3% of the participant’s Plan compensation contributed to the Plan and 50% of the next 2% of the participants’ Plan compensation contributed to the Plan.

Participant Accounts

Each participants’ account is maintained separately within the Plan and is credited with elective deferrals, Employer contributions and plan earnings. Participants may elect to have contributions invested in any or all of the funds of the Plan, subject to certain limitations. Investment income and expenses are allocated to the participants' accounts regularly. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance or their voluntary contributions, rollover contributions, or other transferred or segregated monies for which an account balance is maintained. A participant may not request a loan for less than \$1,000. Participant notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through regular payroll deductions as of each payroll withholding period.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer matching and profit sharing contributions and related earnings are based on the following schedule:

If a participant is not already fully vested, he or she will become so upon attaining normal retirement age, on death prior to normal retirement age, on retirement due to disability, or on termination of the Plan.

Payments of Benefits

Upon retirement, disability, death or termination of employment, the participant shall become entitled to the total value of his or her vested account, determined as of the valuation date. The Plan also provides for in-service withdrawals by qualified participants, generally participants that have attained the age of 59 1/2. The Plan also allows for hardship distributions, and distributions for childbirth and adoption expenses, if certain conditions are met. Distributions are paid by lump sum or in installments over a number of years, based upon election of the participant or the Plan, as defined in the Plan or the IRC.

Forfeited Accounts

Amounts forfeited by participants that separate from service before they are fully vested are maintained by the Plan and used to offset the Company contribution in future years or administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,402 and \$18,769 respectively. During 2024, the amount of forfeitures that were utilized to reduce Employer contributions was \$29,596.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Managed Income Portfolio, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan monitored and evaluated any subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended December 31, 2024 through July 29, 2025, the date on which financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of mutual funds and the money market fund is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – TAX STATUS

The Plan is a volume submitter plan sponsored by Fidelity which received an opinion letter from the United States Treasury Department Internal Revenue Service (IRS) on June 30, 2020, which stated that the volume submitter document was acceptable in accordance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position

NOTE 4 – TAX STATUS (CONTINUED)

that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – MANAGED INCOME PORTFOLIO

The Plan has a managed income portfolio fund (the “Portfolio”), which invests in short-term bonds and other fixed income securities such as U.S. treasury bonds, government agency securities, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities and derivative instruments, including futures, options and swaps. The Portfolio also purchases third-party wrap contracts designed to permit the use of contract value accounting to maintain a constant net asset value per unit and to provide for the payment of participant-directed withdrawals and exchanges at contract value under most circumstances. Interest is credited to the Portfolio under the wrap contracts; there is no immediate recognition of gains and losses. Instead, gains or losses are recognized over time by adjusting the interest rate credited to the Portfolio. The Portfolio may also invest in investment contracts offered by insurance companies and other approved financial institutions that provide for the payment of a specified rate of interest to the Portfolio and the repayment of principal at maturity.

NOTE 6 – PLAN TERMINATION

While the Company has indicated that it has no intention to do so, it has the right under the Plan to terminate the Plan at any time under the provisions of ERISA. In the event of a termination, participants will become fully vested in their account balances.

NOTE 7 – CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, the trustee of the Plan.

NOTE 8 – RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan offers investments that are managed by Fidelity. Fidelity is the Trustee of the Plan’s assets, therefore transactions in these funds qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Plan provides for participant loans. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investments and mutual funds that include growth funds, blended funds, international funds, fixed income funds, value funds, and growth funds. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment options will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for Plan benefits.
