Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cerenity Senior Care Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). The following description of Cerenity Senior Care Employee Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The 401(a) Plan is a defined contribution plan established on July 1, 2005, with a transfer from a predecessor plan. Every eligible employee who was a participant in the HealthEast Employee Retirement Plan on June 30, 2005 became a participant in this Plan on July 1, 2005. The Plan was last amended and restated effective October 15, 2021 to comply with Internal Revenue Service (IRS) Cycle 3 regulations. The Plan covers eligible employees of Cerenity Senior Care and related Employers (the Company) who have attained age 21 and completed one year of service. The Plan excludes employees covered by a collective bargaining agreement unless the bargaining agreements provide for participation in the Plan, chaplains, clergy, and members of a religious order who are or elect to be covered under another private pension or church plan, leased employees, and student interns. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Subsequent to year end effective February 28, 2025, the Board of Directors executed a resolution to freeze the Plan whereby all contributions are ceased and no new employees will enter the Plan after this date. The Board of Directors also executed a resolution to terminate the Plan effective June 30, 2025. All participants will become 100% vested upon Plan termination.

Contributions

Each year, at its discretion, the Company may choose to make a discretionary profit sharing contribution allocated to all eligible participants. In order to receive an allocation of the profit sharing contribution, a participant must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year, unless termination is due to death, disability, or retirement. For the years ended December 31, 2024 and 2023, the Company contributed 3% of a participant's compensation. Contributions are subject to limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Vesting in employee rollover contributions plus actual earnings thereon is immediately 100% vested. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, subject to a graded vesting schedule. A participant is 100% vested after the completion of five years of credited service. Notwithstanding the above, participants shall, however, become 100% vested in the account upon attaining normal retirement age (65), their death, becoming totally and permanently disabled, or upon Plan termination.

Participant Accounts

Each participant's account is credited with an allocation of the Company's contributions and Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, or participant transactions as defined. Company contributions are allocated based on the participants covered compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants may elect to receive their vested account balance in the form of a lump-sum distribution. If a participant terminates employment and the participant's account balance is not greater than \$7,000 (\$5,000 prior to January 1, 2024), the Plan administrator will authorize the benefit payment without the participant's consent. All automatic distributions between \$1,000 and \$7,000 (\$1,000 and \$5,000 prior to January 1, 2024) are required to be rolled over into an individual retirement account. In-service withdrawals are allowed from the rollover contribution source only.

Forfeited Accounts

The Plan states that forfeited nonvested accounts are to be used to reduce future Company contributions or pay Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$101,823 and \$131,475, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$100,000 were used to reduce Company contributions. There were no forfeitures used to pay Plan expenses during the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Administrative expenses paid by the Plan are included on the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Company appointed Fidelity Management Trust Company (Fidelity) as trustee. The trustee is responsible for the Plan's investment assets and investing transactions. Fidelity has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts (See Notes 1 and 10).

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype Plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity for administrative services were \$3,298 and \$3,148 for the years ended December 31, 2024 and 2023, respectively.

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of Cerenity Senior Care Employee Retirement Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The 401(a) Plan is a defined contribution plan established on July 1, 2005, with a transfer from a predecessor plan. Every eligible employee who was a participant in the HealthEast Employee Retirement Plan on June 30, 2005 became a participant in this Plan on July 1, 2005. The Plan was last amended and restated effective October 15, 2021 to comply with Internal Revenue Service (IRS) Cycle 3 regulations. The Plan covers eligible employees of Cerenity Senior Care and related Employers (the Company) who have attained age 21 and completed one year of service. The Plan excludes employees covered by a collective bargaining agreement unless the bargaining agreements provide for participation in the Plan, chaplains, clergy, and members of a religious order who are or elect to be covered under another private pension or church plan, leased employees, and student interns. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Subsequent to year end effective February 28, 2025, the Board of Directors executed a resolution to freeze the Plan whereby all contributions are ceased and no new employees will enter the Plan after this date. The Board of Directors also executed a resolution to terminate the Plan effective June 30, 2025. All participants will become 100% vested upon Plan termination.

Contributions

Each year, at its discretion, the Company may choose to make a discretionary profit sharing contribution allocated to all eligible participants. In order to receive an allocation of the profit sharing contribution, a participant must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year, unless termination is due to death, disability, or retirement. For the years ended December 31, 2024 and 2023, the Company contributed 3% of a participant's compensation. Contributions are subject to limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Vesting in employee rollover contributions plus actual earnings thereon is immediately 100% vested. Vesting in the Company contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, subject to a graded vesting schedule. A participant is 100% vested after the completion of five years of credited service. Notwithstanding the above, participants shall, however, become 100% vested in the account upon attaining normal retirement age (65), their death, becoming totally and permanently disabled, or upon Plan termination.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with an allocation of the Company's contributions and Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, or participant transactions as defined. Company contributions are allocated based on the participants covered compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Participants may elect to receive their vested account balance in the form of a lump-sum distribution. If a participant terminates employment and the participant's account balance is not greater than \$7,000 (\$5,000 prior to January 1, 2024), the Plan administrator will authorize the benefit payment without the participant's consent. All automatic distributions between \$1,000 and \$7,000 (\$1,000 and \$5,000 prior to January 1, 2024) are required to be rolled over into an individual retirement account. In-service withdrawals are allowed from the rollover contribution source only.

Forfeited Accounts

The Plan states that forfeited nonvested accounts are to be used to reduce future Company contributions or pay Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$101,823 and \$131,475, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$100,000 were used to reduce Company contributions. There were no forfeitures used to pay Plan expenses during the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan. Administrative expenses paid by the Plan are included on the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Company appointed Fidelity Management Trust Company (Fidelity) as trustee. The trustee is responsible for the Plan's investment assets and investing transactions. Fidelity has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts (See Notes 1 and 10).

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the prototype Plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The investments are managed by Fidelity Management Trust Company (Fidelity), the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity for administrative services were \$3,298 and \$3,148 for the years ended December 31, 2024 and 2023, respectively.

The Board of Directors also executed a resolution to terminate the Plan effective June 30, 2025. All participants will become 100% vested upon Plan termination. Participants were notified in 2025 and they are able to make elections as to the distribution of their account balances. All Plan assets will be distributed in accordance with the participants' elections or rolled over into separate IRA accounts effective September 30, 2025.
