### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the accompanying financial statements of United Association of Plumbers and Pipefitters Local Union No. 51 Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion*

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. DESCRIPTION OF PLAN**

The following description of the United Association of Plumbers and Pipefitters Local Union No. 51 Annuity Plan (the "Plan") is provided for general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering substantially all employees represented by the United Association of Plumbers and Pipefitters Local Union No. 51 which has collective bargaining agreements with employers requiring contributions to the Plan. The Plan provides for retirement benefits, occupational or total and permanent disability, termination of service, or death. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

***Participants' Accounts***

Each participant's account is credited with the employer's contribution and an allocation of the Plan earnings. Each participant directs the investment of their account among investments offered by Principal Financial Group.

***Vesting***

A participant's account is fully vested at all times.

**2. SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, certain revenues are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when the obligation is incurred. The modifications result in the recording of capital assets and prepaid expenses on the statements of net assets available for benefits. Except for depreciation and prepaid expenses, most transactions are recognized as either revenue or expense when cash is received or paid.

***Valuation of Investments***

Investments held by the Plan are required to be reported at fair value. However, contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**2. SUMMARY OF ACCOUNTING POLICIES (continued)**

***Fixed Assets***

Fixed assets are recorded at cost. Depreciation is provided principally on the straight-line method over the useful lives of the assets. The principal estimated useful lives used in computing depreciation of equipment are 3 - 7 years. All assets are fully depreciated.

***Reciprocity Agreement***

The Plan participates in a regional agreement where contributions for members of participating funds who work outside their local jurisdiction are reciprocated to their jurisdiction at the rate in effect at the time.

***Payment of Benefits***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Subsequent Events***

The Plan has evaluated subsequent events through July 16, 2025 the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.

**3. TAX STATUS**

The Internal Revenue Service has determined and informed the Plan by a letter dated January 26, 2001, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**4. CONTRIBUTIONS**

Under the provisions established under a collective bargaining agreement, employers are required to contribute \$3.35 per hour worked effective August 29, 2022; \$3.70 effective February 27, 2023; \$4.15 effective August 28, 2023; and \$4.60 effective August 26, 2024.

The Board of Trustees has the right to terminate the Plan. In the event of termination of the Plan, assets will be used to provide for the expenses of the administration of the Plan and the payment of any individual accounts previously approved for distribution. All remaining assets of the Plan will then be distributed to participants.

**9. RELATED-PARTY TRANSACTIONS**

The Plan pays administration fees to Plumbers and Pipefitters Local Union No. 51 Pension Plan (a related organization) of \$5,600 per month plus 2% of total employer contributions received.

The Plan leases its office space from the Plumbers and Pipefitters Local No. 51 Realty Corporation (a related organization) under a five-year, non-cancellable operating lease expiring March 31, 2027, at a monthly rate of \$2,877. The lease is automatically renewed for successive one-year periods unless cancelled by either party in a manner permitted under the lease agreement. Lease payments were \$31,647 and \$34,524 for the years ended December 31, 2024 and 2023, respectively.

The Plan invests in mutual funds managed by Principal Financial Group. Principal Financial Group is the custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

**10. RISKS AND UNCERTAINTIES**

The Plan maintains cash accounts at a commercial bank in Rhode Island. The accounts are fully insured by the Federal Deposit Insurance Corporation (FDIC) up to a maximum of \$250,000 for all cash accounts per depositor. Cash in excess of FDIC limits totaled \$258,037 and \$245,707 for the years ended December 31, 2024 and 2023, respectively.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

**11. GUARANTEED INVESTMENT CONTRACT**

The Fund has a fully benefit-responsive, guaranteed investment contract with Principal Life Insurance Company (Principal Life) totaling \$6,485,965 and \$6,796,985 for the years ended December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Fund. Contract value, as reported to the Fund by Principal Life, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

**12. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC), *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

---

**Level 1**            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2**            Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – valued at the daily closing price as reported by the Fund. Mutual funds are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Fund are deemed to be actively traded.

*Pooled separate accounts* – valued at the daily closing price as reported by the Fund. These funds are required to publish their daily NAV and to transact at that price. The pooled separate accounts have a readily determinable fair value.

The following tables present, by level within the fair value hierarchy, the Plan investment assets at fair value as of December 31, 2024 and 2023. Investments are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.
