## Independent Auditor's Report

To the Participants and Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Ambassador Theater Group-North America, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the year ended December 31, 2022, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

### ***Opinion***

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Management's Responsibilities for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### **Note 1 – Plan Description**

The following description of the Ambassador Theatre Group-North America, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Ambassador Theatre Group-North America, LLC, and affiliates (collectively, the “Company” or “Employer”). Effective May 1, 2019, ATG San Antonio, LLC; Art Center Enterprises New Orleans, LLC; Art Center Enterprises – Brooklyn, LLC; Saenger Theatre Redevelopment Company, LLC; Lyric Theatre, LLC; and ATG Colonial, LLC, became participating affiliates. The Plan, which commenced effective January 1, 2013, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”). Effective May 1, 2022, the Plan adopted an amended and restated pre-approved defined contribution profit-sharing plan within IRC Section 401(k), which received a favorable opinion letter from the Internal Revenue Service (“IRS”), dated October 6, 2020.

#### ***Plan Custodian and Trustee***

Reliance Trust Company (“Reliance,” the “Trustee,” or “Custodian”) is the Custodian and Trustee of the Plan, maintaining custody of all investments held by the Plan. Among other duties, Reliance receives contributions, holds and invests the fund assets in accordance with the directions of participants, and makes distributions as directed by the Plan Administrator. ADP, LLC Retirement Services provides Plan administration and recordkeeping services and maintains the Plan’s participant account balances.

#### ***Eligibility***

Full-time employees, except those under collective bargaining agreements and leased employees, are eligible to participate in the Plan. Part-time employees must either work at least 1,000 hours during the first year of service or work at least 500 hours in each of three consecutive years to be eligible to participate.

#### ***Participant Contributions***

All eligible participants may elect to contribute, on a before-tax or Roth basis, up to 90% of their eligible compensation, as defined by the Plan. Participant contributions are subject to certain limitations under the IRC. Participant’s annual contribution shall not exceed the maximum amount allowed for deferral annually by the IRC, which was \$20,500 for 2022. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of up to the maximum amount allowed by the IRC, which was \$6,500 for 2022. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”) in accordance with the provisions of the Plan Document.

#### ***Employer Contributions***

The Company makes Safe Harbor Employer matching contributions to all eligible participants in an amount equal to 100% of the first 3% of participant’s eligible compensation and 50% of the next 2% of participant’s eligible compensation, contributed to the Plan as employee contributions.

#### Note 1 – Plan Description (continued)

##### ***Participant Accounts***

Each participant account is credited with the participant's contributions, the Company's Safe Harbor Employer matching contributions, plus allocations of Plan earnings. Each participant account is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in types of investments, rates of return, and investment risk.

##### ***Vesting***

Participants are immediately vested in their pre-tax contributions, Roth deferred contributions, rollover contributions, and Safe Harbor Employer matching contributions, plus any income or loss therein.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 2% above Prime, as defined.

##### ***Payment of Benefits***

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum payment equal to the value of the participant's vested balance or a partial withdrawal.

Distributions to a terminated employee with an account balance equal to or less than \$5,000 are made as a lump sum distribution as soon as administratively possible following the participant's termination of employment. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. If a terminated employee has an account balance exceeding \$5,000, the participant may elect to maintain their balances within the Plan. If the participant's total vested benefit under the Plan is \$5,000 or less as of the distribution date, and the participant does not consent to a distribution of their vested account balance, then the vested benefit will automatically be rolled over to an individual retirement account ("IRA") selected by the Plan Administrator. If the participant's total vested account balance exceeds \$5,000, no distribution will be made from the Plan without the participant's consent.

A participant may withdraw all or a portion of their account in the event of a financial hardship, as defined by the Plan. Effective January 1, 2019, the requirement to suspend a participant's contributions for six months following a hardship distribution was removed. In-service withdrawals are permitted upon attainment of age 59 ½.

##### ***Forfeited Accounts***

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$700 and \$257, respectively. These accounts will be used to reduce future Employer contributions. \$5,711 of Employer contributions were reduced from forfeited nonvested accounts for the year ended December 31, 2022.

#### **Note 2 – Summary of Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

##### ***Payment of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net assets value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.
- **Money Market Fund** – This investment is valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2022 and 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

#### Note 4 – Information Prepared and Certified by the Plan’s Trustee

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

#### Note 5 – Exempt Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and a money market fund managed by the Trustee. As such, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants as of December 31, 2022 and 2021. As a result, these receivables and all transactions relating to these receivables qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

#### Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants would become 100% vested in their Employer contributions, and all assets in the affected participants’ accounts would be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA.

#### Note 7 – Income Tax Status

The Plan operates under an adoption agreement in connection with a preapproved profit-sharing plan and trust sponsored by ADP, LLC. This preapproved plan document has been filed with the appropriate agency and the prototype plan sponsor has obtained a determination letter from the IRS, dated October 6, 2020, stating that the Plan constitutes a qualified plan under Section 401 of the IRC, and that the related trust was tax-exempt as of the financial statement date.

#### Note 7 – Income Tax Status (continued)

The Plan has not filed individually with the IRS for a letter regarding the Plan's qualified tax status; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. As such, the Plan Administrator believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is not subject to income tax examinations prior to 2019.

#### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

#### Note 9 – Prohibited Transactions

During the year ended December 31, 2022, the Company failed to remit to the Plan's Trustee certain participant contributions totaling \$5,833 within the period prescribed by the Department of Labor's Rules and Regulations. Delays in remitting contributions and loan repayments to the Trustee were due to unintentional administrative errors.
