## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Florida Hardware, LLC 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Florida Hardware, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Florida Hardware, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements (modified cash basis) referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified basis of accounting described in Note B.
- the information in the financial statements (modified cash basis) referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Florida Hardware, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Basis of Accounting**

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements (and supplemental schedules) were prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note B; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## **FLORIDA HARDWARE, LLC 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### **NOTE A – DESCRIPTION OF PLAN**

The following description of the Florida Hardware, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan adopted effective April 1, 2002, and amended and restated September 1, 2021, by Florida Hardware, LLC and participative affiliates, Florida Hardware Sales Company, Florida Hardware Farm Equipment, Inc., and Florida Hardware Trucking Company (the “Companies”), which comprise a controlled group of corporations under Internal Revenue Code Section 414(b). The Plan covers all eligible employees of the Companies who have completed 90-days and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each year, participants may contribute Section 401(k) deferrals of up to 100% of pretax annual compensation, as defined in the Plan. The Companies’ matching contribution equals 25% on the first 5% of the participant’s compensation which is deferred as an elective deferral. The Plan does not include an auto-enrollment provision. The Plan was amended to remove the provision as of January 1, 2020, and all newly eligible employees must opt into the Plan. Effective, beginning July 1, 2011, a Roth deferral component was added to the Plan. The Roth elective deferrals are subject to the same conditions and limitations that apply to pretax elective deferrals, except in-plan Roth rollovers are not permitted. The matching percentage for each participant will be made on a payroll-by-payroll basis. The Companies may decide to make a non-elective or profit-sharing contribution to the plan, although the Companies are not required to do so. The Plan allows catch-up contributions by participants age 50 and older, as well as “rollover” contributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers fifty mutual funds as investment options for participants.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution, the Companies’ matching contribution, and investment earnings minus administrative fees and expenses. Investment earnings are determined separately for each account based on that account’s investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are immediately vested in their section 401(k) deferrals, “rollover” contributions, qualified non-elective contributions, qualified matching contributions, and earnings thereon. Participant’s interest and vesting in the Companies’ matching contribution portion, of the participants account, is based on years of continuous service, as follows: 20% after one year, 40% after two years, 60% after three years, 80% after four years, and 100% after five years of service. Notwithstanding the foregoing, a participant will become fully vested upon attainment of normal retirement age, or upon death or disability, while an employee.

## **FLORIDA HARDWARE, LLC 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### NOTE A – DESCRIPTION OF PLAN (continued)

*Notes Receivable from Participants.* Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their vested account balance, for a term not to exceed 5 years, reduced by the highest outstanding balance of loans during the one-year period ending on the day before the loan is made. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one percent. Principal and interest is paid ratably through payroll deductions.

*Forfeited Accounts.* At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,438 and \$26,292, respectively. If the participant is reemployed, and the participant repays to the Plan the full of amount of the distribution attributable to the employer contribution, before the earlier of 5 years after the first date the participant is subsequently reemployed, or the participant incurs 5 consecutive one-year breaks in service, forfeited amounts are restored. Forfeitures that are restored pursuant to the foregoing, shall be accomplished by an allocation of forfeitures, or if insufficient, by a special Company contribution. During this period, the Plan has historically held forfeited amount in cash account. After the foregoing term, these accounts will be used to reduce future employer contributions or pay reasonable plan expenses. Employer contributions were reduced by \$24,020 and \$3,559, in 2024 and 2023 respectively, from forfeited nonvested accounts.

*Payment of Benefits.* On termination of service, a participant may receive the vested interest in his or her account as a joint and survivor annuity (if married) or life annuity (if unmarried) or, if elected, as a lump sum or in installments over a period not to exceed the life or expected life of the participant and a designated beneficiary. In-service distributions are permitted after age 59½ or in case of documented hardship (as defined in the Plan agreement). Vested account balances not exceeding \$5,000, at such time an individual becomes entitled to a distribution, shall be paid in a lump sum to the extent it is not subject to automatic rollover provisions (as defined in the Plan agreement). Amounts sourced from rollovers from other plans along with applicable earnings may be withdrawn at any time.

### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared under the modified cash basis of accounting. The modified cash basis of accounting financial statements is prepared on a comprehensive basis of accounting other than GAAP (special purpose frameworks) which is acceptable by the DOL. Under that basis, certain contributions and related assets are recognized when received rather than earned, and certain plan expenses are recognized when paid rather than when the obligation is incurred. That basis differs from generally accepted accounting principles primarily because the Plan has not recognized contributions receivable from the employee and employer and accounts payable to vendors and their related effects on additions and deductions in the financial statements. The modified cash basis financial statements are financial statements on the cash basis with security investments adjusted to fair value.

## **FLORIDA HARDWARE, LLC 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### *Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent loans are reclassified as distributions based on terms of the Plan document. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

Based on the Plan document, if a participant misses a loan repayment (other than leave of absence) and fails to make it up by a specified date, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

#### *Excess Contributions*

Contributions in excess of amounts allowed by the IRS are recorded in the year of distribution. The Plan distributed the 2024 excess contributions of \$152,606 prior to March 15, 2025, and the Plan distributed the 2023 excess contributions of \$171,161 prior to March 15, 2024.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note C for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefits are recorded when paid.

## **FLORIDA HARDWARE, LLC 401(k) PLAN NOTES TO FINANCIAL STATEMENTS**

### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### *Operating Expenses*

Most administrative expenses of maintaining the Plan are paid by the Plan, from the Plan assets, and deducted from the participants' accounts in accordance with the Plan document. The audit fee is paid by the Plan Sponsor and therefore excluded from these financial statements.

### NOTE C – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

FASB ASC 820 (*Fair Value Measurements*) establishes a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan had no Level 1 inputs. Level 2 inputs were used only when Level 1 inputs were not available, and Level 3 inputs were used only when Level 1 or Level 2 inputs were not available to the Plan. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

#### *Level 1 Fair value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stocks, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

#### *Level 2 Fair Value Measurements*

Pooled separate accounts ("PSA") invest in a single mutual fund. The fair value of the mutual fund is a publicly quoted pricing input (Level 1) and is used in determining the net asset value ("NAV") of the PSA, which is not publicly quoted. ASC 820 allows NAV per share to serve as a practical expedient to estimate the fair value of a PSA as long as certain requirements are met. Additionally, ASC 820 states that NAV is allowed to be used as an estimate of fair value, if the reporting entity has the ability to redeem its investment at NAV as of the measurement date, that investment shall be categorized as a Level 2 fair value measurement.

The Plan’s investments were held and administrated by John Hancock Life Insurance Company USA, in 2024 and 2023, respectively. All investment information presented in the accompanying financial statements and supplemental schedules, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the custodians listed above.

NOTE E – NONPARTICIPANT-DIRECTED INVESTMENTS

The Plan did not have any nonparticipant-directed investments at December 31, 2024 and 2023.

NOTE F – PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all amounts credited to their accounts.

NOTE G – TAX STATUS

According to a letter dated June 30, 2020, the Internal Revenue Service (IRS) has determined, under Section 401 of the Internal Revenue Code (IRC), through the adoption of a non-standardized pre-approved profit-sharing plan with CODA, that the Plan and trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE I – RELATED PARTY TRANSACTIONS**

The Plan's investments are managed by John Hancock Life Insurance Company USA. Economic Group Pension Services, Inc. is the contract administrator and record keeper for the Plan, and therefore, these transactions qualify as party-in-interest transactions. However, these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA. Fees paid by the Plan to the trustee for certain investment management services were included as a reduction of the return earned on each fund. For the year ended December 31, 2024, fees paid by the Plan for investment management services were \$39,660. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the plan sponsor. For the years ended December 31, 2024 and 2023, fees paid by the Plan for administrative services amounted to \$2,500 and \$3,189, respectively. The Plan's fees for the audit are paid by the plan sponsor. All other expenses of maintaining the Plan are paid by the Plan.
