Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 – DESCRIPTION OF PLAN

The following description of Cleaner's Supply and Mity Forms Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Cleaner's Supply, Inc. and Mity Forms, Inc., a participating employer (collectively referred to as "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

The Plan covers all employees of the Company who have attained 18 years of age and six months of service, except for employees covered by a collective bargaining agreement. Employees are able to participate in the foregoing types of contributions on the first day of the month following satisfaction of eligibility requirements.

Contributions

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan on the first day of the month following satisfaction of eligibility criteria, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants' deferral rate is three percent, and their contributions are invested in a designated blend fund until the participant elects otherwise. Participants may make Roth elective deferrals and participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company matching contributions and profit sharing contributions are made to the Plan at the discretion of management each year. For 2024 and 2023, the Company contributes 50% of the first 6% of eligible plan compensation that a participant contributes to the Plan. In order to receive employer profit sharing contributions for a given Plan year, an employee must be employed by the Company on the last day of the Plan year. There were no profit sharing contributions made for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with participant contributions, employer matching contributions, employer profit sharing contributions, rollover contributions, and actual earnings or losses thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service, as defined by the Plan Document. A participant is 100% vested in employer matching and profit sharing contributions, plus any earnings thereon, after six years of service.

Payment of Benefits

Benefits are available for distribution when participants attain normal retirement age of 65, become disabled, or terminate employment with the Company, or upon death. Participants may elect to receive a distribution of their vested account balance in the form of a single lump-sum payment or a rollover contribution to another qualified plan. In-service distributions are permitted to eligible participants, as defined by the Plan.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted under certain circumstances.

Forfeitures

If employees' participation in the Plan is terminated prior to being 100% vested in employer matching contributions, employer profit sharing contributions, and the actual earnings thereon, then the non-vested portion is forfeited in the year of distribution of the vested balance. Forfeitures are retained in the Plan and can be used to pay the Plan's administrative expenses or reduce future employer contributions. Forfeitures totaling \$10,186 and \$29,141 were used to pay Plan expenses for the years ended December 31, 2024 and 2023, respectively. There were no forfeitures applied to reduce employer contributions for both years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeitures available for future offset totaled \$14,603 and \$334, respectively.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustees and insurance company. See Note 4 for discussion of fair value measurements.

Purchases or sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through July 31, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from the trustee that all of the information provided by them is complete and accurate.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash and Cash Equivalents – Valued at cost plus interest which approximates fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Fund – Valued at the net asset value, based on the fair values of the underlying investments reported by the trustee of the funds. Fair values for the underlying assets were based on either quoted price in active markets or observable inputs or quotations from inactive markets.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

NBT Bank is the trustee of the Plan's assets. As such, transactions between NBT Bank and the Plan qualify as party-in-interest transactions. As described in Note 2, the Company or the Plan paid certain expenses related to plan operation and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from prohibitive transaction rules.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The IRS has determined and informed the Company, through a prototype plan opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
