#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Flogistix, LP 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statement.

December 31, 2024

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Flogistix, LP 401(k) Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the current Plan agreement.

#### General

The Plan is a defined contribution retirement plan which provides for the participation of the employees of Flogistix, LP (the Company), who have completed one hour of service. Once eligibility requirements are met, employees are automatically enrolled. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC). Under the Plan, each participant has an account for his/her salary deferral contributions, employer matching contributions and for a separate discretionary employer contribution.

Empower Annuity Insurance Company of America (EAIC) and Empower Trust Company, LLC (ETC) serve as the Plan's investment custodians and are responsible for executing all investment transactions.

#### Contributions

Participants may make salary deferral contributions through payroll deductions of not less than 1% up to 100% of their compensation (limited to certain amounts allowed under the IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, the Company makes matching contributions, which are applied to active participants who made salary deferral contributions to the Plan. The Plan has elected Safe Harbor, and the Company matches 100% of each employee's contribution up to 3% of compensation earned for the first level and up to 50% of each employee's contribution up to a maximum of 5% of compensation earned for the second level. Participant and Company contributions are subject to the provisions of the IRC and related regulations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) eligible employer matching contributions, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participant contributions and Company safe-harbor matching contributions plus actual earnings are immediately fully vested and non-forfeitable.

#### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,275 and \$3,230, respectively, and were included in guaranteed investment contract. During 2024, the Plan utilized \$-0- of forfeitures to reduce employer match contributions or pay Plan expenses. Forfeited balances of terminated participants' non-vested accounts are available to be used to pay plan expenses or as a reduction of Employer contributions in the year in which the forfeitures occur.

#### NOTE 1 - DESCRIPTION OF PLAN (continued)

##### **Notes Receivable from Participants**

Participants may borrow from their Plan account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Loan terms range from 1 to 5 years. The loans bear interest at rates based on the Prime lending rate as published in the *Wall Street Journal* at the time of the loan plus 1%. As of December 31, 2024, interest rates ranged from 4.25% to 9.50% on participant loans. Principal and interest is paid ratably through monthly payroll deductions.

##### **Payment of Benefits**

On termination of service for any reason, a participant may elect to receive the value of the vested interest in his/her account as a lump-sum distribution. In certain hardship situations, as described in the Plan adoption agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants' withdrawals are permitted from all participant accounts with a 100% vested balance.

##### **Investment Management**

Upon enrollment in the Plan, a participant may direct his/her contributions in any of the investment options currently available as determined and selected by the Plan's Administrative Committee. Participants may change their investment allocations daily, via phone or internet access to Empower Retirement.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles.

##### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Fees**

Certain administrative costs including the trustee's fees and third-party custodian fees are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. The value of the guaranteed investment contract is determined as the value of contributions to the account, plus accrued interest, less distributions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

#### Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

#### Subsequent Events

The Plan Administrator has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued. See Note 9 for management's evaluation of subsequent events.

### NOTE 3 - INVESTMENT INFORMATION CERTIFIED BY THE INVESTMENT CUSTODIAN

The following is a summary of the asset information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodians Empower Annuity Insurance Company of American and Empower Trust Company, LLC (previously Great-West) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodians that the information provided to the Plan Administrator by the custodians related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following Plan assets:

#### **NOTE 4 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

At December 31, 2024, the Plan held investments in a guaranteed investment contract and notes receivable from participants which are managed by EAIC and ETC, respectively. Thus, transactions within these investment funds qualify as party-in-interest transactions as defined by ERISA.

Administrative fees incurred and paid by the Plan to the administrator and recordkeeper, aggregated to \$98,412 in 2024. The plan also paid the investment advisor \$41,196 for advisory services. Transactions involving the administrator and investment managers qualify as party-in-interest transactions.

#### **NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in their accounts and the Plan assets will be distributed in a manner approved by the Internal Revenue Service (IRS).

#### **NOTE 6 - TAX STATUS**

The Plan has not received a determination letter on their adoption of the pre-approved plan. In accordance with Revenue Procedure 2003-6, the Plan administrator has chosen to rely on the opinion letter, dated November 14, 2022, that has been issued to the pre-approved plan. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code (the Code) to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

#### **NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE 8 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed investment contract:* Total contributions to the account, plus all interest credited to the account, less any amounts transferred or distributed, less fees and expenses.

#### NOTE 9 - SUBSEQUENT EVENT

The Plan's sponsor Flogistix, LP merged with three other entities in June 2024 to create a new combined company named Flowco LLC, however the Flogistix 401k Plan remained without change. Then subsequently in January 2025 an Initial Public Offering (IPO) under Flowco Holdings Inc. (NYSE Ticker FLOC) was completed for a partial interest in Flowco LLC. Management of Flowco LLC is currently evaluating a plan to merge the various entities' 401(k) plans in 2026.
