**Note 1 - Plan Description**

The following brief description of thyssenkrupp Materials NA, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of thyssenkrupp Materials NA, Inc.; thyssenkrupp Supply Chain Services NA, Inc. (formerly known as thyssenkrupp Industrial Services NA, Inc.); thyssenkrupp Online Metals, LLC; thyssenkrupp Materials, LLC; and thyssenkrupp Logistics, Inc. (collectively, the "Companies"). All employees who are not covered by a collective bargaining agreement (unless the agreement specifically provides for participation in the Plan) are eligible to participate in the Plan. Participation is voluntary and effective after the participant's date of hire. The Plan's investments are managed by the trustee of the Plan, John Hancock Trust Company LLC (John Hancock or the "Trustee"), and disbursed to specific investment option offerings in proportions directed by each participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Employee contributions represent a percentage of each eligible participant's pretax earnings, as defined in the plan agreement, and are subject to limits imposed by the Internal Revenue Code. The Plan also provides for after-tax and Roth deferral options for participants. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Prior to January 1, 2023, the Plan allowed for the Companies to make discretionary contributions equal to 50 percent of each participant's pretax contributions up to the first 6 percent of compensation deferred. Effective January 1, 2023, the Plan was amended to allow for the Companies to make discretionary contributions equal to 100 percent of each participant's pretax contributions for the first 4 percent of compensation deferred, with the exception of thyssenkrupp Supply Chain Services NA, Inc., which remained at 50 percent of the first 6 percent of compensation deferred. Discretionary matching contributions made to participants employed by thyssenkrupp Online Metals, LLC are limited to 4 percent of each participant's compensation for the period during which elective deferrals are made. Through November 10, 2023, any participant covered by a collective bargaining agreement between the Companies and Teamster's Local Union No. 600 was not eligible for discretionary matching contributions. Effective November 11, 2023, the Plan was amended to permit discretionary matching contributions for these participants equal to 25 percent of the first 4 percent of deferrals contributed by each participant.

Effective January 1, 2019, thyssenkrupp Materials NA, Inc. began making transition benefit contributions to certain employees no longer eligible to accrue benefits under the ThyssenKrupp Materials NA, Inc. Pension Plan (the "Pension Plan"), under which benefit accruals were frozen effective December 31, 2018. The transition benefit was calculated as the difference between (1) the December 31, 2018 present value of an impacted participant's future benefit at normal retirement age calculated as if the freeze had not occurred and (2) the December 31, 2018 present value of an impacted participant's future benefit at normal retirement age as a result of the freeze to future benefit accruals. Contributions were determined such that the participant's contributions, accumulated with interest at 4 percent per year between January 1, 2019 and the participant's normal retirement age, will match the participant's transition benefit.

Participants who satisfied early retirement eligibility requirements under the Pension Plan prior to January 1, 2019 received one level stream of contributions starting in 2019 and ending in the year they terminate employment with thyssenkrupp Materials NA, Inc. Participants who did not satisfy early retirement eligibility requirements under the Pension Plan prior to January 1, 2019 will receive two level streams of annual contributions: (1) one stream of level payments starting in 2019 and ending in the year they satisfy early retirement eligibility requirements under the Pension Plan and (2) a second stream of level payments starting in the year they attain early retirement eligibility under the Pension Plan and ending in the year they terminate employment with thyssenkrupp Materials NA, Inc. Approximately \$603,000 and \$616,000 of transition benefit contributions were made to the Plan in 2024 and 2023, respectively.

## Note 1 - Plan Description (Continued)

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### ***Vesting***

Participants are immediately 100 percent vested in their contributions, rollovers, and transition benefit contributions plus actual earnings thereon. Vesting in the Companies' discretionary matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. Participants with less than three years of service have a vesting percentage of 0 percent, and participants with three or more years of service have a vesting percentage of 100 percent.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant or his or her beneficiary may elect to receive his or her benefit in the form of partial payments (if the vested account balance exceeds \$1,000), installments (at least annual, if vested account balance exceeds \$1,000), or a lump-sum amount equal to the value of the participant's vested interest in his or her account.

### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to a maximum equal to the lesser of \$50,000, which shall be reduced by the highest outstanding loan balance during the preceding 12-month period, or 50 percent of their account balances at the issue date. Borrowings may not exceed five years unless used for the purchase of a primary residence. Notes receivable are collateralized by the participant's account balance and bear interest equal to the prime lending rate plus 1 percent. Principal and interest are paid ratably, with payments to be made at least quarterly.

### ***Hardship Withdrawals***

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan agreement.

### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan.

### ***Termination***

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by John Hancock Trust Company LLC or its affiliates. John Hancock Trust Company LLC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Certain administrative expenses of the Plan are paid by the Companies, which qualify as party-in-interest transactions.

## Note 2 - Summary of Significant Accounting Policies

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices. See Note 4 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 29, 2025, which is the date the financial statements were available to be issued.

## Note 3 - Certified Information

John Hancock Trust Company LLC holds the Plan's investments and participant notes receivable and executes all related transactions. ### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

The following tables present information about the Plan's assets measured at fair value on a recurring basis at December 31, 2024 and 2023.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
