INDEPENDENT AUDITORS' REPORT

To the Trustees and Plan Administrator of
U.S. Battery Manufacturing 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of U.S. Battery Manufacturing 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of U.S. Battery Manufacturing 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The U.S. Battery Manufacturing 401(k) Savings Plan is a defined contribution plan providing retirement income, disability, termination and death benefits to eligible employees. The Plan is administered by U.S. Battery Manufacturing Company (the Company). The Plan was adopted effective October 1, 1998 with a year end of December 31. The Plan consists of a tax deferred savings program under Internal Revenue Code (IRC) Section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective January 1, 2016 to comply with the Pension Protection Act of 2006 (PPA) and other regulatory changes. The Plan was amended effective October 1, 2020 to change available forms of distributions.

The following description of the U.S. Battery Manufacturing 401(k) Savings Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Eligibility and Participation

The Plan excludes all nonresident aliens and employees covered by a collective bargaining agreement. Eligibility requirements for the plan consist of one year of service, based upon elapsed time, and attainment of 21 years of age. The plan was amended October 1, 2016, to adjust the eligibility age requirement from 21 years of age to 18 years of age. The plan entry dates are the first day of the month coinciding with or next following the satisfaction of these requirements.

Contributions

Each year, subject to the provisions of the Plan and limitations of the IRC Provisions, participants may elect to defer up to 100% of pretax annual compensation; as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investments of their contributions into various investment options offered by the Plan.

The Plan is a safe harbor plan and has employer matching contributions of 100% of participant eligible compensation deferrals that do not exceed 3% of the participant's compensation plus 50% of salary deferrals between 3% and 5% of eligible compensation. The Plan also allows for employer profit sharing contributions. There were no profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

A participant's account is credited with the participant's contributions, allocations of (a) the Company's contribution and (b) plan earnings. A participant's account is debited with an allocation of plan losses and charged with administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. Allocation of the Company's contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer matching contributions, plus actual earnings thereon. Vesting in employer profit sharing contributions is based on years of continuous service using the following schedule:

Less than 1 year	0%
At least 1, but less than 2	20%
At least 2, but less than 3	40%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear a reasonable fixed rate of interest (as determined by the Company) equal to the current prime rate plus two percentage points. Principal and interest is paid through payroll deductions.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. Participants terminating their employment with the Company or attaining age 59 1/2 are entitled to withdraw all or a portion of their vested account balance. Upon termination, automatic distributions are required for participants with account balances less than \$1,000. "Hardship" distributions, as outlined in the Plan, are permitted subject to the approval of the Company. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum cash distribution or in periodic installments. Benefits under the Plan shall be distributed solely from the assets of the Trust. Effective October 1, 2020, the Plan was amended to remove the partial withdrawal minimum amount. The amendment also removed partial withdrawals or installments permitted for participants or beneficiaries who must receive required minimum distributions.

Forfeitures

Participants are immediately vested in salary deferrals, rollover contributions and safe harbor matching contributions. Forfeitures of employer profit sharing contributions may be used to offset plan administrative expenses and reduce the Company's matching contributions. At December 31, 2024 and 2023, there was no balance of forfeitures in the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition

The Plan's investments, except for the stable value fund which is stated at contract value, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees of the administrative agent are paid by the participants. All other expenses related to the administration of the Plan, including fees of the independent public accountants, are paid by the Company. The investment options have certain management fees which reduce the overall return on assets. The net appreciation or depreciation of assets is reflected net of these fees.

Subsequent Events

The plan administrator has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued and concluded there were no events that require recording or disclosure in the financial statements as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENT

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the applicable methodologies used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

The value is based upon the unit price of the investment. The unit price is determined using market prices of the underlying investments which are traded on active markets and then adjusted for management fees plus all dividends and capital gains received. As this investment is not traded on an active market, but the underlying securities are actively traded, then this investment is classified as a Level 2 investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INSURANCE CONTRACTS

The Plan entered into a fully benefit-responsive group annuity insurance contract with Standard Insurance Company through the investment in a Stable Asset Fund. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Net deposits invested in the Stable Asset Fund II become part of Standard Insurance Company's general account, and there are no particular segregated or identifiable assets ascribed to the plan's investment. Net deposits and interest credited become liabilities against Standard Insurance Company on the plan's behalf. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions.

Contract value is guaranteed by the full faith and credit of Standard Insurance Company; there are no wrap contracts supporting the liquidity of the fund. The fund is neither a mutual fund nor a bank product. Standard Insurance Company's obligations are not insured by the FDIC or any other federal government agency.

Crediting rates for the plan's Stable Asset Fund II are set by Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products. Every month a crediting rate is declared for financial activity in the coming month. This crediting rate takes into account yield forecasts from the asset advisory group and required margins. Management approval is required for all crediting rates. Monthly rates are combined quarterly into cells, which are weighted based on the amount of net transactions in the fund each month. Other cell features are governed by

terms in the fund's rider. The declared crediting rate will never be set below 1.0%. The plan's unit value increases daily due to the monthly crediting rate, cell crediting rates and interest rate enhancement, if applicable. Past crediting rates are not indicative of future rates. Daily transactions are valued at the plan's unit value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023 was \$5,787,708 and \$5,272,188, respectively.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PLAN TERMINATION

NOTE 7 - TAX STATUS

The Company adopted a Volume Submitter Profit Sharing Plan (the VSPPS Plan) sponsored by Standard Retirement Services, Inc. The Internal Revenue Service has determined and informed the Trustee by a favorable opinion letter dated March 31, 2014, that the VSPPS Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain investments are units held in pooled separate accounts managed by Standard Insurance Company. The Plan issues notes to participants which are secured by the balances in participants' accounts. These transactions qualify as a party-in-interest transactions for which a statutory exception exemption exists.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for plan benefits.
