To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of APDerm Management LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of APDerm Management LLC 401(k) Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing 401(k) plan, covering employees of APDerm Management LLC and its affiliates (collectively, the Employer) who have attained the age of eighteen, as defined by Plan provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All investments are participant-directed.

Compass 360, LLC is the administrator of the Plan and has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Reliance Trust Company (Reliance) is the appointed trustee of the Plan, and acts at the direction of the Plan Administrator.

Contributions

Participants may elect to contribute up to 100% of their annual pretax compensation, as limited by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers). The Plan also provides for participant catch-up, Roth and Roth catch-up contributions.

The Employer makes safe harbor matching contributions equal to 100% of the first 3% of the participant's eligible compensation and 50% of the next 2% of the participant's eligible compensation totaling \$1,468,241 for the year ended December 31, 2024. A participant is eligible to receive Employer matching contributions after completing one year of service, with quarterly entry. The Employer may make discretionary matching contributions in an amount equal to a percentage of the amount contributed by each participant. The discretionary matching contributions may be limited to a certain dollar amount.

The Employer may also make non-elective contributions to the Plan. A participant is eligible to receive non-elective Employer contributions after completing one year of service and 1,000 hours, with quarterly entry.

There were no discretionary matching or non-elective contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's contribution, and their allocation of Plan earnings/losses and any expenses incurred.

Allocations are based on participant compensation or individual participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer safe harbor matching contributions plus the allocation of Plan earnings on those contributions, at the time of allocation. Participants become vested in the Employer discretionary matching and non-elective contributions and the allocation of Plan earnings on those contributions as follows: 20% after 2 years, 40% after 3 years, 60% after 4 years, 80% after 5 years and 100% after 6 years of employment. Participants are immediately vested in all accounts upon death, disability, or attainment of retirement age 65.

Participant Notes Receivable

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 within the last twelve-month period or 50% of their vested account balance. Terms range from one to five years, or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate comparable to the current interest rates charged by financial institutions for similar loans. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan allows for in-service distributions of the participant's vested accounts upon reaching the age of 59-1/2, attainment of normal retirement age or due to hardship, as defined by the Plan. In-service withdrawals are also permitted for Rollover account balances at any time. Upon termination of employment for any reason, a participant or beneficiary will be entitled to the value in their vested account balance. If a participant's vested balance is equal to or less than \$1,000, the participant will receive an immediate cash-out of their vested account balance, and the non-vested portion shall be treated as a forfeiture. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$5,000, the amount will be rolled over to an individual retirement plan designated by the Plan Administrator, unless otherwise directed by the participant. Participants with vested balances exceeding \$5,000 will receive a lump sum distribution, with partial or installment distributions permitted only to satisfy minimum distribution rules.

Effective January 1, 2024, the Plan adopted the qualified birth or adoption distribution provision of the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), to provide participants with distributions up to \$5,000 during the one-year period beginning on the date on which the participant's child is born or on which the legal adoption by the participant of an eligible adoptee is finalized.

Forfeitures

A participant forfeits the unvested portion of his or her account after incurring five one-year breaks in service. Forfeited non-vested accounts may be used to reduce Employer matching contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,218 and \$450, respectively. Forfeitures of \$450 were used to pay administrative expenses of the Plan during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-responsive Investment Contract

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

The Plan has an investment in the Stable Value Core Option, a group annuity contract issued by Transamerica Life Insurance Company (TLIC), which meets this requirement. The Plan's investment in this fund, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds, is recorded at contract value which approximates fair value.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

Contributions

Participant and Employer matching contributions are recorded each pay period, as applicable, when the Employer remits the contributions for investment into the Plan.

Payment of Benefits

Benefits are recognized when paid to participants or their designated beneficiaries.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management and recordkeeping fees, if applicable, are paid by the Plan through revenue sharing as a reduction of investment income (net appreciation or depreciation) from the related investment fund.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held one investment that accounted for approximately 12% and 10% of total plan investments as of December 31, 2024 and 2023, respectively.

Financial Instruments with a Concentration of Credit Risk

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

Subsequent Events

Management has evaluated subsequent events through July 31, 2025, which is the date these financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds are reported at level 1 within the fair value hierarchy.

4. Fully Benefit-responsive Investment Contract

The Plan has an investment in the Stable Value Core Option, a group annuity contract, which is a traditional fully benefit-responsive investment contract. Contributions to this fund are deposited into the TLIC's general account.

The account is credited with participant contributions, plus earnings, and charged for participant withdrawals and administrative expenses. The insurance company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There is no minimum crediting rate under the contract and it is reviewed on a semi-annual basis for resetting. The contract's credit rate at December 31, 2024 and 2023 was 1.65% and 1.25%, respectively. The guarantee of values provided for investments made with TLIC under the Plan's investment contract is based on the financial strength and claims-paying ability of TLIC.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. In order to maintain the issuer's promise to pay withdrawals and exchanges at contract value, the contracts subject the fund and its participants to certain restrictions, such as withdrawals prompted by certain events (e.g., full contract discontinuance or partial contract discontinuance) and may be paid at market value of the fund's securities, which may be less than contract value, or may restrict withdrawals in these events. It is not probable that these events will occur. There are no events that allow TLIC to terminate the contract which require the Plan sponsor to settle at an amount different than contract value.

5. Plan Termination

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

6. Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Summary of Financial Data Certified by the Trustee

The following is a summary of financial information and data certified by the trustee, Reliance:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for contributions receivable and liabilities, if any;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

8. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items. Total Plan assets are in agreement.

9. Related Party Transactions and Party-in-Interest Transactions

Plan investments are held and managed by Reliance, the trustee of the Plan, and Transamerica is the recordkeeper for the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the recordkeeper for administrative services totaling \$63,216 for the year ended December 31, 2024. The Plan also made payments of approximately \$30,000, \$5,100, and \$19,600 to its investment advisor, third-party administrator, and accountants, respectively. In addition, participant notes receivable qualify as party-in-interest transactions.
