### (1) Plan Description

The following description of the Costco Puerto Rico Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description. Participants in the Plan are employees of Costco Wholesale Corporation (the Company) in Puerto Rico.

The Plan is a defined-contribution plan established by the Company under the Puerto Rico Internal Revenue Code (PRIRC). It includes a qualified cash or deferred arrangement, as described in the PRIRC, for the benefit of eligible employees. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### (a) *Eligibility*

The Plan allows employees at least 18 years of age who have completed 90 days of service within a 12-consecutive-month period to make salary-deferral contributions and receive matching contributions commencing the first day of the month following the completion of 90 days of employment. Participants are eligible for the Company's discretionary contribution after completing one year of service and attaining the age of 18.

#### (b) *Employee Contributions*

Each year participants may contribute from 1% to 50% of their compensation before income taxes, subject to certain limitations set by the Puerto Rico Treasury Department (PRTD). Participants may also contribute distributions from other qualified benefit or contribution plans (rollover contributions).

All newly-eligible participants entering the Plan are automatically enrolled at a salary contribution rate of 4%. On an active participant's employment anniversary date and each anniversary date thereafter the percentage deferred into the Plan automatically increases by one percentage point, to a maximum of 20%. Employees may opt out of automatic enrollment and increases. Contributions are subject to regulatory requirements.

#### (c) *Employer Contributions*

The Company matches 50% of each employee's contribution up to a maximum of \$500 per year. In addition, the Company may contribute a discretionary amount into the account of each participant who is employed by the Company on the last day of the Plan year. A discretionary contribution was approved for 2024, totaling \$4.7 million and ranged from 4% to 9% of eligible compensation based on years of service. The discretionary contribution was deposited into the Plan and allocated to participant accounts in March 2025.

All Company contributions are made in cash and invested in accordance with selections made by the participants. The Retirement Fund corresponding to the participant's age is the default investment option.

#### (d) *Participants' Accounts*

Each participant's account is credited or debited with the participant's contributions, the Company's contributions, earnings and losses, fees, expenses, and changes in underlying account assets. The benefit to which a participant is entitled is the vested account balance.

(e) ***Vesting***

Participants are immediately vested in their deferral contributions and in certain other contributions as defined in the Plan document, adjusted for net value changes.

Effective for participants employed on or after August 1, 2024, vesting in any form of employer contributions are 100% vested and nonforfeitable. Prior to this date, the Plan had a 5-year graded vesting schedule.

(f) ***Forfeitures***

Forfeited amounts are used to reduce employer contributions, funded subsequent to each year. Forfeitures during 2024 and forfeiture balances as of December 31, 2024 and 2023, were immaterial. Forfeitures are restored to a participant's account if within five years the participant is re-hired and repays the vested account balance distributed upon termination.

(g) ***Investment Options***

Participants may direct their accounts to the Plan's investment options. Participants may change their investment options and transfer amounts between funds daily. Amounts may be temporarily invested in a cash account prior to investment in investment accounts.

(h) ***Distributions***

Upon termination of employment, total disability or death, the vested interest in a participant's account is payable in a lump sum, unless a participant or beneficiary elects an installment distribution. Participants may apply for a distribution of all or a portion of the vested interest at any time after attaining the age of 59-1/2. Participants are also eligible to make withdrawals from their salary deferral contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of twelve months.

(i) ***Notes Receivable from Participants***

A participant may borrow between \$1,000 up to the lesser of \$50,000 or 45% of their vested account balance, reduced by the highest outstanding balance in the previous 12 months minus the outstanding balance of all loans on the date on which the loan is made, provided this amount is available in the participant's pre-tax and rollover accounts. Loans are repaid through payroll deductions over a period ranging up to four years or, if for the purchase of a principal residence, up to 15 years. The bi-weekly repayment amount cannot exceed 25% of the participant's net pay. The interest rate is determined by the Plan Administrator from time-to-time and is comparable to rates charged by commercial lenders. At December 31, 2024, interest rates on loans outstanding ranged from 9.00% to 10.50%, with various maturities through January 2039. Participant accounts with loans are charged an application fee at initiation and an annual maintenance fee.

(j) ***Trustee, Recordkeeper, and Plan Administrator***

Banco Popular de Puerto Rico is the trustee and T. Rowe Price Retirement Plan Services Inc. is the recordkeeper for the Plan. The Plan Administrator is the Costco Benefits Committee.

(k) ***Administrative, Recordkeeping, and Investment Expenses***

Certain administrative expenses, and recordkeeping and investment fees including investment management and transaction fees, are paid by the Plan. Certain of those expenses are charged to participant accounts.

(l) **Subsequent Events**

The Plan monitors significant events occurring after the statement of net assets available for benefits date and prior to the issuance of the financial statements to determine the impacts, if any, of events on the financial statements to be issued. The Plan has evaluated subsequent events through the date which the financial statements are issued.

(2) **Significant Accounting Policies**

(a) **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates and assumptions.

(c) **Investment Valuation and Income Recognition**

The Plan invests in common collective commingled trusts and registered investment company funds that invest in a combination of stocks, bonds and other investment securities. The investments are reported at fair value as certified by the Plan's trustee. If available, quoted market prices are used to value investments.

Investment securities are exposed to risks, such as interest rate, credit and overall market volatility risks. Changes in the values of investment securities could occur, and those changes could materially affect the amounts reported in the statements of net assets available for benefits and participant balances.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the change in the fair value of assets from one period to the next, plus realized gains and losses.

(d) **Notes Receivable from Participants**

Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. Loans were not allowed under the Plan until January 1, 2024.

(e) **Distribution of Benefits**

Distributions of benefits are recorded when paid.

(3) **Fair Value Measurement**

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is estimated by applying a fair value hierarchy, which requires maximizing the use of observable inputs. The three levels of inputs are:

Level 1: Quoted market prices in active markets for identical assets or liabilities.

Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3: Significant unobservable inputs that are not corroborated by market data.

Valuation techniques utilized during the reporting period were not changed from previous practice. The following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment company funds:*

Valued at the closing price reported in the active market in which the individual securities are traded. These assets are valued using Level 1 inputs.

*Common collective commingled trust funds:*

The valuation techniques used to measure the fair values of the common collective commingled trust funds are based on quoted market prices, such as quoted net asset values (NAV) published by the fund as supported in an active market. Plan participant transactions of investment or withdrawals may occur on a daily basis. These funds are valued using Level 1 inputs.

The tables below present information regarding investments that are measured at fair value on a recurring basis and indicate the level within the hierarchy reflecting the valuation techniques utilized to determine fair value as of December 31, 2024, and 2023.

**(4) Plan Termination**

Although it has no present intent to do so, the Company has the right under the Plan at any time to discontinue its contributions and to terminate the Plan, subject to ERISA. In the event of termination, participants remain 100% vested in their accounts.

**(5) Tax Status**

In a letter dated September 21, 2018, the PRTD informed the Company that the Plan was designed in accordance with applicable sections of the PRIRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the requirements of the PRIRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the PRIRC. The Plan Administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a

### **(7) Party-in-Interest and Related Party Transactions**

Plan investments include shares of common collective commingled trust funds and registered investment company funds managed by T. Rowe Price Trust Company or T. Rowe Price Associates, Inc., which are affiliates of the recordkeeper for the Plan, T. Rowe Price Retirement Plan Services, Inc. These transactions qualify as exempt party-in-interest transactions.
