- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UHA 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note B to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UHA 401(k) Plan's ability to continue as a going concern for one year after the date financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of UHA 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about UHA 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note B.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) (modified cash basis) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed

to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule (modified cash basis), we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule (modified cash basis), other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule (modified cash basis) related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF THE PLAN

The following description of the UHA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan established March 1, 1997 for the benefit of all eligible employees of University Health Alliance (the “Employer”) under the provisions of Section 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is administered by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

Employees are eligible to participate in the Plan upon their date of hire. Student hires and interns are not eligible to participate in the Plan unless they complete 1,000 hours of service during the plan year. Leased employees (except employees leased through Tilson HR, Inc., Tilson HR of Florida, and THR Solutions, Inc.) and collectively bargained employees are not eligible to participate in the Plan.

3. Contributions

Participants may elect to contribute on a pre-tax basis and/or make Roth contributions, up to the maximum deferral limit per Section 402(g)(1) of the IRC. The Plan has an automatic deferral increase arrangement whereby the percentage that a participant elects to defer is increased by 1% of compensation on an annual basis, up to a maximum of 10%. Participants may opt out of this arrangement. In addition, the Plan maintains an automatic contribution arrangement, whereby eligible participants are automatically enrolled in the Plan at a deferral rate of 10% of compensation, unless the participant affirmatively elects a greater or lesser percentage (including zero). Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions.

In addition, participants may also make after-tax contributions. After-tax contributions totaled \$50,205 during the year-ended December 31, 2024.

Employer matching and profit sharing contributions to the Plan are discretionary. During 2024, the Employer made matching contributions in an amount equal to 50% of a participant’s pre-tax and Roth contributions up to 10% of compensation. During the year ended December 31, 2024, Employer matching contributions totaled \$635,828 (net of applied forfeitures of approximately \$27,000).

3. Contributions (Continued)

Discretionary profit sharing contributions for the year ended December 31, 2023, which were equal to 4% of compensation for eligible employees and totaled \$547,158, are reflected in the accompanying 2024 financial statements as the contributions were funded to the Plan in 2024. Discretionary profit sharing contributions for the year ended December 31, 2024, which were also equal to 4% of compensation for eligible employees, totaled \$619,709 and will be reflected in the Plan's 2025 financial statements as the contributions were funded to the Plan in 2025.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions as desired in any of a variety of options held by Empower Trust Company, LLC ("Empower"), trustee, as provided by the Plan. Participants may change their investment options daily.

5. Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve month period. New loans shall bear an interest rate of prime plus one percentage point. Loans must be repaid within five years of the date of issuance in accordance with terms established by the plan administrator. Loans for the purchase of a principal residence may be repaid over a longer period of time. A participant may only have one loan outstanding at any time.

6. Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and Plan earnings. Employer profit sharing contributions are allocated based on the same ratio each participant's compensation bears to the compensation for all participants. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF THE PLAN (Continued)

7. Benefit Payments

Upon termination of employment, a participant will be entitled to an amount equal to the value of his or her vested account balance. When a participant attains normal retirement (or qualifying early retirement), incurs total and permanent disability, or dies while employed, the participant or the participant's beneficiary is entitled to 100% of the participant's account balance. In addition, participants may request distributions upon attaining age 59 1/2 or for financial hardship if certain criteria are met.

8. Forfeitures

Forfeitures of terminated participants' non-vested accounts may be used to pay administrative expenses of the Plan or to reduce future Employer contributions. Forfeitures of terminated non-vested account balances available as of December 31, 2024 and 2023 totaled \$344 and \$309, respectively.

9. Vesting

Participant contributions, participant rollover contributions, and Employer qualified non-elective contributions and actual earnings on all such contributions are fully vested at all times. However, vesting in the Employer matching and Employer profit sharing contribution portions of participant accounts, plus actual earnings thereon, is based upon the participant's years of service with the Employer as follows:

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The financial statements of the Plan are prepared using the modified cash basis of accounting, under which contributions and investment income are recorded when received, rather than when earned, and distributions and expenses are recorded when paid, rather than when incurred. That basis differs from accounting principles generally accepted in the United States of America primarily because the Plan has not recognized Employer contributions receivable, accounts payable, and their related effects on earnings in the accompanying financial statements.

2. Plan Administration

The Employer is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Payment of Benefits

Benefits are recorded when paid.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest income are recorded when received. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

5. Administrative Expenses

Administrative expenses incurred by the trustee and recordkeeper in performance of their duties are paid from the assets of the Plan. Other reasonable plan expenses may be paid from the Plan's forfeiture account. The Employer paid substantially all other out-of-pocket expenses. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of assets.

6. Notes Receivables from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

7. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded when received by the Plan.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December, 31 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Collective investment trusts: Valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Stable value collective investment trust: A stable value collective investment trust seeks to preserve principal and achieve high current income through a diversified portfolio of high-quality investment contracts. To implement this objective, this fund's underlying investment is the Putnam Stable Value Fund, and the fund is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower Trust Company, LLC is the trustee of the Plan's assets, and Empower Retirement Services is the recordkeeper. Transactions with these entities qualify as party-in-interest transactions. Notes receivable from participants of the Plan and the related interest income are also considered party-in-interest transactions.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits (modified cash basis).

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions, and the assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner prescribed by the Plan provisions and the IRC.

NOTE H - TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan with a cash or deferred arrangement (non-standardized plan) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the non-standardized plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The financial statements are presented on a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America; therefore, plan management is not required to recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would be unsustainable upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through July 11, 2025 the date the financial statements were available to be issued.
