We are submitting this letter as a statement of reasonable cause for the late filing of the Form 5500 for the Elite Manufacturing Technologies (EMT) 401(k) Plan for the plan year ending December 31, 2023.

This plan was merged into the Cadrex 401(k) Plan effective January 1, 2024 as part of a larger company integration effort. During the transition, we worked with the plan's recordkeeper, Principal, and third-party auditor, CLA, to complete the plan's year-end processes and final audit for 2023. However, due to the transition of responsibilities and changes in service providers, it was unintentionally overlooked that a final Form 5500 filing was still required to formally close out the EMT plan.

As soon as this oversight was discovered during our current plan audit cycle, we took immediate steps to prepare and submit the required Form 5500 to bring the plan into compliance.

We respectfully request that the DOL and IRS consider this a good faith error due to organizational restructuring and vendor transition, and that no penalties be assessed. We are committed to ongoing compliance and have implemented internal measures to prevent this type of oversight in future plan transitions.
