Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CareOregon, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the CareOregon, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement, as amended, for a more complete description of plan provisions.

General - The Plan is a 401(k) defined-contribution salary deferral plan covering substantially all employees of CareOregon, Inc. (the Company) and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as plan administrator. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company), Principal Life Insurance Company and Principal Global Investors Trust Company, serve as custodian and/or trustee, and Principal Financial Group serves as the recordkeeper of the Plan. Certain executives of the Company serve as trustees of the Plan.

Eligibility - Employees of the Company are eligible to participate in the Plan on the first day of each month upon reaching age 18. Employees must be employed on the last day of the year to receive a discretionary profit-sharing contribution.

Contributions - Participants may elect to contribute employee pretax elective deferrals and/or Roth contribution amounts from their paychecks up to 75% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollover). The Plan includes an auto-enrollment provision whereby 4% of the compensation of newly eligible participants will be automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect to contribute a lower or higher amount. Participants who do not make a deferral election will receive an automatic deferral election increase of 1% annually in June of each year until reaching the 8% maximum deferral election, unless the participant elects differently.

The Company matches of 100% on the first 2% of participant contribution and 50% on the next 2% of eligible compensation deferred to the Plan. The Company also contributes 3% of each participant's compensation as a safe harbor nonelective contribution. During the years ended December 31, 2024 and 2023, the Company made an additional discretionary profit-sharing contribution of 1.5% and 3%, respectively. Discretionary contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation.

The total employer contribution was \$10,985,293 and \$10,943,425 for the years ended December 31, 2024 and 2023, respectively.

Participant contributions, company matching and safe harbor contributions are recorded in the year in which the employee contributions are withheld from compensation. Contributions are subject to regulatory limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The Plan currently offers various registered investments (mutual funds), pooled separate accounts, and a collective trust as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. In addition, the Company's 3% safe harbor contribution immediately vests to the participant. In general, vesting in discretionary contributions and matching are based on years of service, as defined in the Plan document, with employees becoming fully vested after three years.

Payment of Benefits - Upon termination of service, death, disability, or retirement, a participant will receive their benefits as a lump sum amount equal to the value of the participant's vested interest in his or her account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. Account balances that are under \$1,000 may be automatically paid out at the discretion of the Company. Balances between \$1,000 and \$7,000 may be transferred to an IRA, also at the discretion of the Company.

Expenses - Administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts. Expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel are provided by the Company without charge to the Plan.

Forfeitures - Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan until used to reduce the Company's contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$950 and \$26,214, respectively. For the years ended December 31, 2024 and 2023, the Company's matching and profit-sharing contributions were reduced by \$301,839 and \$330,271, respectively, from forfeited nonvested accounts.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared using the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments in mutual funds, pooled separate accounts and common/collective trust.

Notes Receivable from Participants - Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments - Benefits are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid at year-end have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Units held in pooled separate accounts are valued using the net asset value (NAV) of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a pooled separate account is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund. The NAV of the fund is determined daily based on net assets at fair market value, and plan participants can transact at that NAV on a daily basis.

Each pooled separate account seeks a total return consisting of long-term growth of capital and current income. Of the 18 pooled separate accounts, 12 operate as “target date funds.” Target date funds invest in underlying Principal Funds, Inc. (PFI) domestic and foreign equity, real estate investments, and fixed-income funds (the Funds) according to an asset allocation strategy designed for investors having a Common Collective Trust investment time horizon comparable to that of the fund. Each Fund’s asset allocation will become more conservative over time as investment goals near (for example, retirement, which is assumed to begin at age 65) and investors become more risk-averse. The Funds invest in PFI Institutional Class shares of the underlying funds. These pooled separate accounts can be redeemed at NAV as of the measurement date.

Common/collective trust: Units held in the common/collective trust are valued at fair value using the NAV of the trust. The NAV of a collective investment is calculated based on a compilation of primarily observable market information. The NAV of the trust is determined daily based on net assets at fair market value, and plan participants can transact at that NAV on a daily basis. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemption activity in the trust. The Plan has investments in the Principal Stable Value Fund (the Trust), which is a common/collective trust and is designed to provide preservation of capital and returns that are consistent regardless of stock and bond market volatility. The Trust seeks to earn a high level of income consistent with those objectives. The Trust holds guaranteed investment contracts, which typically have a fixed maturity. Each contract contains a provision that the issuer will, if required, repay principal at the stated contract value for the purpose of paying benefit payments.

NOTE 4 – NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000, up to 50% of participants' vested accounts, but not in excess of \$50,000. Loans are subject to certain restrictions and are secured by the balance of the participant's account. Loans bear fixed reasonable rates of interest, as determined by the plan administrator. The maximum loan term is five years, unless the loan qualifies as a home loan, in which case the term of the loan may be longer than five years up to ten years. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 3.25% to 8.50%, with various maturities through November 28, 2034.

NOTE 5 – INFORMATION CERTIFIED BY TRUSTEE AND CUSTODIANS OF THE PLAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule, Schedule H, Line 4i – *Schedule of Assets (Held at End of Year)*, that was certified by the trustee, Principal Global Investors Trust Company, and the custodians, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, as of December 31, 2024 and 2023 and for the years then ended, and furnished to the plan administrator. The plan administrator has obtained certification from the trustee and custodians that such information is complete and accurate.

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Principal Trust Company is the issuer of the Principal Stable Value Fund. Plan investments also include pooled separate accounts managed by Principal Trust Company, the trustee, and therefore, transactions with these entities qualify as exempt party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Upon termination, the Company may continue the Plan to pay benefits as they mature or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to participants in proportion to their interests.

NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. There were two investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of that date.

NOTE 9 – INCOME TAX STATUS

The Plan is an adoption of a non-standardized pre-approved profit-sharing plan sponsored by Principal Life Insurance Company. The non-standardized pre-approved profit-sharing plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however; there are currently no audits for any tax periods in progress.

NOTE 10 – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to increase the automatic deferral rate from 4% to 6% as well as to increase the automatic maximum deferral election from 8% to 12%.

The Plan's management has performed an evaluation of subsequent events through August 4, 2025, which is the date these financial statements were available to be issued.
