To the 401(k) Plan Administrative Committee and Participants
Planar Systems, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Planar Systems, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Planar Systems, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. Description of Plan

The following description of the Planar Systems, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution savings and profit-sharing plan established by Planar Systems, Inc. (the “Company”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan is administered by the 401(k) Plan Committee that is comprised of employees of the Company and an investment advisor. The Plan utilizes a prototype plan document provided by the Great-West Trust Company, the trustee of the Plan.

b. Eligibility

Employees of the Company who have attained the age of 21 years, and are not covered by a collective bargaining agreement or are not nonresident aliens, are eligible to participate in the Plan upon their hire date.

c. Participant Contributions

Participants may defer up to 100% of their eligible compensation, limited by requirements of the IRC. Upon reaching the age of 50, eligible employees may make additional catch-up contributions as allowed by the IRC. Participants may also roll over amounts representing pre-tax distributions from other qualified plans into the Plan.

d. Employer Matching Contributions

The Company matches 100% of the first 3% of eligible compensation deferred and 50% of the next 2% of eligible compensation deferred during the Plan year, measured on an annual basis. The Company may also make nonelective contributions to the Plan at the discretion of the Company's board of directors. No nonelective contributions were made during 2024 or 2023.

e. Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's contributions, and an allocation of the Plan's net earnings (losses) and expenses. Allocation of earnings (losses) is based on the proportion of the participant's account balance to the total of all participants' account balances.

Participants are immediately vested in their elective contributions, all Company contributions, and any earnings thereon.

f. Payment of Benefits

Upon termination, death, disability, or retirement, the participant (or beneficiary) may elect to receive distributions of benefits in a lump sum or in monthly, quarterly, semi-annual, or annual installments over a period not to exceed the participant's life expectancy. Account balances less than \$5,000 but greater than \$1,000 are distributed in the form of a direct rollover to an individual retirement account designated by the Plan administrator. Account balances less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

g. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, a portion of their account balance as a result of an immediate and heavy financial need, assuming the participant has received all other available distributions and loans under the Plan. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of burial or funeral costs of immediate family members, the payment of natural disaster clean-up on the participant's principal residence or to prevent eviction or foreclosure from the participant's principal residence. A participant's right to make deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

h. Notes Receivable from Participants

Participants may borrow the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest balance of loans in the prior 12 months, subject to a \$1,000 minimum and certain other restrictions. Participants may only have one loan outstanding at any given time. As these loans are repaid by the participant, the proceeds, including interest, are returned to the participant's account. Loans are payable through payroll deductions over periods ranging from one to five years. The interest rate on participant loans is the Prime Rate, plus 1% per annum, and is fixed at inception of the loan. The interest rate on outstanding loans at December 31, 2024 ranges from 4.25% to 9.50% with the loans maturing through to 2029.

If an active participant discontinues making payments and fails to make payments when they are due under the terms of the loan, the loan will be considered to be in default. Upon an event of default, all principal and interest is due and payable as of the date of the missed payment. However, the amount of the defaulted loan will not be considered distributed to the participant until 90 days after the calendar quarter in which an event of withdrawal occurs (a deemed distribution).

i. Forfeitures

Participants who terminate employment forfeit any non-vested portion of the employer contributions and earnings thereon. Forfeited amounts may be used to reduce future employer contributions. At December 31, 2024 and 2023, forfeitures totaling approximately \$1,700, were available to reduce future employer contributions. No forfeitures were utilized to offset the 2024 and 2023 employer contribution.

2. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

b. Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management of the Plan to make a number of estimates and assumptions that relate to the reported amounts of assets and the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates under different assumptions or conditions.

c. Investment Valuation and Income Recognition

Investments are reported at fair value, with the exception of the Key Guaranteed Portfolio Fund, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Net appreciation in fair value of investments consists of the net change in unrealized gains or losses on mutual funds during the year and the realized gains or losses on mutual funds sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date.

d. Contribution Receivables

Contribution receivables are contributions earned during the year but not received until the subsequent period due to the timing of the deposit and can be from either the Company or the participants. Contribution receivables are recorded at amortized cost and due to its nature, the Plan does not establish an allowance for credit losses for contribution receivables.

e. Notes Receivable from Participants

Notes receivable from participants are recorded at amortized cost-plus accrued interest. The Plan does not establish an allowance for credit losses on notes receivables since the receivables are fully secured by the participants' contributions to the plan.

f. Payment of Benefits

Benefit payments to participants are recorded upon distribution.

g. Administrative Expenses

Certain loan and administrative fees are paid by the Plan. Certain expenses are included in the transaction prices of investments bought and sold and cannot be separately quantified. The Plan

charges certain distribution fees to impacted participants. The Company pays substantially all other administrative expenses incurred by the Plan.

3. Investments

Participants can direct their accounts among various mutual funds, a common collective trust, and a guaranteed investment contract offered by Great-West Life and Annuity Insurance.

The Cohen and Steers US Realty CIT RS (the “Trust”) is a common collective trust investing primarily in a diversified portfolio of common stocks of real estate companies and other permitted investments and seeks to achieve maximum total return by outperforming its benchmark over the long term.

Earnings from the investment in common collective trust is included in dividends and interest on the accompanying statements of changes in net assets available for benefits.

The investment contract offered is the Key Guaranteed Portfolio Fund (the “KGPF”), which is a fully benefit-responsive group annuity contract. The KGPF invests primarily in mortgage loans, policy loans, and bonds such as Securities issued by states, territories and possessions and political subdivisions in the U.S., mortgage-backed securities as well as other debt and other fixed-income securities. The value of the KGPF is determined as the value of the sum of Participant’s KGPF contributions and deposits plus interest to the KGPF minus the sum of 1) any amounts distributed, 2) any transfers from the KGPF, and 3) any applicable fees and charges. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Certain events may result in the KGPF not transacting at contract value such as excessive trading, market closings, plan terminations, partial plan terminations or changes in laws or regulations.

The KGPF credits interest daily on a portfolio basis. The crediting interest rate may change or stay the same each quarter and apply to all money deposited regardless of when it was deposited. The crediting rates as of December 31, 2024 and 2023, were 1.45% and 1.30%, respectively. Earnings on the KGPF fund are included in dividends and interest income on the accompanying statements of changes in net assets available for benefits.

Either the Plan Sponsor or Great-West Life and Annuity Insurance may elect to terminate the contract at any time with an advance written notice to the other party. The contract allows three options to settle the funds upon contract termination, 1) payment at book value, 2) lump sum payments with market value adjustments, and 3) any other termination option allowable under applicable law as mutually agreed upon by both parties.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value

hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Shares valued based on the quoted market price on an active market as of the reporting date.

Common collective trusts: The Plan's interest in the common collective trusts are valued at the NAV of the common collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trust at year-end. The NAV is used as a practical expedient to estimate fair value. Participant transactions can occur daily.

5. Risks and Uncertainties

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and therefore participant account balances.

6. Information Certified by the Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following information included in the financial statements and supplemental schedule was provided and certified by Great-West Trust Company, the trustee of the Plan as of December 31, 2024 and 2023 and for the years then ended as complete and accurate:

- Investment income
- Investments, at fair value
- Investment, at contract value
- Schedule of assets (held at end of year)
- Notes receivable from participants
- Interest on participant notes receivable

7. Party-In-Interest Transactions

Certain Plan investment funds were managed by Great-West Trust Company. Great-West Trust Company is the trustee as of December 31, 2024 and 2023 and for the years then ended. Therefore, these investments and investment transactions qualify as party-in-interest transactions. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan sponsor, Planar Systems, Inc., is a party-in-interest to the Plan. However, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan which are exempt transactions.

8. Tax Status

The Plan utilized a prototype plan document provided by Great-West Trust Company, LLC ("Great-West"). Great-West obtained its latest prototype opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC.

The Plan has been amended since receiving the opinion letter. However, management of the Plan believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan sponsor and administrator believes the Plan is a qualified plan and the related trust is tax exempt as of and for the years ended December 31, 2024 and 2023.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Plan Termination

Although it has not expressed any intention to do so, the Company may terminate the Plan at any time. If this occurs, the affected participants shall receive their vested balance, which is their total account balance.

10. Subsequent Events

The Plan has evaluated subsequent events with respect to the Plan through July 28, 2025, the date the financial statements are available to be issued.
