Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carroll College 403(b) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

1. PLAN DESCRIPTION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of the Carroll College 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a 403(b) defined contribution plan covering all full-time employees of Carroll College (the Plan Sponsor) who normally work 20 or more hours per week. Employees are immediately eligible to make elective deferrals beginning on their date of hire and are required to make a minimum 5% contribution after three years of employment. Plan entry dates subsequent to their initial hire date are the first day of the month following election. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's Board of Trustees.

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Accounting Estimates The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions After one year of service, as long as the participant elects to contribute the full 5% of their gross base salary, the Plan Sponsor will provide a matching contribution of 100% of the first 5% of the participants' gross base compensation. After completing three years of service, employees are required to make mandatory contributions of 5% of compensation. Participants may contribute up to 100% of qualified compensation subject to the maximum limits set by the Internal Revenue Service (IRS). The maximum amount for voluntary elective deferrals was \$23,000 and \$22,500 for the Plan years ended December 31, 2024 and 2023, respectively. Eligible participants who are age 50 by the end of the plan year may also make additional catch-up contributions to the Plan. For 2024 and 2023, the maximum catch-up contribution was \$7,500.

Participant Accounts Each participant's account is credited with the participant's contributions, the sponsor matching contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately 100% vested in their account balance, which may include elective deferrals, mandatory participant contributions, actual earnings, and matching contributions.

(Continued)

Investment Redemption Fees Participants invested in TIAA-CREF International Equity Index Fund Retirement are subject to a 2.00% redemption fee if assets are held less than 60 days. Participants invested in TIAA Traditional Group Retirement Annuity and TIAA Traditional Retirement Choice are subject to a 2.50% surrender charge for a lump-sum withdrawal made within 120 days after termination of employment. No other fund options have redemption fees.

Expenses Certain operating expenses of the Plan are deducted from participant accounts, and the remaining expenses are paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Participant loans are generally limited to a minimum of \$1,000 and a maximum of one-half of the participant's vested account balance or \$50,000, whichever is less.

The maximum amount is determined based on the amount of the participant's accumulation under the Plan and any loans outstanding. Only three loans per participant can be outstanding at a time. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Repayment of the loan plus interest must be made within 5 years, or 10 years if the loan was used to purchase a primary residence. Principal and interest are paid ratably per the terms of the loan agreement. The interest rate on loans will vary depending upon how the participant's account balance is invested.

TIAA provides participants with an alternative plan loan option. Plan loans are issued directly from funds owned by TIAA. For plan loans, a portion of the participant's account is reserved, or held in collateral to cover 110% of the outstanding loan balance in case of default. For all plan loans, interest is paid directly to TIAA. These loans are not made from Plan assets. At December 31, 2024 and 2023, the balance of plan loans was \$-0-.

Payment of Benefits On termination of service due to death, disability or retirement, or upon attaining age 59½, a participant may elect to receive either a lump-sum amount or, if the vested balance of the participant's account is greater than \$1,000, they may also choose, partial payment, or annual installments over their life expectancy, or to apply the vested portion of their account toward the purchase of an annuity contract. Benefits are recorded when paid. At December 31, 2024 and 2023, there were no amounts due to participants who had withdrawn from the Plan for which distributions were in process.

Qualified reservist distributions and hardship distributions may also be made if participants meet certain qualifications. Participants may request distribution of rollover contributions at any time.

Plan Termination Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Investment Valuation and Income Recognition Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurement of Investments The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Variable Annuities: Valued at the daily closing price as reported by the fund. The funds invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's objectives. Fund investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments, including matrix pricing. CREF Money Market holdings are valued at amortized cost. These funds are required to publish their daily net unit value (NUV) and to transact at that price. The variable annuities held by the Plan are deemed to be actively traded.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the NUV of shares of an insurance company separate account invested mainly in real estate and real estate-related investments. The NUV is based on the fair value of the underlying investments held by the fund less its liabilities. The investment value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. Participant transactions may occur daily. Transfers out of the account are limited to one per calendar quarter.

Non-Benefit Responsive Investment Contract: Valued at fair value by the insurance company by discounting the related cash flows using an appropriate risk-adjusted market discount rate that correlates with TIAA Traditional Annuity's historical credit rates. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during the reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

Transfers into level 3 investment from level 2 totaling \$780,646 and \$1,022,623 for the years ended December 31, 2024 and 2023, respectively, were made because of the lack of observable market data due to decreased market activity for the securities. Transfers out of level 3 investments totaling \$559,120 and \$905,626 for the years ended December 31, 2024 and 2023, respectively, were made because observable market data became available for the securities. The Plan's policy is to recognize transfers into and out of level 3 as of the actual date of the event or change in circumstances.

There were purchases of level 3 investments totaling \$66,699 and \$73,433, for the years ended December 31, 2024 and 2023, respectively.

3. INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments and notes receivable from participants included in the statements of net assets available for benefits, and the investment income (loss) and interest income on notes receivable from participants included in the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by TIAA and CREF, qualified institutions that prepared and certified the information in accordance with 29 CFR 2520.103-5.

4. GUARANTEED INVESTMENT CONTRACTS

At December 31, 2024 and 2023, the Plan had holdings in the Group Supplemental Retirement Annuity (GSRA) and Supplemental Retirement Annuity (SRA) accounts included in the TIAA Traditional Annuity. The TIAA Traditional Annuity is a guaranteed annuity account backed by the claims-paying ability of Teachers Insurance and Annuity Association of America (TIAA), a New York domiciled insurance company. GSRA and SRA are direct fixed-dollar annuity contracts that are fully and unconditionally guaranteed and meet the fully-benefit responsive investment contract (FBRIC) criteria.

Contract value is the relevant measure for direct FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings and less participant withdrawals and administrative expenses.

Contributions to the GSRA and SRA accounts are used to purchase a contractual or guaranteed amount of future benefits for the participants. The GSRA and SRA accounts provide a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. The guaranteed annual interest rate has been 3.00% for all contributions (premiums) since 1979 under all TIAA Traditional Annuity accumulating contracts.

When the accumulation of the TIAA Traditional Annuity accounts are converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The contracts are presented in the statements of net assets available for benefits at contract value. The contract value of the GSRA and SRA accounts at December 31, 2024 and 2023, was \$1,112,354 and \$1,874,181, respectively.

For distributions from the GSRA and SRA accounts, other than as an annuity based on the account balance and the participant's assumed mortality rate, lump-sum withdrawals are available from the Plan only within 120 days after termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from the account must be spread over 10 annual installments (over five years for withdrawals after termination of employment).

The Plan's ability to receive amounts due in accordance with the direct contracts are dependent on the contract issuer's ability to meet its financial obligations. Certain events, such as premature termination of the contracts by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with TIAA. The Plan administrator does not believe that the occurrence of such events, which would also limit the Plan's ability to transact at contract value with Plan participants, is probable.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.

6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in note 1, the Plan has a number of service providers. Such parties are parties in interest under ERISA. Certain Plan investments are shares of mutual funds, variable annuities, and pooled separate accounts managed by TIAA and CREF. TIAA and CREF are the insurance providers and custodians; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these services are included in net appreciation in fair value of investments. The Plan Sponsor pays directly any other fees related to the Plan's operations. Certain administrative functions are performed by the employees of the Plan Sponsor. No such employee receives compensation from the Plan.

7. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the *Internal Revenue Code* (IRC). The Plan Sponsor adopted a volume submitter prototype plan document and is relying on the prototype sponsor's advisory letter from the IRS dated August 7, 2017. The letter states that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The prototype sponsor and the Plan administrator believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.
