Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of COPE Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about COPE Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**1. Description of the Plan**

*The following description of the COPE Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.*

*General*

COPE Community Services, Inc. (COPE) established the Plan, effective January 1, 2006, to provide employees with a systematic means of saving and investing for the future. Effective February 1, 2016, Pima Prevention Partnership (PPP) elected to participate in the Plan. COPE and PPP are collectively referred to as the “Organization”.

Only eligible employees are allowed to participate in the Plan. Employees are considered to be eligible unless they are specifically excluded from the Plan. Excluded employees include those employees who are eligible to participate in a Code section 457(b) eligible governmental plan maintained by the Employer in which employees may make elective deferrals.

All eligible employees of the Organization and its wholly owned subsidiaries, as defined in the universal availability standards are eligible to enroll on their date of hire. Elective deferrals may begin on the employee’s date of hire. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

*Plan contributions*

Effective March 6, 2009, the employer began automatically withholding 2% of a participant’s compensation each pay period and contributing that amount to the Plan as a pre-tax elective deferral. Effective July 1, 2021, the employer increased the automatic withholding to 3%. The employee can enter a salary reduction agreement at any time to select an alternative deferral amount or to elect not to defer in the Plan. The employer may contribute a discretionary matching contribution. All eligible employees of the Organization that have accumulated one year of service are eligible for the discretionary matching contribution. For the year ended December 31, 2024, the employer match was three percent of eligible compensation.

In addition to the discretionary match above, the employer can elect to contribute a nonelective contribution to the Plan which is unrelated to any elective deferrals the employee contributes. All eligible employees of the Organization that have accumulated one year of service are eligible for the discretionary nonelective contribution. Employer contributions are allocated to participants’ accounts based upon the ratio that the participant’s compensation bears to all participants’ compensation. For the year ended December 31, 2024 the employer made a discretionary nonelective contribution equal to five percent of the eligible participant’s compensation. During the year ended December 2024, the Organization contributed a total of \$1,320,429 for both the match and the nonelective contribution to the Plan.

*Participant accounts*

Each participant’s account is credited with the participant’s contributions, allocations of the Organization’s matching and nonelective contributions and Plan gains or losses. Plan gains and losses are credited to each participant account based upon the performance of the funds in which the participant is invested, as the investments are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**1. Description of the Plan - continued**

*Investment options*

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Organization's contributions into various mutual funds offered by the Plan.

*Vesting*

Participants are immediately vested in their voluntary contributions, matching and discretionary nonelective contributions and the actual earnings on their individual accounts.

*Benefits paid to participants*

Termination of employment

For participants with vested account balances greater than \$7,000, the vested account balance will remain in the Plan unless the participant elects to receive a lump sum distribution from the Plan or roll over the distribution to an IRA or other qualified plan. For participants with vested account balances between \$1,000 and \$7,000, if an election is not made to receive a lump sum distribution from the Plan or roll over the distribution to an IRA or other qualified plan, then the balance is rolled over into an IRA selected by the Plan employer. For participants with vested account balances of \$1,000 or less, if an election is not made to roll over the distribution to an IRA or other qualified plan, then the balance is distributed in a lump sum to the participant.

In-service distributions

The Plan allows for in-service distributions of vested account balances for participants who are 59½ at the time of the distribution and for "hardship withdrawals" subject to the requirements as defined in the Plan.

Required distributions

Participants that have not already begun taking distributions must begin taking required minimum distributions on the later of April 1<sup>st</sup> following the year of attaining age 72 or termination of employment.

Distributions upon death

Upon death of a participant, the vested balance of the participant's account is distributed to the participant's beneficiary(ies) as designated by the participant.

*Participant investment rollovers*

At the discretion of the Plan Administrator, participants may be permitted to transfer or rollover funds into the Plan from other qualified or 403(b) plans. Participants are always fully vested in their rollover funds.

*Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeited amounts can be used to reduce future employer contributions or plan expenses, if available.

**2. Summary of significant accounting policies**

*Basis of accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

*Use of accounting estimates*

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of certain assets, liabilities and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

*Investment valuation and income recognition*

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments bought and sold as well as held by the Plan during the year.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the plan year to the end of the plan year is included with realized gains/losses as “Net appreciation (depreciation) in fair value of investments” in the accompanying statements of changes in net assets available for benefits.

*Contributions*

Contributions from employees and the Organization are recorded in the period in which the Organization makes the payroll deductions from participant earnings.

*Distributions*

Distributions are recorded when paid. At December 2024 and 2023, there were no benefits processed and approved for payment, but not paid.

*Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

*Income tax status*

403(b) plans currently are not required to submit plans to the Internal Revenue Service for determination. However, the Internal Revenue has issued a letter dated January 1, 2018, that the volume submitter 403(b) plan adopted by the Organization is acceptable under section 403(b) of the Internal Revenue Code. The plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator believes that the Plan has not taken any uncertain tax positions. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**3. Investments (unaudited)**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the following information certified by the custodians of the Plan (Ascensus Trust Company and Fidelity Investments), except for comparing such information to the information included in the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

- Investments and cash and cash equivalents as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value and contract value of investments, interest and dividends, and administrative expense, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

**4. Fair value measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date. The Plan determines the fair value of its financial instruments based on the fair value hierarchy. The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect assumptions that the Plan believes a market participant would use in pricing the asset or liability based on the best information available in the circumstances, including assumptions about risk. Three levels of inputs are used to measure fair value. A financial instrument's level within the fair value hierarchy is based on the lowest level of input significant to the fair value measurement. Transfers between levels are recognized at the end of the reporting period.

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.

- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement. Assets and liabilities utilizing Level 3 inputs include: financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the fair value calculation requires significant management judgment or estimation.

Where quoted prices are available in an active market for identical instruments, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of investments with similar characteristics or discounted cash flows. In cases where there is limited activity or less transparency around inputs to the valuation, investments are classified within Level 3 of the valuation hierarchy.

The following is a description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan had \$19,790,662 and \$16,694,846 of investments in mutual funds at December 31, 2024 and 2023, respectively. The net asset value is used as a practical expedient to estimate fair value funds. This practical expedient would not be used if it is determined to be probable that the mutual funds will sell the investment for an amount different from the reported net asset value.

The underlying securities in Ascensus Trust Company and Fidelity mutual funds are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by Ascensus Trust Company and Fidelity approximates fair value of the investments. The investments are redeemable at the adjusted net asset value under agreements with Ascensus Trust Company and Fidelity. The methods described previously may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the end of the reporting date.

Participant transactions (purchases and sales) may occur daily subject to the short-term trading policies of the Plan Sponsor. Additional restrictions may be imposed at the request of the fund company of an underlying fund as outlined in their prospectus.

**5. Plan termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**6. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur.
