NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Go-Hire Employment and Development, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer defined contribution plan covering those employees of Go-Hire Employment and Development, Inc. (the "Plan Sponsor") and Knott County Center for Family Health (collectively, "the Company"). The Plan was established April 1, 2011 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Eligible employees, as defined in the Plan document, are able to make or receive contributions under the Plan beginning on their date of hire. Seasonal or temporary employees who are not expected to complete more than nine months of service are not eligible to participate. Effective January 1, 2024, long-term, part-time employees, as defined in the plan document, are eligible to make or receive contributions upon completing at least 500 hours of service for three consecutive years.

Contributions

The Plan permits eligible employees to make annual pre-tax contributions of up to the current Internal Revenue Service (IRS) limit through a salary reduction deferral election. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective January 1, 2025, catch-up contributions will no longer be permitted and employee deferral deductions will be limited to 75% of compensation per payroll period.

The Company's matching contribution to the Plan is discretionary. The Company's matching contribution is invested in the same manner as the employee contributions. Additional non-elective amounts may be contributed at the Company's discretion and are allocated to employee accounts based on the annual compensation of participants, and are invested in the same manner as employee contributions. Participants must complete at least 1,000 hours of service during the plan year and be employed by the Company on the last day of the Plan year to be eligible for any non-elective contributions. However, a participant will share in the allocation of non-elective contributions if they do not satisfy the last day and annual service requirements due to death, disability, or retirement. During the year ended December 31, 2024, the Company matched up to 3% of the annual compensation of participating employees.

Certain participant contributions in 2024 and 2023 were paid after the timeframe required by the Department of Labor. The late contributions and the related lost earnings for each year were remitted subsequent to the end of the year to which the late contributions related.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) plan earnings and (c) non-elective contributions made at the discretion of the Company, and charged with an allocation of administrative expenses. Non-elective allocations are based on the relationship of the participant's compensation to the total compensation for all participants. Other allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and non-elective portion of their accounts is based on years of continuous service. Using a graduated scale, a participant is 100% vested after five years of credited service. Participants are 100% vested in their entire account balances upon attainment of normal retirement age (as defined), disability, or death.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their fund accounts.

Payment of Benefits

Upon reaching the age 59-1/2, a participant may elect to receive a lump-sum payment of all, or part of, the value of the participant's vested account. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or, if permitted under the Plan at the time of distribution, an alternative form of payment. Upon termination of service for other reasons, a participant may elect to receive a lump-sum amount equal to the value of participant's vested account. Participants may elect to withdraw all or part of the value of any rollover contributions at any time. As defined in the Plan documents, certain participants are also eligible for hardship distributions, consistent with the provisions of the Internal Revenue Code. Effective January 1, 2025, in-service and hardship withdrawals are limited to one per participant per plan year.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,431 and \$18,610, respectively. The accounts may be used to reduce future Company contributions or pay administrative expenses. For the year ended December 31, 2024, \$108,207 of forfeitures were used to pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Contributions received from certain active participants are reported net of payment made to them in the subsequent year to return excess contributions as required to satisfy the relevant nondiscrimination provision of the Plan. That amount is also included in the Plan's statement of net assets available for benefits as excess contributions payable.

Subsequent Events

Plan management has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Trust Company, the custodian of the Plan, and Transamerica Life Insurance Company (TLIC), the group annuity contract holder, have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024, and investment-related activity reflected in the statement of changes in net assets available for benefits for the period July 1, 2024 to December 31, 2024. Reliance Trust Company, the prior custodian of the Plan, and TLIC have certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2023, and investment-related activity reflected in the statement of changes in net assets available for benefits for the period January 1, 2024 to June 30, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. FULLY-BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan holds a group annuity contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The Transamerica Stable Value Focus Option is a group variable annuity contract issued by TLIC and is backed by the full faith and creditworthiness of TLIC. All deposits in this investment are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is set semi-annually and effective on the first day of the semi-annual period. Contract charges may reduce this return.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the claims-paying ability of TLIC. Although Plan participants generally may withdraw assets from the Transamerica Stable Value Focus Option without restrictions, a hold may apply on the Plan's assets in the group annuity contract. If the Company wishes to remove the Transamerica Stable Value Focus Option as an option from the Plan, then TLIC may

impose a hold for up to a 270-day period on the investment assets at the Plan level if the most recently announced upcoming credited rate has increased or has not changed. The custodian will provide at least 45 days' advance notice of any interest rate change for each semi-annual period. Additionally, under limited circumstances occurring at the issuer, the custodian may impose up to a 12-month delay period on all withdrawal requests from all plan sponsors at the plan level. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value to be paid.

6. RELATED-PARTY AND PARTY-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as a fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. The Trustee is currently a participant in the Plan. TLIC is the issuer of the Plan's group annuity contract. Transamerica Retirement Solutions, LLC is the Plan's recordkeeper. Meridian Wealth Management, LLC is the Plan's investment advisor. ANEW 401k TPA, LLC is the Plan's third-party administrator. Blue & Co., LLC is the independent auditor of the Plan. Fees paid by the Plan to these service providers are included in administrative expenses on the accompanying statement of changes in net assets available for benefits. However, the aforementioned parties may receive payment from the Company.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the company contribution portion of their account.

8. TAX STATUS

The IRS has determined by an opinion letter dated June 30, 2020, that the non-standardized prototype adopted by the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended subsequent to June 30, 2020, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and that the trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
