INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Human Services Management Corporation 401(k) and Profit Sharing Plan
Milford, Massachusetts

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

1 – DESCRIPTION OF THE PLAN

General

The Human Services Management Corporation 401(k) and Profit Sharing Plan (the "Plan") is a defined contribution plan that has been established for the collective benefit of the employees of Human Services Management Corporation, Inc., Beacon ABA Services, Inc, and Behavioral Education, Assessment and Consultation Services of Connecticut, Inc., (collectively the "Company" or "Companies"). The Plan is funded by contributions from its participants and the Companies and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility for Participation

Employees become eligible to make voluntary deferral contributions to the Plan after three months of service. Employees become eligible for any safe harbor non-elective employer contribution after completing one year of service with at least 1,000 hours. All employees are eligible for any discretionary non-elective employer contributions after completing one year of service with at least 1,000 hours and must also be employed on the last day of the Plan year. However, any participant who becomes disabled, retires, or dies during a Plan year is exempt from the service or employment on the last day of the Plan year eligibility requirement.

Contributions

For each Plan year, the Companies may decide to provide a safe harbor non-elective employer contribution on behalf of eligible participants in an amount equal to not less than 3% and not more than 25% of participant's eligible compensation. In addition, the Companies may decide to provide a discretionary non-elective employer contribution that will be allocated by varying percentages based upon the following participant groups:

Population Group 1 - Participants who are age 45 or older with 10 or more years of vesting service as of the last day of the Plan year.

Population Group 2 - Participants who are age 35 or older with 5 or more years of vesting service as of the last day of the Plan year.

Population Group 3 - All other participants.

The Companies elected to make the discretionary non-elective employer contributions for the years ended December 31, 2024 and 2023.

While the Companies may also make discretionary matching contributions, no such contributions have been made.

Participants may contribute a percentage of compensation as defined in the Plan document and subject to limitations mandated by the Internal Revenue Code. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and any safe harbor non-elective employer contributions plus earnings thereon. For employer discretionary matching contributions plus earnings thereon, participants vest 25% for each year and are 100% vested at the end of four years. Participants vest in discretionary non-elective employer contributions plus earnings thereon in accordance with the following schedule:

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions, transfers, and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

The Plan was established with Fidelity Management Trust Company as its trustee. Upon enrollment into the Plan, a participant may direct employee and employer contributions in whole number percentages into a variety of investment options.

Notes Receivable From Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing lending interest rates for loans made under similar circumstances as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

In-service Withdrawals

Participants may make withdrawals prior to termination of employment under the following circumstances:

- Hardship withdrawals from a participant's deferred contributions account in accordance with the Plan document and the Internal Revenue Code.
- Withdrawal from a participant's rollover contributions account.

Retirement Benefits

The normal retirement age under the Plan is age 59 ½. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

Upon termination of employment, a participant may elect to receive the vested portion of his account in the form of a single lump sum payment or other forms of available annuity payments as defined in the Plan document. If a participant's vested account balance exceeds \$1,000 at the time of termination, the participant may defer payment of benefits until April 1 of the calendar year following the calendar year in which the participant attains age 73 or retires, whichever is later. If a participant's vested account balance is \$7,000 or less, the Plan Administrator will direct the trustee to distribute the account balance without the participant's consent.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the trustee.

As of December 31, 2024 and 2023, there were no distributions payable to participants.

Administrative Expenses

Certain administrative expenses are paid by the Plan and certain administrative expenses are paid by the Companies. Expenses paid by the Companies are excluded from the financial statements.

Forfeited Accounts

Forfeitures may be used to pay administrative expenses as directed by the Plan Administrator. If the Plan does not direct that forfeitures be used for administrative expenses, the forfeitures will be applied to reduce future Company contributions. Forfeitures are included with the Plan assets as of December 31, 2024 and 2023 totaling \$40,894 and \$35,136, respectively, and were invested in the Fidelity Government Money Market Portfolio mutual fund.

Participant-Directed Contributions, Withdrawals and Transfers

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted by the trustee. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and may include amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants that are in default are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when processed and approved for payment.

Risks and Uncertainties

The Plan provides for various investment options in various mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, July 24, 2025, for potential recognition or disclosure in the financial statements. The Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY TRUSTEE

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's trustee and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained a certification from the trustee that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Basis of Fair Value Measurement

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6 – PLAN TERMINATION

Although it has expressed no intent to do so, under the Plan, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a termination of the Plan, all participants will become 100% vested in their aggregate account balances and will be entitled to a lump-sum distribution.

7 – INCOME TAX STATUS

Fidelity Management and Research Company ("FMR") obtained an advisory letter from the Internal Revenue Service indicating its "Fidelity Basic Plan No. 17" is qualified under Internal Revenue Code Section 401. The Company has adopted FMR's Basic Plan No. 17.

Although the Company has amended the adopted plan document, the Company and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of shares of mutual funds and units of a common/collective trust managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan's assets and, therefore, these transactions qualify as party-in-interest.

Recordkeeping and investment advisory services were provided to the Plan during the year ended December 31, 2024 **and 2023** by the following parties-in-interest.
