Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Winchester Equipment Co. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of the Winchester Equipment Co. (the Company) 401(k) Plan (the Plan) provides only general information. The Company is the Plan administrator and sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have met certain eligibility requirements. Employees 18 or older are eligible for elective deferrals and discretionary matching contributions upon completion of 3 months of service. Employees are eligible for profit sharing contributions upon completion of one year of service. The entry dates for elective deferrals and matching contributions are the first day of the month after employees meet all of the applicable age and service requirement. The entry date for profit sharing contributions is the earlier of the first day of the Plan year or the seventh month of the Plan year after the employee has met the service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants who have not made investment elections are invested in accordance with the default investment alternatives established by the Plan.

Each year, the Company may make a discretionary matching or profit sharing contribution to the Plan. For the year ended October 31, 2024, the Company made a discretionary match contribution equal to 50% of the first 6% of the participants eligible compensation contributed as elective deferrals to the plan. The Company made a profit sharing contribution for the year ended October 31, 2024 of \$375,000. Employer profit sharing contributions are allocated based on eligible participant compensation. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's elective deferral contribution and an allocation of the Company's contribution. Allocation of Plan earnings, net of expenses attributable to investment funds are made proportionately based upon account balances to each participant's account. If a participant terminates employment before being fully vested, the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Forfeitures

At October 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,405 and \$9,934, respectively. Forfeitures attributable to profit sharing contributions may be allocated as additional discretionary nonelective contribution. For the year ended October 31, 2024, \$13,118 of forfeitures were reallocated as a discretionary nonelective contribution. For the year ended October 31, 2024, \$7,287 of forfeitures were used to reduce the profit sharing contribution.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. For Company matching contributions, a participant is 50% vested after two years and 100% after three years of credited service. For Company profit sharing contributions, a participant is 100% vested after six years of credited service, 20% after the first two years, and 20% each year thereafter.

Payment of Benefits

Upon death, disability, early retirement (which is the later of the date participants have attained age 55 or the 30th anniversary of the first day of the Plan year in which the participant commenced participation in the Plan), or normal retirement, which is defined as age 65, the participant becomes 100% vested in all of their accounts under the Plan and may begin receiving benefits. Participants who terminate service for other reasons may elect to receive their benefits as soon as administratively feasible after a break in service occurs. However, if the vested account balance does not exceed \$7,000 then a distribution of the account balance will be made regardless of participant consent.

On termination of service, if a participant's vested account balance does not exceed \$7,000, the account balance will only be distributed as a lump sum. If the amount of distribution exceeds \$1,000 and the participant does not elect to either receive or roll over the distribution, the distribution will be directly rolled over to an IRA. If the participant's vested balance exceeds \$7,000, the participant can elect to receive the distribution in a lump sum or by installments over a period of not more than the participant's or their beneficiary's assumed life expectancy.

Note 2. Summary of Significant Accounting Policies

This summary of significant accounting policies of the Plan is presented to assist in understanding the financial statements. The financial statements and notes are representations of the Plan's administrator, who is responsible for their integrity and objectivity. The accounting policies conform to the accounting principles generally accepted in the United States of America (GAAP) and have been consistently applied in the financial statements.

Notes to Financial Statements

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustee determines the Plan's valuation policies using information provided by the investment advisor and custodian. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The administrative expenses are paid by the Plan and consist of audit and third-party administration fees.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

Note 4. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Notes to Financial Statements

Note 5. Party-in-Interest Transactions

Certain Plan investments are managed by the trustee, Ascensus Trust Company and its affiliates and, therefore, these transactions qualify as party-in-interest transactions.

The trustee provides certain administrative services to the Plan pursuant to an agreement between the Company and the trustees. The trustee receives revenue from mutual fund service providers for services that the trustee provide to the funds. This revenue is used to offset certain amounts owed to the trustee for administrative services to the Plan.

If the revenue received by the trustee from such mutual fund service providers exceeds the amount owed under the agreement, The trustee remits the excess to the Plan's trust on a regular basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to the trustee for administrative expenses not covered by revenue sharing.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Information Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at October 31, 2024 and 2023, net appreciation in fair value of the investments, interest, dividends, and capital gains for the year ended October 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus Trust Company, the trustee of the Plan.

Notes to Financial Statements

Note 8. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the prescribed literature are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Interest-bearing cash: Valued at historical cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
