Note 1 - Plan Description

The following description of The Croghan Colonial Bank 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of The Croghan Colonial Bank (the "Company" or the "Plan Sponsor") who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

New employees are automatically enrolled at 6.0 percent employee deferral contributions following 60 days of employment, unless changed by the employee. If the employee does not complete a funds selection, the contributions are allocated to the American Funds Balanced Fund.

The Plan provides for employee salary 401(k) contributions up to 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). The IRC places annual limits on employee contributions to the Plan; the limit was \$23,000 per participant for 2024. Participants who are age 50 or older may make annual pretax catch-up contributions up to the annual limit established by the IRC; the limit was \$7,500 for qualifying employees for 2024. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 100 percent of the participant's contribution on the first 3 percent and then an additional 50 percent on the next 3 percent for a max of 4.5 percent of the employee's eligible compensation. Matching contributions to the Plan amounted to approximately \$485,000 in 2024.

The Plan has adopted safe harbor provisions with respect to certain nonelective contributions. Under the safe harbor provisions, contributions must be at least 3 percent of annual compensation of participants who qualify for safe harbor contributions. Participants are immediately vested in safe harbor contributions made under the safe harbor provisions and are not required to be employed by the Company on the last day of the plan year to participate in safe harbor contributions. Safe harbor contributions to the Plan amounted to approximately \$404,000 in 2024.

The Company also provides for discretionary profit-sharing contributions to the Plan. Discretionary profit-sharing contributions amounted to approximately \$148,000 in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary contributions, safe harbor contributions, and rollover contributions and any income or loss thereon. Participants vest in the employer matching and profit-sharing contribution portions of their accounts 20 percent per year beginning in year two until they become fully vested after six years of credited service.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the IRC. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Benefit Payments

Distributions are generally payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Distribution of company common stock may occur in cash, in kind, or in annual installments, as defined in the plan document.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Party-in-interest Transactions

Certain plan assets are in the common stock of the Plan Sponsor in the amount of \$348,824 and \$374,544 at December 31, 2024 and 2023, respectively. Therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

In addition, various administrative costs are paid by the Company, which also qualify as party-in-interest transactions.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible based on terms of the plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Hand Benefits & Trust Company (the "Custodian") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan, as currently adopted, uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the IRS indicating the Plan, as designed, is qualified for federal income tax exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common Stock

The common stock of Croghan Bancshares, Inc. is valued at quoted prices reported in active markets.

Money Market Fund

The money market fund is valued at the outstanding balance, which is the best estimate of fair value.
