### **1. Description of Plan**

The following description of the Willard Companies (the “Company”) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

Willard Companies Profit Sharing Plan is a defined contribution salary deferral pension plan covering substantially all employees of Willard Agri-Service of Greenwood Inc., Willard Agri-Service of Lynch Inc., Willard Agri-Service of Marion Inc., Willard Agri-Service of Mt. Airy Inc., and William F. Willard Farms, LLC, which provides an individual account for each participant and provides benefits upon retirement based on amounts contributed by the employee, employer matching and discretionary contributions, plus earnings on those contributions, less any Plan administrative expenses. The Plan was established on January 1, 1986.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participation**

All employees are eligible to participate in the Plan, except for employees covered by a collective bargaining agreement and reclassified employees. To be eligible to participate in the Plan, an employee must have completed one hour of service, which the employee satisfies on their employee commencement date. An employee becomes eligible to enter in the Plan on their date of hire.

#### **Contributions**

Eligible participants may defer (in whole percentages) up to the maximum allowable, not to exceed the limits of Internal Revenue Code (“IRC”) Sections 401(k), 402(g), 404 and 415 of \$23,000 and \$22,500 for 2024 and 2023, respectively. The Company contributed 35% of the first 4% of eligible compensation as defined by the Plan.

All employees over the age of 50 before the close of the Plan year are eligible to make catch-up contributions of \$7,500 per employee for the years ended December 31, 2024 and 2023, under IRC Sections 401(a)(30), 402(g) and 414(v).

The Company may make a discretionary contribution at the end of the Plan year for employees who are eligible as of the last day of the Plan year. Employees who are employed on the last day of the Plan year and who have been credited with at least 1,000 hours or more of service during the Plan year are eligible to receive an allocation of the discretionary contribution.

### **1. Description of Plan (continued)**

#### **Contributions** (continued)

The Company recorded discretionary contributions of \$161,491 of which \$11,491 of forfeitures were subsequently allocated to reduce the Company contribution to \$150,000 for the year ended December 31, 2024.

The Company recorded discretionary contributions of \$150,000 of which \$1,683 of forfeitures were subsequently allocated to reduce the Company contribution to \$148,317 for the year ended December 31, 2023.

Forfeitures are to be used immediately following the Plan year in which the forfeitures occur. Participant and Company contributions are directed by the participant into various investment options offered by the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Company's matching and discretionary contributions, and Plan earnings, less any administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. The standard measure for one year of service is completion of 1,000 hours during the Plan year. Failure to meet the requirement means that no vesting credit is given to the participant. A participant vests at a rate of twenty percent per year and is fully vested after five years of credited service and participation in the Plan.

Any employer matching contributions and discretionary contributions which are not vested are forfeited upon termination. If a participant is re-employed prior to incurring five consecutive one year breaks in service and restores their vested balance, the amount forfeited will be restored to his or her account. If the participant does not return, the forfeitures are used to offset future employer contributions. Notwithstanding the above, a participant shall be fully vested in their entire account upon the attainment of age 65, death, disability or if the Plan is terminated.

### **1. Description of Plan (continued)**

#### **Participant Loans**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one to five years; however, this limit can be extended to ten years if the loan is used by the participant for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate deemed reasonable by the Plan administrator. The interest rates on current outstanding loans range from 3.25% to 8.50%. Principal and interest is paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon termination of service, death, disability, retirement at age 65, or after the participant's fifth anniversary of their participation date, if the participant's account balance is in excess of \$1,000, such participant or his or her beneficiary may elect to receive his or her individual account in a rollover or a single lump-sum payment. The Plan also allows installments for required minimum distributions only. If the participant's vested account balance is less than \$1,000, then the participant or their beneficiary may only receive a lump sum distribution. Under the provisions of the Plan, the Plan administrator has the ability to rollover balances less than \$1,000 into an IRA.

A terminated or retired participant may elect to receive payment from their account soon after it is valued or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. However, payments must begin on April 1 of the year after the year the participant reaches 73 years of age, even if they are still working. In-service and hardship withdrawals are permitted if certain criteria are met.

Upon the death of a participant before retirement or termination of employment, the current balance of such participant's individual account shall become payable as of the valuation date coincident with or next following his or her death.

#### **Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,449 and \$1,676, respectively. The balance of the forfeiture account is used to reduce future Company contributions to the Plan. Forfeited nonvested amounts totaling \$11,491 and \$1,683 were used subsequently in 2025 and 2024 to reduce the discretionary contribution payments due for 2024 and 2023, respectively. No forfeitures were applied to reduce Company match contributions to the Plan for 2024 and 2023. There were no amounts that were reallocated to employees during 2024 and 2023.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Participant Loan Reporting**

The Company follows the accounting guidance for “participant loans in defined contribution plans” in accordance with generally accepted accounting principles. Under the guidance, participant loans are reported in the Statement of Net Assets Available For Benefits as “notes receivable from participants” rather than included as investments as reported under prior guidance.

#### **Investment Valuation and Income Recognition**

In accordance with generally accepted accounting principles, the Plan has adopted the provisions which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Items carried at fair value on a recurring basis consist primarily of financial instruments which are valued primarily based on quoted prices in active or brokered markets for identical as well as similar assets and liabilities. Items carried at fair value on a non-recurring basis generally consist of assets held for sale, if applicable. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

#### **Investment Valuation and Income Recognition** (continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment contract: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. Reported at contract value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Unrealized gains/(losses) from the guaranteed investment contract are not included in the Statement of Changes in Net Assets Available For Benefits as the contract is recorded at contract value for purposes of the net assets available for benefits.

The Plan invests in mutual funds and a guaranteed investment contract. Such investments are exposed to various risks such as market and credit risks. Due to the level of risk associated with such investments, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available For Benefits. Plan assets are not FDIC insured.

#### **Plan Expenses**

The Company sponsors the Plan. Personnel within the employer organization perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Certain record keeping and administrative expenses are paid by the Plan. Investment related expenses are included in “net appreciation/depreciation in the fair value of investments.” All other expenses are paid by the Company.

#### **Funding Policy**

Contributions are funded as accrued.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

### **3. Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by and Ascensus, LLC, the trustee of the Plan.

### 5. Investment Contract

In 2017, the Plan entered into a traditional fully benefit-responsive investment contract with Reliance Trust Company Stable Value Fund Collective Investment Trust, Series 25053 (the "Fund"). The Fund maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal for transfer of all or a portion of their investment at contract value.

The Plans' ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

### **5. Investment Contract (continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition or competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. The Plan administrator believes that any events which would limit the Plan's ability to transact at contract value with participants are probable of not occurring. The guaranteed investment contract permits the insurance company to terminate the agreement upon 30 days advance notice.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Reliance Trust Company Stable Value Fund, Collective Investment Trust, Series 25053 was \$1,238,772 and \$1,870,662 at December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer which is typically reviewed on a monthly basis for resetting.

### **6. Related Party Transactions**

The Plan Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Certain Plan expenses were paid to McLean, Koehler, Sparks & Hammond, the external auditor and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for audit services amounted to \$11,500 for each of the years ended December 31, 2024 and 2023.

Certain Plan expenses were paid to Ascensus Trust Company, LLC, the third-party administrator, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$2,586 and \$2,200 for the years ended December 31, 2024 and 2023, respectively.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

### 8. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the prototype for this Plan and related trust are designed in accordance with applicable sections of the IRC.

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
