### Note 1 - Plan Description

The following is a brief description of Brownstein Hyatt Farber Schreck Retirement Plan (the "Plan") and provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a tax-qualified defined contribution plan that includes a qualified cash or deferred arrangement, within the meaning of Section 401(k) of the Internal Revenue Code of 1986, as amended (the "Code"). The Plan was established effective January 1, 1988 and has since been amended and restated. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Brownstein Hyatt Farber Schreck, LLP (the "Firm") sponsors the Plan and is the named fiduciary. Effective April 23, 2015, the Firm's executive committee established the Brownstein Benefits Committee and appointed it as the plan administrator. Effective October 24, 2016, the Firm's executive committee delegated certain of its settlor authority to the Brownstein Benefits Committee. Vanguard Fiduciary Trust Company (Vanguard) serves as trustee and third-party administrator. Innovest Portfolio Solutions, LLC has been engaged as an ERISA Section 3(21) fiduciary to provide investment advisory services to the Firm and the plan participants.

#### **Eligibility**

Participation in the Plan is available to each individual who is an employee of the Firm or a participating affiliate, who is at least age 21, and who has completed six consecutive months of continuous service. Any individual who is classified by the Firm as a leased employee; nonresident alien with no United States (U.S.) earned income; independent contractor; or employee covered under a collective bargaining agreement, unless participation is expressly provided for in such agreement, is not eligible to participate in the Plan. The entry date for eligible participants is the first day of the calendar quarter coincident with or immediately following satisfaction of the Plan's eligibility criteria.

#### **Contributions**

Participants must take action to begin to make contributions to the Plan. Participants may make elective deferral contributions on a pretax or after-tax basis as Roth contributions. Total annual participant contributions are limited to the lesser of 60 percent of their annual plan-eligible compensation or the annual dollar limitation set forth in Code Section 402(g) for the applicable year (\$23,000 for 2024), the limitation of which is adjusted annually by the secretary of the U.S. Treasury for inflation. Participants who are age 50 or older during the plan year may elect to make catch-up contributions, as limited by Code Section 414(v) (\$7,500 for 2024). Participant contributions to the Plan are made through regular payroll deductions. Participants may elect to change the amount of their contributions at any time subject to administrative rules established by the Firm. The Plan also permits employees who are not part of any excluded class of employees and who are not yet participants to roll over their accounts from certain other eligible retirement plans to the Plan.

The Firm may make a matching contribution equal to a discretionary percentage, to be determined by the Firm, of the participants' elective deferrals. Catch-up contributions are not matched, except to the extent required by applicable law. The Firm made matching contributions up to 50 percent of elective deferrals up to 6 percent of each participant's annual plan-eligible compensation, totaling \$3,060,272 for the year ended December 31, 2024, which includes \$65,000 paid with forfeitures. Matching contributions are funded each pay period. The Firm has the right to designate all or a portion of the matching contributions as qualified matching contributions. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½.

### Note 1 - Plan Description (Continued)

The Firm may also elect, at its sole discretion, to make an additional profit-sharing contribution to the Plan. In order to receive an allocation of the profit-sharing contribution, a participant must be employed on the last day of the plan year to which the contribution relates and have been credited with at least 501 hours of service during the plan year, unless, in each case while employed, the participant died, became disabled (as defined in the Plan), or terminated after normal retirement age (as defined in the Plan) during the plan year. The Firm's profit-sharing contribution was \$6,019,828 for the year ended December 31, 2024.

Aggregate annual contributions under the Plan and all other defined contribution plans sponsored by the Firm are limited to the lesser of the contribution limits defined in the Plan or the annual contributions limit pursuant to Code Section 415(c)(1)(A), which was the lesser of 100 percent of the participant's compensation or \$69,000 for 2024, or \$76,500 for 2024 if eligible for catch-up contributions. Annual contributions are defined as the participant's contributions and the Firm's matching and profit-sharing contributions.

#### ***Participant Accounts***

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Firm's contributions, plan earnings or losses, and plan expenses. Allocations are based upon plan earnings or losses and account balances, as defined by the Plan. The benefit to which a participant is entitled is the vested portion of the participant's account.

Participants are required to direct the investment of their individual plan accounts. The Plan offers participants a broad range of investment options through various mutual funds, a common collective trust, a money market fund, and a brokerage option for other stocks and mutual funds. The default investment is the Vanguard Target Date Retirement Fund whose name indicates the year nearest to the actual year in which the participant would attain age 65.

#### ***Valuation of Investments and Income Recognition***

Investments are recorded at fair value, as reported to the Plan by the trustee. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policy utilizing information provided by the investment advisors, including the monitoring of the performance of the Plan's investment funds. See Note 4 for discussion of fair value measurements.

The Plan invests in investment contracts through a common collective trust. Plan investments in common collective trusts are valued by the trustee based upon the fair value of the investments comprising the trust. Investment contracts held by a defined contribution plan are required to be reported at fair value.

Investments in mutual funds are reported at the last reported sales price at the end of the respective periods using quoted market values.

Self-directed brokerage investments represent a self-directed brokerage account, which is valued based on its underlying assets.

The money market fund is based on quoted market values, as reported by the trustee.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of two loans outstanding at any given time. The loans are secured by the balances in the participants' accounts and subject to an interest rate equal to the prime rate plus 1 percent, which currently ranges from 4.25 to 9.5 percent, and mature at various dates through November 2034. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 10 years from the date of the loan origination. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's loan shall be due in full.

#### ***Vesting***

Participants are immediately 100 percent vested in employee elective deferral contributions, rollover contributions, employer matching contributions, and any income or loss thereon. Vesting in the Firm's profit-sharing contribution portion of their accounts is based on years of service. Participants vest in profit-sharing contributions made by the Firm 100 percent after three years of credited service.

A participant's account becomes 100 percent vested if, while actively employed by the Firm, the participant dies, attains the Plan's normal retirement age (as defined in the Plan), or becomes disabled (as defined in the Plan). A participant's account also becomes 100 percent vested upon termination of the Plan.

#### ***Participant Termination and Forfeitures***

If at the time of termination of employment the participant is not 100 percent vested, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account. Forfeitures can be used to pay employer matching contributions or eligible plan expenses. The balance of this account at December 31, 2024 and 2023 was approximately \$25,000 and \$600, respectively, and is recorded in the money market fund on the statement of net assets available for benefits. During 2024, approximately \$65,000 was used to fund employer matching contributions.

#### ***Benefit Payments***

Upon death, disability (as defined in the Plan), attainment of normal retirement age (as defined in the Plan), or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, either a lump sum or nonrecurring partial payments in the amount equal to the participant's vested account balance. Benefits are recorded when paid.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Firm. The Plan also provides for hardship withdrawals of certain amounts for defined hardship events. Furthermore, the Plan provides that terminated participant vested account balances of \$1,000 or less will be automatically distributed in a single lump-sum payment. Section 401(a)(9) of the Code and the Plan generally require minimum distributions once a participant reaches age 72 during the previous plan year and is no longer employed by the Firm, or once a 5 percent or greater owner reaches age 72 during the previous plan year even if still employed by the Firm.

#### ***Participant Self-directed Accounts***

The Plan offers participants the choice to self-direct their investment elections outside of the money market fund, mutual funds, and common collective trust offered under the Plan. This alternative allows participants to invest their account balances in any investment desired within specified limitations.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The money market fund and demand notes are valued at fair value based on their outstanding balance. All other investments, including self-directed brokerage account investments, are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefit payments or distributions are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Firm.

#### ***Risks, Uncertainties, and Concentrations***

The Plan invests in various investment securities that are exposed to various risks, such as interest rate, credit, and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements. No assurance can be provided to the timing or magnitude of future unfavorable economic events or of their impact on participant account balances.

Additionally, some investments held by Vanguard are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Plan participants may elect to invest in various investment options through self-directed brokerage accounts. This offering carries risks, including the potential for significant concentrations in individual securities and lack of diversification for the participants' portfolio.

#### ***Concentration of Investments***

During the year ended December 31, 2024, two investments accounted for 29 percent of investment income. At December 31, 2024 and 2023, one investment accounted for 14 percent and 13 percent, respectively, of total investments at fair value.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Subsequent Events***

The plan administrator has evaluated all subsequent events through July 22, 2025, which is the date these financial statements were available to be issued.

Effective July 1, 2025, the Plan was amended to have no minimum age for Plan eligibility.

**Note 3 - Certified Information**

Vanguard Fiduciary Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Generally accepted accounting principles require disclosure about how fair value is determined and establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

***Level 1***

Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

***Level 2***

Inputs to the valuation methodology include quoted prices for similar assets in active markets and inputs that are observable for the asset, either directly or indirectly, for substantially the full term of the financial instrument.

***Level 3***

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

#### Note 5 - Tax-exempt Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan subject to the applicable provisions of ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested in their plan accounts, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

**Note 7 - Party-in-interest Transactions**

Certain plan investments are mutual funds, a money market fund, and a common collective trust, which are held by Vanguard. Vanguard is the asset trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules under ERISA Section 406 and Code Section 4975. In addition, the Plan allows for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.
