### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Egan Company 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. #### **NOTE 1. DESCRIPTION OF THE PLAN**

The following brief description of the Egan Company 401(k) and Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### ***General:***

The Plan is a defined contribution plan. Egan Company (the Company) is the administrator and sponsor of the Plan. The Plan was established July 1, 1976, and as of July 1, 2023, uses Empower Trust Company as the plan trustee and Empower Trust Company, LLC and Empower Annuity Insurance Company of America as the plan custodians. Before July 1, 2023, the Plan used Matrix Trust Company as the plan trustee and custodian (the "prior trustee"). The Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA), as amended.

##### ***Eligibility:***

Employees of the company who are not covered by collective bargaining agreements, who are not resident aliens, who are not leased employees, and who have obtained the age of twenty-one years of age or older are eligible to participate immediately upon satisfying the eligibility requirements. Employees who are classified temporary or part time are eligible to participate upon completion of a period of service equal to one year. Employees of the Company become eligible participants for a non-discretionary safe harbor matching contribution after completing one hour of service within the first six months of employment. Safe harbor entry date is immediate upon satisfying the eligibility requirements. To be eligible for the discretionary profit-sharing contribution, participants must perform six months of service and 1,000 hours and be employed on the last day of the Plan year. Entry dates for the discretionary profit sharing are the first day of the first month and seventh month of the plan year.

##### ***Contributions:***

Each year, participants can elect, through a salary reduction, to contribute up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan will automatically increase participant deferrals by 1% for all eligible participants who are contributing less than 15% of plan compensation. Participants must make an annual affirmative election to opt out of the automatic increase. The Plan requires an employer safe harbor qualified non-elective contribution of 100% of the first 3% of the participant's deferred compensation, plus 50% of the next 2% of the participant's deferred compensation. Safe harbor qualified non-elective contributions of \$915,348 and \$970,197 were made during the years ended December 31, 2024 and 2023, respectively.

***Contributions (continued):***

The Company may also make discretionary profit-sharing contributions. Discretionary profit-sharing contributions were made in the amount of \$3,384,401 and \$2,847,949 for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

***Participant accounts:***

Each participant's account is credited with participant deferrals, participant post-tax Roth contributions, safe harbor matching contributions, an allocation of any discretionary contributions made by the Company and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are vested immediately in their contributions plus actual earnings thereon, as well as all safe harbor matching contributions. Vesting in the Company's profit-sharing contribution portion of their accounts is based on years of continuous service, as defined in the following schedule:

Each participant also becomes 100% vested upon normal retirement age as defined in the Plan, at the time of the participant's death, if the participant becomes totally or permanently disabled, or termination of the Plan.

***Notes receivable from participants:***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in participant's account and bear interest at rates that range from 2.50% to 9.50%, which are commensurate with prevailing market rates. Loans must be repaid within five years, except a loan used to build, purchase, or substantially remodel a principal home may be repaid over a ten-year period. Principal and interest are paid through semi-monthly payroll deductions.

##### ***Payment of benefits:***

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary) or periodic installments over a period specified by the plan. Effective January 1, 2024, if terminated/retired participants do not voluntarily elect to move their funds out of the plan, vested account balances between \$1,000 and \$7,000 (previously \$5,000) are rolled into an IRA on the employee's behalf. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator can authorize the benefit payment without the Participant's consent. Active (not terminated/retired) participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan's provisions.

##### ***Forfeitures:***

Forfeited non-vested accounts totaled \$5,386 and \$10,192 at December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses. Forfeitures of \$112,255 and \$29,480 were used to reduce employer contributions and \$4,939 and \$7,507 were used to pay plan administrative expenses during the years ended December 31, 2024 and 2023, respectively.

#### **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICES**

##### ***Basis of accounting:***

The financial statements of the Plan are maintained on the accrual basis of accounting.

Investment held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

##### ***Use of estimates:***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Investment valuation and income recognition:***

The plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

##### ***Investment valuation and income recognition (continued):***

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### ***Notes receivable from participants:***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

##### ***Payment of benefits:***

Benefits are recorded when paid.

##### ***Expenses:***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

##### ***Subsequent events:***

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 1, 2025, the date the financial statements were available to be issued.

#### **NOTE 3. CERTIFICATION OF INVESTMENTS**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Matrix Trust Company, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees (custodians) of the Plan, have certified as to the completeness and accuracy of all investment held at fair value and notes receivable information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the year ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024. The investment information for the investment held at contract value was not certified from July 1, 2023 through July 3, 2024, when the investment was liquidated and the account balances were transferred to Empower Trust Company, LLC and Empower Annuity Insurance Company of America (see Note 5).

#### NOTE 4. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

**Common collective trust:** Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee is a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

**Variable annuities:** Valued daily according to the methods described in the annuity contract with Empower. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. GROUP ANNUITY CONTRACT WITH NATIONAL INSURANCE COMPANY**

The Plan held a traditional fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL) and Putnam Investments totaling \$1,075,630 as of December 31, 2023. AUL and Putnam maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer. The crediting rate was reviewed on an annual basis for resetting. The guaranteed investment contract permitted AUL and Putnam to terminate the agreement prior to the scheduled maturity date under certain instances as defined in the investment contract. When the Plan transitioned from Matrix Trust Company to Empower Trust Company for custodial services effective June 30, 2023, the AUL balance was transferred to an Alternative Fixed Account until the maturity date of the AUL, at which point the balance was transferred into a stable value fund with Empower Trust Company. Upon transfer, which was completed July 3, 2024, the contract was terminated under the administrative provisions of the contract.

**NOTE 5. (CONTINUED)**

This contract met the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain could limit the ability of the Plan to transact at contract value with the issuer. Such events included (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

In addition, certain events allowed the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events included (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer. Notwithstanding these requirements, the Plan's contract was terminated effective July 3, 2024, and all participant and plan accounts were permitted to transfer at contract value before the contract's termination.

**NOTE 6. PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. Empower Trust Company, LLC and Empower Annuity Insurance Company of America is the custodian and record-keeper for the Plan and, therefore, these transactions qualify as party in interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8. PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated August 19, 2020, received from the Internal Revenue Service (IRS) on the Volume Submitter Profit Sharing Plan with CODA indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The prototype Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10. SECURE ACT 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and administratively adopted an increase to the force out limit for terminated participants (see Note 1, Payment of Benefits subnote). Plan management will determine other optional provisions to elect in the future.
