Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Woodley's Fine Furniture, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, Equitable Financial Life Insurance Company, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Woodley's Fine Furniture, Inc. Retirement Plan provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description, which are available from the Plan Administrator, for a more complete description of the Plan's provisions. The Plan's custodian and recordkeeper as of, and for the years ended, December 31, 2024 and 2023 was Equitable Life Insurance Company ("Equitable").

General

The Plan, which became effective April 1, 1993 and was restated effective January 1, 2021, is a defined contribution plan covering all employees of Woodley's Fine Furniture, Inc. (the "Company") who have completed at least two months of service and have attained the age of twenty-one (21). Effective February 1, 2025, the Plan was amended to reduce the age requirement to eighteen (18). Employees can enter the Plan quarterly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The Company is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of their annual compensation not to exceed the maximum allowable by law (\$22,500 in 2024; thereafter as adjusted by the Secretary of the Treasury) in a calendar year. Participants who have attained age 50 and before the end of the Plan year are eligible to make catch-up contributions (up to \$7,500 in 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. The Company may make discretionary profit-sharing contributions as determined by the Company's Retirement Committee. For the years ended December 31, 2024 and 2023, there were no discretionary profit-sharing contributions. The Company matches employee contributions equal to 50% of deferrals up to 6% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's contributions, (2) Plan earnings, and (3) forfeitures of terminated participants' non-vested accounts. Each participant's account is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, as defined. Certain account fees may be charged by the custodian based on investments in certain funds and will be withdrawn directly from the account of the participants who are invested in those funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus earnings thereon. Vesting in the Company's matching contribution portions of their accounts is based on years of service, as defined in the Plan Document. A participant is vested under a graded vesting schedule and is 100% vested after five years of credited service.

Notes Receivable from Participants

The Plan does not allow for notes receivable from participants.

Payment of Benefits

Upon retirement, death, disability or termination of service, a participant's vested balance is paid to the participant or to the participant's beneficiaries. If the vested amount is less than \$1,000, it is payable in a lump sum unless the participant makes an election otherwise within 60 days. If the vested account balance is less than \$5,000, the vested account balance (including any rollover contributions) will be distributed to an individual retirement plan (IRA) in the employee's name by the Plan administrator, unless instructed otherwise within 60 days. The Plan also permits hardship withdrawals. Upon termination of service, an employee with a vested account balance greater than \$5,000 may elect to receive a lump sum or partial lump sum payment, roll over the vested account balance to an account of his or her choice, or maintain the vested balance in the Plan and continue to share in investment gains and losses.

Forfeited Amounts

Any non-vested balance is forfeited upon termination of service. Forfeitures during a Plan year are used to pay the Plan's administrative expenses. If available forfeitures exceed the Plan's administrative expenses, forfeitures will be used to offset the Company's future contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

Plan Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan sponsored by the administrator of the Plan. This prototype plan document was reviewed by the Internal Revenue Service and informed Equitable Financial Life Insurance Company by letter dated June 30, 2020 that the prototype plan document is designed in accordance with applicable sections of the Internal Revenue Code, was in compliance with the applicable requirements of the Internal Revenue Code, and therefore not subject to tax. The Plan Administrator has determined that it is eligible to, and has chosen to, rely on the current IRS advisory letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

New Act

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. The most significant changes impacting existing Plan provisions included updates to required minimum distributions (RMDs) and hardship distribution rules, expanded eligibility of part-time employees, modifications to catch-up contribution rules and options for the plan sponsor to make matching contributions to an employee's retirement account based on the employees' student loan payments. SECURE Act 2.0 amendments must be adopted by December 31, 2025 for calendar year plans. Plan documents are to be updated in accordance with the provisions of SECURE Act 2.0.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investments

Investments are reported at fair value (except for the guaranteed interest option, which is stated at contract value. Contract value represents contributions plus credited interest less participant withdrawals and expenses. Interest income is recognized when earned). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Plan or the Company, at management's discretion. Certain account fees may be charged by the custodian based on investments in certain funds and will be withdrawn directly from the account of the participants who are invested in those funds. Administrative expenses for the years ended December 31, 2024 and 2023 was \$43,493 and \$34,150, respectively.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes any excess contributions in the succeeding year. Excess contributions payable at December 31, 2024 and 2023 were \$-0- and \$-0-, respectively.

Contributions Receivable

Contributions receivable are related to the amounts withheld from employees' paychecks, the employer match for the last payroll for the year then ended, and employer qualified nonelective contributions. There were no contributions receivable as of December 31, 2024 and 2023.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts, which are actively traded, are valued at quoted market prices on nationally recognized securities exchanges and represent the net asset value (NAV) of shares held by the Plan at year-end.

NOTE 4: GUARANTEED INTEREST OPTION

The Plan's contract includes a Guaranteed Interest Option (GIO), maintained by Equitable. Equitable maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIO issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the GIO meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the GIO.

The GIO is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Equitable, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate for the GIO is based on a formula as follows:

- the minimum interest rate guaranteed over the life of the contract;
- the annual minimum guaranteed interest rate for the calendar year; and
- the current interest rate.

There were no reserves against the guaranteed interest option value for credit risk of the contract issuer or otherwise. The contract value of the GIO at December 31, 2024 and 2023, was \$2,180,777 and \$2,039,191, respectively. The contract's minimum interest rate is 1% and the crediting interest rate as of December 31, 2024 and 2023 was 2.75%.

NOTE 5: RISKS AND UNCERTAINTIES

The Plan invests in various investment options in registered investment companies and has a variable annuity contract with underlying investments in registered investment companies. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, certain Plan investments were investments managed by Equitable Life Insurance Company, the Plan's custodian and recordkeeper.

Fees paid during the year for accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

The Plan sponsor provides certain administrative costs to the plan at no cost to the Plan.

These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 7: SIGNIFICANT ESTIMATES AND CONCENTRATIONS

The current economy continues to present retirement plans with difficult circumstances and challenges, which in some cases have resulted in large and unanticipated declines in the fair value of investments. The financial statements have been prepared using values and information currently available to the Plan. Given the volatility of current economic conditions, the values of assets recorded in the financial statements could change rapidly, resulting in material future adjustments in investment values that could negatively impact the Plan.

NOTE 8: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, management instructed the Plan's independent auditors not to perform any audit procedures with respect to the information certified by the custodian, except for comparing such information, as summarized below, to the information included in the financial statements and supplementary schedule.

The information certified by the custodian, as of and for the years ended December 31, 2024 and 2023, as complete and accurate, is as follows:

- Investments as reported in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income as reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

NOTE 9: SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued, and has determined that no events require disclosure, except as noted below.

Effective February 1, 2025, the Plan was restated to a new pre-approved plan document in connection with a transition to a new recordkeeper and custodian, Empower Retirement, LLC. The restated plan document included certain amendments, including a change in the Plan's eligibility age from 21 to 18. Plan assets were transferred to the new custodian shortly after the effective date. These changes occurred subsequent to the plan year-end and do not affect the financial position of the Plan as of December 31, 2024.

At December 31, 2024, the Plan held a guaranteed interest option contract with Equitable that is fully benefit-responsive and reported at contract value. Subsequent to year-end, the Plan transitioned its recordkeeper and custodian, and as part of that transition, the guaranteed interest option contract was liquidated. Management has evaluated the impact and determined that this does not affect the classification of the contract at year-end.
