Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Mountaineer Contractors Inc., (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established in 1987, last restated July 1, 2021, is a defined contribution plan covering substantially all employees of the Company and its wholly-owned subsidiaries who have six months of service and are age 18 and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

Contributions

Each year, participants may contribute up to the maximum allowed under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Both pre-tax and after-tax (Roth) deferrals are permitted. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute to the Plan a discretionary amount determined by the Company's management. Plan Sponsor contributions are allocated to each eligible participant based on compensation.

Participant Accounts

Each participant account is credited with the participant's contributions, allocation of the Company's profit sharing contributions and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant is 100 percent vested after 6 years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments over a term not to exceed the life expectancies of the participant and participant's beneficiary. Hardship withdrawals of participant deferrals plus interest are allowed under the Plan. If vested balances are less than \$1,000, the Plan Administrator may elect to distribute the account without consent. Balances over \$1,000 are automatically rolled over into an IRA account if the participant has not affirmatively elected another benefit payment option.

Forfeited Accounts

At October 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,251 and \$4,219, respectively. Forfeitures are to be used to pay Plan expenses or reduce future employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Policies

The accounting and financial reporting policies of the Plan conform to the modified cash basis of accounting and to general practices within the employee benefit plan industry. The preparation of financial statements in conformity with the Plan's basis of accounting requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The principles and policies which significantly affect the determination of net assets and the changes in net assets are summarized below.

Basis of Accounting

The accounting records of the Plan are maintained and these financial statements are presented on a modified cash basis of accounting, a practice permitted by the United States Department of Labor. Accordingly, with the exception of appreciation or depreciation in the fair value of investments, income and expense items are recognized only as cash is received or paid. Therefore, certain receivables, certain payables and accrued expenses and deferred expenses which, would be recognized under accounting principles generally accepted in the United States of America, and general practice within the employee benefit plan industry, and which may be material in amount, are not recognized in the accompanying financial statements. Accordingly, the accompanying financial statements are not intended to present net assets or changes in net assets in accordance with accounting principles generally accepted in the United States of America.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The fair value of the guaranteed investment contract is calculated by discounting the related cash flows based on an appropriate current market rate adjusted for the counterparty's credit quality, liquidity, and any risk margins on unobservable parameters, over the accounts expected duration.

Under certain requirements of professional accounting and financial reporting standards, investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. As required by professional accounting standards, the Statement of Net Assets Available for Benefits on a Modified Cash Basis presents the guaranteed investment contract at contract value.

The value of a unit in a pooled separate account is the fair market value of investments in the account as of the valuation date, plus cash balances and accruals less accounts payable, expenses and taxes that are allocable to the account, divided by the number of outstanding participation units in the account. Securities held in the pooled separate accounts are valued based on quoted market prices. If there is no readily available market value for a particular security, the investment manager will determine the fair market value of such investment in accordance with accepted practices and applicable laws and regulations. As of any date, the value of the Plan's share of a separate account will equal the number of participation units held by the Plan multiplied by the participation unit value.

The Plan does not require collateral to secure investment instruments.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of distributions for participants are included in administrative expenses and charged directly to the participant's account.

Subsequent Events

The Plan has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued. There has been no material event noted during the period that would either impact the results in the report or the Company's results going forward.

NOTE 3 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

Empower Retirement ("Empower") acquired Massachusetts Mutual Life Insurance Company's ("MassMutual") retirement plan business. All contracts previously issued by MassMutual remained as such and were not reissued by Empower. Empower has been appointed a power of attorney by Talcott Resolution Life Insurance Company (Talcott) to provide all administrative services necessary to support and certify the insurance contracts. The Plan maintains as an investment option for participants a benefit-responsive investment contract with Talcott Resolution Life Insurance Company (Talcott), an affiliate of Empower. Empower maintains the contributions in a general account. No other changes were made to the structure of the contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no allowances against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3 percent. Such interest rates are reviewed and can be changed at any time by Empower with written notice.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents including those that adversely affects Empower's sole determination, (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract value of the investment contract at October 31, 2024 and 2023, was \$5,457,430 and \$5,121,253, respectively.

NOTE 4 - FAIR VALUE MEASUREMENTS

Investments in the Plan's variable investment account (pooled separate account) are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

NOTE 4 - FAIR VALUE MEASUREMENTS (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels. The Plan's investments held in the HLIC separate account and administered by Empower are valued entirely using Level 2 inputs (observable inputs other than quoted prices for identical assets).

The valuation methodology used for the assets measured at fair value and held in the pooled separate account was the accumulated units of the variable investment that are credited to participant's account (also known as the participant's variable investment account "Account Value"). There were no changes in the methodology used at October 31, 2024, and 2023.

NOTE 5 - RELATED PARTY TRANSACTIONS

The principal owners of Mountaineer Contractors, Inc. (the plan sponsor) are also the trustees of Mountaineer Contractors, Inc., 401(k) Profit Sharing Plan. Mountaineer Contractors, Inc. provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions are exempt party in interest transactions.

NOTE 6 - TAX STATUS

The Plan has adopted the Plan Document Systems Advantage Volume Submitter 401(k) Savings/PS Plan. The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Plan management evaluates tax positions taken by the Plan to determine if any uncertain tax positions exist that compromise the Plan's tax exempt status that could result in tax obligations requiring recognition or disclosure in the Plan's financial statements. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 7 - PLAN TERMINATION

Although it has not expressed intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer accounts.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net assets Available for Benefits and participants' individual account balances.

NOTE 9 – ERISA SECTION 103(a)(3)(C) AUDIT DISCLOSURE

The investment asset values, transactions, and income, and the schedules of assets held for investment purposes and reportable transactions were certified by Empower Retirement, the third party plan custodian, as of October 31, 2024 and 2023 to be complete and accurate.

NOTE 10 - ERISA FIDELITY BOND COVERAGE

The amount of the Plan's ERISA Fidelity Bond coverage as of October 31, 2024 and 2023 was sufficient in relation to the plan's assets. The IRS/DOL requires the bond to be at least equal to the lesser of 10% of plan assets or \$500,000. The Plan's policy is \$500,000 and \$500,000 as of October 31, 2024 and 2023, respectively, and therefore, provides compliance.
