Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

(1) Description of Plan

The following description of Eastern Controls, Inc. of PA 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective January 1, 1997, and most recently restated March 4, 2022 for employees of Eastern Controls, Inc. of PA (the Company). The Plan excludes union employees, nonresident aliens, and residents of Puerto Rico. Employees of the Company are eligible to participate in the Plan upon completion of three months of service, and participants must be a minimum age of 20.5 years. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Administrative Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the plan trustee.

Contributions

Participants may contribute up to the maximum dollar limit as determined by the Internal Revenue Service (IRS), including after-tax Roth contributions. Participants may elect to have their deferrals by either pre-tax contributions or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible rollover distributions from other qualified retirement plans may also be transferred into the Plan and retained as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balance fund until changed by the participant.

The Company provides a safe harbor matching contribution and a discretionary additional matching contribution, as determined by the Company's management. Eligible participants receive safe harbor matching contributions equal to 100 percent of a participant's salary deferrals that do not exceed 3 percent, plus 50 percent of deferrals in excess of 3 percent but not in excess of 5 percent. During 2024, the Company elected not to make a discretionary additional matching contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

Participant Accounts, Continued

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service and will vest according to the following schedule:

Participants' accounts are fully vested upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The \$50,000 limitation is reduced by the highest principal balance on any other loans issued to the participant during the past twelve months or any existing loan balances on the date a new loan is made, whichever is greater. Loan terms range from one to five years unless the proceeds are used for the purchase of a primary residence, in which case the repayment period may exceed five years. Loans are secured by the balance in the participants' accounts and bear interest at rates ranging from 4.25% to 9.50%, which is one percent over the prime rate at the beginning of the month in which the loan is originated. Principal and interest are paid ratably through bi-weekly payroll deductions.

Participants are limited to one outstanding loan at any given time.

Payments of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to plan provisions. If a participant terminates employment and the participant's account exceeds \$5,000, the participant's consent is required to distribute their account before they reach normal retirement age. If the balance of the terminated participant's account is less than \$5,000, the benefit payment will be made to the participant regardless of consent.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,214 and \$2,911, respectively. These accounts may be used to pay plan administrative expenses or to reduce the employer matching contribution. There were no forfeitures used to reduce administrative expenses during 2024.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are treated as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (Empower), a qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

(6) Related Party Transactions and Party-In-Interest Transactions

Empower is the custodian as defined by the Plan and, therefore, certain investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. These party-in-interest transactions are exempt from the prohibited rules of ERISA.

(7) Plan Termination

Although it has not expressed any intent to do so the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100% vested in their employer contributions.

(8) Tax Status

The Plan adopted non-standardized pre-approved plan sponsored by Empower Retirement, LLC. The IRS has determined and informed Empower Retirement, LLC by a letter dated November 14, 2022 that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Nonexempt Transactions

The plan sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable as required by ERISA Section 2510.3-102. During 2024, certain employee deferrals and loan repayments to the Plan aggregating \$33,045 were not remitted to the Plan's trust within the timeframe required by the DOL under plan asset rules. These transactions are considered prohibited transactions as defined by ERISA. While the participant withholdings resulting in the delinquent contributions have been remitted to the Plan as of December 31, 2024, the related lost earnings have not been remitted. The Company intends to compensate the affected participants for lost earnings during 2025.
