Independent Auditor's Report

Opinion

We have audited the financial statements of Timac Agro USA, Inc. Note 1 - Description of Plan

The following description of the Timac Agro USA, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan is a self-insured welfare benefit plan that provides benefits to all regular full-time employees of Timac Agro USA, Inc. (the Company) who have completed 60 days of service and are working at least 30 hours per week, as well as former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a member of Veris Benefits Consortium, LLC, which operates as a health insurance consortium under which the members negotiate and establish employee welfare benefit plans for their employees. Some expenses of the Plan are paid through the Veris Benefits Consortium, LLC Trust. The employees are required to pay for a portion of the cost of the benefit.

Contributions

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan. Contributions for certain other premiums expenses under the Plan are paid directly by the Company, and the funds do not travel through the Plan's trust account. Employee contributions are determined on a fixed fee basis. The amount varies depending on the selection of individual or eligible dependent coverage.

Benefits

The Plan provides health (medical, hospital, surgical, major medical, and telemedicine), dental, vision, disability, accidental death and dismemberment, life insurance, and prescription drug benefits to substantially all employees of the Company who meet the eligibility requirements of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the COBRA, as defined in the plan document.

Health and prescription drug benefits are self-insured and paid through the plan trust account. All other benefits are fully-insured through third-party plan administrators. Premiums for these other fully-insured benefits are paid directly by the Company, and are included in contributions and insurance premiums paid on the statement of changes in net assets available for benefits. The employees pay a portion of their health and prescription drug coverage based upon the coverage chosen and also may elect dental, additional voluntary life, and additional voluntary accidental death and dismemberment insurance through payroll deductions.

Current health and prescription drug claims are processed through Highmark, Inc.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Premiums paid by the trust or the Company are recorded as insurance premiums in the accompanying statement of changes in net assets available for benefits when paid.

Claim payments are recorded when paid by the third-party claims processor.

Stop Loss Insurance

The Plan has a stop loss insurance arrangement, whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$80,000 and \$75,000 per covered person for the years ended December 31, 2024 and 2023, respectively. Stop loss refunds of \$383,723 and \$289,682 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. If the Plan is in a deficit for the year, the stop loss provider will fund the deficit. At the end of the stop loss policy, the Plan will owe any amounts that were reimbursed in excess of the Plan's deficit. As of December 31, 2024 and 2023, the Plan owed \$111,458 and \$-0-, respectively, to the stop loss provider.

Plan Benefit Obligations

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's management. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. As of December 31, 2024 and 2023, benefit obligations for claims that had been incurred but not paid totaled \$311,328 and \$254,223, respectively. Each of these amounts was paid in the plan year immediately following the respective period end dates noted above. It is the Plan's policy that deductions for claims are recorded when paid.

Administrative Expenses

The Plan pays administrative expenses that consist of administrative fees paid to third-party administrators, including costs related to claims processing and actuary, broker fees, and patient advocate fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses and are paid directly from the plan trust account. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Note 3 - Plan Administration

The Plan has entered into a service agreement with Highmark, Inc. to provide administrative services for health and prescription drug claims. Highmark, Inc. is responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services, or to the employee in accordance with the terms of the Plan. Highmark, Inc. charges a fee based on the number of employees participating in the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

The interest bearing cash account is valued at cost, which approximates fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Plan is funded through a nonqualified trust under Internal Revenue Code (IRC) 419(a). The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for, or on, account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 7 - Risks and Uncertainties

The Plan maintains cash in a bank deposit account which may, at times, exceed federally insured limits. The Plan has not experienced any losses in such account. The Plan believes it is not exposed to any significant credit risk on cash.

The actuarial present value of benefit obligations is reported based on certain assumptions, including level of past claims, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 8 - Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are managed by UMB Bank, National Association (UMB Bank, N.A.), the custodian of the Plan as of and for the year ended December 2024, and from July 5, 2023 through December 31, 2023, and Univest Bank, the custodian of the Plan from January 1, 2023 through July 5, 2023 and; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Plan's custodian totaled \$81,895 and \$98,440 for the years ended December 31, 2024 and 2023, respectively. As described in Notes 1, 2, and 3, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.
