Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 DESCRIPTION OF THE PLAN

The following description of the PAXXUS, Inc. Employees' Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Effective January 21, 2019 the name of the Plan was changed from Rollprint Packaging Products, Inc. Employees' Profit Sharing and 401(k) Plan to PAXXUS, Inc. Employees' Profit Sharing and 401(k) Plan.

General

The Plan is a defined contribution plan established to provide deferred compensation benefits to eligible employees. Under the Plan, all of the employees of PAXXUS, Inc. (the Employer) who have met eligibility requirements may participate in the Plan. The Plan was last amended and restated effective October 1, 2022, to update for changes related to eligibility requirements for employer matching contributions and a revised vesting schedule. No other significant changes were implemented. The Plan and the Trust, of which it is a part, are intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state and tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees must be 18 years of age or older and complete 60 days of service to participate in the Plan. Employees are automatically enrolled into the Plan effective the first pay period following 60 days from the employee's date of hire unless the employee declines enrollment within those 60 days.

Eligible employees having completed at least two months of service are eligible to receive the Employer matching contribution. Eligible employees having completed at least one year of service, 1,000 hours of service during the Plan year, and are actively employed on the last day of the Plan year, unless terminated due to retirement on or after the normal retirement age, death or disability, are eligible to receive the Employer profit sharing contribution, if any.

Contributions

Participants may make pre-tax and/or after-tax contributions equal to but not less than 1% up to 100% of each participant's compensation, as defined by the Plan, subject to the limitations imposed by the IRC. New participants are automatically enrolled at 2% unless otherwise elected by the employee. The automatic deferral will then increase by 2%, the following January 1 up to a maximum of 6%. Participants may also roll over amounts representing distributions from other qualified defined-benefit or defined contribution plans. . Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer matching contribution is based on a discretionary rate of employee contributions up to 6%. For the year ended December 31, 2024, the Employer made matching contributions of \$0.50 for each \$1.00 by which a participant defers his/her compensation up to a maximum of 6% of compensation.

Contributions (Continued)

The Employer profit sharing contribution is discretionary. The Employer did not make profit sharing contributions for the years ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching contribution, and an allocation of the Employer's profit sharing contribution, if any, Plan earnings or losses, and forfeitures. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants' Investment Options

Participants must direct their salary deferral and Employer contributions to selected investments as made available by the Plan. The Plan currently offers various mutual funds and a collective trust as investment options for Plan participants. Participants may change his/her investment options at any time.

Vesting

Participants are immediately vested in his/her voluntary contributions plus actual earnings thereon. Vesting in the remainder of the accounts is based on years of continuous service. A participant is vested 33% after one year of completed service, 66% after two years of completed service, and is fully vested after three years. Once a participant reaches normal retirement or if a participant dies prior to attaining his/her normal retirement age or becomes permanently disabled, the full value of the participant's account immediately becomes 100% vested and is nonforfeitable.

Benefit Payments

Upon termination of service due to retirement, death, or disability, participants may elect to either receive a distribution in the form of installments, a single cash payment, or a combination thereof. Participants who terminate service prior to retirement age or for any reason other than death or disability, will receive his/her balance under the same provisions. The Plan's provisions also provide for in-service withdrawals or withdrawals in the event of financial hardship, as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from his/her fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his/her vested account balance. Loan terms range from one to five years, or longer if the loan is for the purpose of a principal residence. The loans are secured by the balance in the participant's account and bear an interest rate based on the rates available for similar loans from commercial lending institutions at the time of issuance. Presently, interest rates range from 4.25% to 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

Forfeited Accounts

There were \$22,531 and \$9,927 in forfeited nonvested accounts at December 31, 2024 and 2023, respectively. Forfeitures may first be used to pay expenses and remaining forfeitures may be used to reduce Employer contributions. For the year ended December 31, 2024, forfeitures of \$69 were used to pay Plan expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable, if any, are reclassified as distributions based upon terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Employer. Although the Employer has elected to pay some administrative costs, it is not obligated to do so. If the Employer ceases to pay all or part of these costs in the future, they will be paid by the Plan's trustee out of the assets of the Plan.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Fidelity Management Trust Company, the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and certain related investment activity and notes receivable interest income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Collective Trust Fund – Valued at the net asset value (NAV) of units of the trust company collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in his/her entire accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such manner as the Employer may determine.

NOTE 6 PLAN TAX STATUS

The Plan, through its adoption of a prototype plan from the trustee, has obtained opinion letters issued to the trustee, the latest of which is dated June 30, 2020, from the Internal Revenue Service (IRS) stating that the prototype plan is qualified under Section 401(a) of the IRC and that any Employer adopting this Plan will be considered to have a qualified plan under Section 401(a) of the IRC. The prototype plan opinion letter has been relied upon by this Plan. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a collective trust fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and recordkeeper, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees paid to the Plan's various service providers, as reflected in the statement of changes in net assets available for benefits, are also party-in-interest transactions. The Plan also has an arrangement with service provider Creative Planning, LLC. Fees paid to the provider are party-in-interest transactions under ERISA.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
