**1. Description of Plan**

Mid-Bronx Senior Citizens Council, Inc. (“the Council”) established the Mid-Bronx Senior Citizens Council 403(b) Profit Sharing Plan (“the Plan”) which became effective as of July 1, 1994. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all full-time and part-time employees of the Council who are age twenty-one or older and have completed one year of service with the Council and worked at least 1,000 hours during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Contributions and Vesting***

The Council makes discretionary non-elective contribution to the Plan. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into investment options offered by the Plan. The investment options are limited to mutual funds purchased through a custodial account. Participants are fully vested in their employee contributions and earnings thereon.

***Payment of Benefits***

Benefits are paid upon retirement (age 65), death, disability, or termination of employment. Participants may elect to receive lump-sum, partial payments, installment payments, annuity contracts or income option conversion, subject to the terms of the individual agreements governing the participants’ investment selections. The Plan does not allow participants to borrow from the Plan.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared using the modified cash basis of accounting. Under this method, investments are stated at fair value and all other transactions are recorded on the cash basis of accounting. The modified cash basis of accounting is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (*Continued*)**

***Fair Value of Financial Instruments***

The Plan follows Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

***Investment Valuation and Income Recognition***

Investments in registered investment companies are stated at fair value as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. There have been no changes in the methodologies used at June 30, 2022 and 2021.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income which is reinvested. Realized gains and losses on investments are recognized upon the sale of the related investments, and unrealized appreciation or depreciation is recognized at year end when the carrying values of the related investments are adjusted to their estimated fair value.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of the employer discretionary contributions, plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan's adoption agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their employee contributions and share of employer contributions into investment options offered by the Plan.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

**2. Summary of Significant Accounting Policies (Continued)**

***Accounting for Uncertainty in Income Taxes***

The Plan recognizes the effect of income tax positions only if those positions are more-likely-than-not be sustained upon examination by taxing authorities. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition. The Plan is no longer subject to audits by the applicable taxing jurisdictions for tax periods prior to 2019.

***Subsequent Event Evaluation by Management***

Management has evaluated events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is April 12, 2024.

**3. Information Certified (Unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mid-Atlantic Trust Company, the current custodian has certified to the completeness and accuracy of all the investments reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023, the supplemental Schedule H, Part, IV, Line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2024 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2024.

**4. Investments**

The Plan's investments in registered investment companies amounting to \$999,857 and \$930,807 as of June 30, 2024 and 2023 are classified as Level 1, within the fair value hierarchy.

**5. Plan Termination**

Although it has not expressed any intention to do so, the Council has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**6. Tax Status**

The Company believes that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan Administrator (and the Plan's tax counsel) believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**7. Party-in-Interest**

The Plan is managed by Benefit Consultants Group, Inc., the Plan's record keeper. Mid-Atlantic Capital Group, Inc. is the Plan's custodian of funds. Accordingly, these transactions qualify as party-in-interest transactions. Certain employees of the Plan Sponsor, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

**8. Risks and Uncertainties**

The assets of the Plan are primarily financial instruments which are monetary in nature. Accordingly, interest rates have a more significant impact on the Plan's performance than the effects of the general levels of inflation. Interest rates generally do not move in the same direction or with the same magnitude as prices of goods and services as measured by the consumer price index. Investments are subject to risk conditions of the individual investment's objectives, stock market performance, interest rates, economic conditions and world affairs. Due to the level of risk associated with the Plan's investments, it is reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
