## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the  
Spang & Company Retirement Savings

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Spang & Company Retirement Savings Plan for Non-Bargaining Unit Employees (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from Empower Annuity Insurance Company and Empower Trust Company, LLC, qualified institutions, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report:

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - PLAN DESCRIPTION

The following description of the Spang & Company Savings Plan for Non-Bargaining Unit Employees (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all non-bargaining unit employees of Spang & Company ("Company"). The Company is the Plan Sponsor and Administrator that controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company also sponsors a defined contribution plan that covers other work groups of the Company as defined by the plan agreement of the other plan. On December 11, 2024, the Spang & Company Retirement Plan Committee (the "Committee") authorized a complete plan merger of the Retirement Savings Plan for Bargaining Unit Employees of the Spang Power Electronic Division into the Plan effective January 1, 2025. As a result, assets totaling \$4,595,908 were transferred and merged into the Plan, and the Plan changed its name to the Spang & Company Retirement Savings Plan effective January 1, 2025.

Eligibility

Generally, eligibility in the Plan is effective as of the first day of becoming a covered employee, as defined in the Plan. Employee contributions may begin the first full pay period following completion of an election form. There is no age requirement for participation in the Plan. The Plan has an automatic enrollment feature for all eligible employees who do not opt out. The automatic deferral for those who do not opt out is 6%, increasing annually by 1%, into the age-appropriate Moderate GoalMaker portfolio based on a predetermined allocation of existing investment Plan options.

Contributions

Participants may contribute up to 75% of pretax or after-tax annual compensation, as defined in the Plan. Contributions for any calendar year are subject to certain Internal Revenue Code ("Code") limitations (\$23,000 and \$22,500 for 2024 and 2023, respectively). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024 and 2023). Participants direct all contributions into various investment options offered by the Plan.

The Company provides matching contributions based on deferral contributions as follows: 50% of the first 6% of eligible employee compensation, plus 75% of the next 3% of eligible employee compensation, plus 100% of the next 3% of eligible employee compensation. The Plan document also provides for the Company to make a discretionary profit-sharing contribution of 4% of eligible employees' annual compensation. For the years ended December 31, 2024 and 2023, the Company made no discretionary contributions.

In addition, participants who receive qualified distributions from another qualified plan may be able to rollover such distributions into the Plan. Rollovers into the Plan were \$231,212 and \$41,523 for the years ended December 31, 2024 and 2023, respectively.

Participant accounts

Each participant's account is credited with their voluntary contributions, earnings on account investments and any Company contributions. Each participant's account is reduced by participant withdrawals, forfeitures, and an allocation of Plan losses based on investment options selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions occurs upon completion of three years of continuous service by the participant.

Benefits

Upon termination of service due to death, disability, retirement, or other reasons, a participant may receive payment in a lump sum. If the terminated participant's account balance is less than or equal to \$5,000, the Company may make a lump-sum payment without the participant's consent. Effective April 1, 2024, this amount increased to \$7,000. Hardship withdrawals are also permitted in certain cases.

Forfeitures

Non-vested accounts are forfeited upon participants' terminations. Forfeited balances of terminated participants' nonvested accounts are applied to reduce future Company matching contributions. Forfeitures used to reduce Company matching contributions totaled approximately \$22,000 and \$16,000 for the years ended December 31, 2024 and 2023, respectively. The forfeited non-vested account balance was not material as of December 31, 2024 and 2023.

Administrative fees and expenses

Certain administrative expenses are paid by the Company or the Plan, as provided by the Plan document.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a description of significant accounting policies used by the Plan.

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment valuation and income recognition

The Plan’s mutual fund investments are stated at fair value, determined by quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The Plan’s common collective trust investments and pooled separate accounts are stated at the net asset value (“NAV”) of units held by the Plan at year end. NAV is used as a practical expedient to estimate fair value. The Plan’s investment in the Empower Annuity Insurance Company (“EAIC”) Guaranteed Income Fund is a fully benefit-responsive investment contract and is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Plan management determines the valuation policies utilizing information provided by EAIC and Empower Trust Company, LLC (“ETC”).

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded as earned. Capital gain distributions from mutual funds are included in dividend income. Net appreciation or depreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

The Plan’s investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of assets available for benefits.

Contributions

Participant contributions are generally recorded in the month withheld from the participant's compensation. Employer match contributions are recorded at that same time. Additional employer retirement contributions are recorded as approved.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures. Accordingly, actual results could differ from those estimates.

Subsequent events

Plan management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through July 28, 2025, the day the financial statements were approved and authorized for issue.

NOTE 3 - FEDERAL INCOME TAX EXEMPTION

The Plan obtained its latest determination letter dated August 10, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. As of December 31, 2024 and 2023, the Plan Administrator is not aware of any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan believes it is no longer subject to income tax examinations for periods prior to 2021.

NOTE 4 - INVESTMENTS

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level I – Quoted prices in active markets for identical assets or liabilities. The type of investments reported as Level I include mutual funds.

Level II – Observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. The Plan does not carry any investments that fall within this category.

Level III – Inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability. The Plan does not carry any investments that fall within this category.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds represent investments with various registered investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the quoted market price and classified as Level I assets.

Pooled separate accounts are measured using the unit value calculated based on the NAV of the underlying pool of securities as a practical expedient. The NAV is based on the fair value of the underlying investments held by each fund less liabilities. Purchases and sales may occur daily within these accounts.

The Plan's common collective trust investments are stated at NAV. The nature of these investments is such that Plan participants may redeem units at any time; however, a full Plan withdrawal may be subject to a one-year withdrawal provision. The Plan's common collective trusts pursue a strategy of providing stability for principal and current income by investing in companies with premium prospects for capital appreciation.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

The common collective trusts are made up of three funds offered by MassMutual, Carillon Eagle, and ClearBridge. The MassMutual fund generally invests the majority its assets in a diversified portfolio of investment grade fixed income securities. The objective of this fund is to seek a maximum total return, consistent with the preservation of capital. The Carillon Eagle fund generally invests the majority of its assets in the equity securities of mid-capitalization companies. The fund will invest primarily in the equity securities of companies with above-average growth potential, both emerging and more established companies that may be undiscovered or undervalued in the market. The objective of this fund is to seek long-term capital appreciation. The ClearBridge fund generally invests in quality growth companies mispriced by the market that possess large exploitable opportunities. The objective of this fund is to provide long-term growth of capital.

The Plan has investments in two pooled separate accounts offered by EAIC. The Dryden S&P 500 Fund seeks investment results that correspond to the total return of common stocks publicly traded in the United States, as represented by the Standards and Poor's 500 Composite Stock Price Index ("S&P 500"). Generally, the fund invests the majority of its assets in stocks of companies included in the S&P 500 and in derivative instruments, such as futures contracts and options, that provide exposure to the stocks of companies in the index. The securities are weighted within the fund to attempt to make the total investment characteristics similar to those of the S&P 500 as a whole. The American Century large cap growth fund is an exchange traded fund that generally invests in large cap equity. This fund seeks capital appreciation in order to provide a total return exceeding the Russell 1000 Growth Index benchmark over a market cycle by using a growth equity strategy that integrates sustainability factors into the investment process.

NOTE 5 - INVESTMENT CONTRACT

The Plan maintains a guaranteed income fund, who maintains the contributions in a general fund. The guaranteed income fund is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

Because the guaranteed income fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the guaranteed income fund. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer. The crediting interest rate is determined by the contract issuer based on various factors, which include current economic and market conditions and the general interest rate environment. The credit interest rate may not be less than 1.95% and 1.80% as of December 31, 2024 and 2023, respectively. The interest rates are reviewed on a semi-annual basis for resetting.

The investment contract seeks to provide stability and security through diversification of assets and crediting rates which are known in advance. The investment contract does not permit the contract issuer to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Additionally, the contract issuer has the right to delay transfers or distributions under certain limited circumstances. The Plan Administrator does not believe that the occurrence of any events that would limit the Plan's ability to transact at contract value with participants is probable.

NOTE 6 - RELATED PARTY TRANSACTIONS

The Plan's investments in the investment contract and pooled separate accounts are with EAIC. The investment contract and pooled separate accounts are sponsored and advised by EAIC. EAIC are the contract holders as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid to the Plan for custodian and recordkeeping services were not significant for the years ended December 31, 2024 and 2023. These transactions are not considered prohibited transactions under Section 408(b) of the ERISA regulations.

NOTE 7 - CERTIFICATIONS

All information related to investment assets, investment transactions, and related income as disclosed in the accompanying financial statements and supplemental schedule of assets held at end of year, is certified as complete and accurate by EAIC and ETC, the trustees and custodian of the Plan, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
