Notes to Financial Statements For the Year Ended December 31, 2024

Note 1 - Description of the Plan

The following description of the ECONET 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for complete information regarding the Plan's provisions.

General - The Plan is a defined contribution plan that was established for the benefit of employees of ECONET, Inc., Aloecorp, Inc., Unigen, Inc., Univera, Inc., and Hilltop Gardens, Inc. (collectively, the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - All employees, other than leased, part-time, temporary, and seasonal employees, are eligible to participate in the Plan after reaching 18 years of age and completing one month of service. The entry date will be the first day of the month coinciding with or following the satisfaction of eligibility requirements.

Contributions - Participants may elect to defer up to 100% of their compensation as pre-tax or Roth contributions, up to the Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

Upon completing the eligibility requirements, employees will be automatically enrolled in the Plan to contribute 3% of their eligible compensation. Employees can opt out or change contributions at any time. There is no auto-escalation feature.

The Company may make a discretionary matching contribution. For the year ended December 31, 2024, the employer discretionary matching contributions were equal to 50% of each participant's deferral contributions up to 6% of eligible compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contribution and loan repayments and allocations of (a) the Company's contribution and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested with respect to their deferral contributions plus actual earnings thereon. Employer matching contributions are fully vested after completing one year of service.

Distributions - Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution of their vested account balance as a lump-sum payment. The Plan also allows automatic distributions of terminated participant accounts with balances less than \$5,000 into qualified individual retirement accounts. The Plan also provides for in-service withdrawals for participants over the age of 59½. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 1 - Continued

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their entire vested account balance or \$50,000. The minimum amount required to be borrowed is \$1,000. Loan terms range from one to five years unless it is used to acquire a principal residence. The loans bear interest at the Prime rate plus 2% at the effective date of the loan. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,357 and \$3,152, respectively.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees for loans and benefit payments are charged directly to participant accounts. The Company may elect to pay other administrative expenses of the Plan.

Subsequent Events - The Plan's management has evaluated subsequent events through August 4, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Newport Trust Company, LLC and Ascensus. Ascensus Trust Company has authorized Ascensus to act as its agent for this purpose pursuant to a written agreement between the two parties. Effective November 14, 2024, the Plan changed its qualified institution from Newport Trust Company, LLC to Ascensus Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Employees would become 100% vested in their accounts at the time of termination.

Note 7 - Tax Status

The Company adopted a Newport Group Inc. pre-approved plan document. Newport Group Inc. received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRS. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Delinquent Contributions

The Company determined there were instances during 2023 in which participant deferral contributions were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$1,707 of deferral contributions and loan repayments were identified as delinquent for the years ended December 31, 2023. The Company restored lost earnings associated with the 2023 delinquent contributions during 2024.
