To the Participants and Administrative Committee of
First Community Bancshares, Inc. Employees' Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed audits of the financial statements of First Community Bancshares, Inc. Employees' Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (financial statements).

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following description of First Community Bancshares, Inc. Employees' Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan's Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for the exclusive benefit of participating employees who have completed one year or more of active service. Affiliated entities participating in the Plan include First Community Bancshares, Inc., First National Bank Texas, First Community Services Data Processing, Inc., and Jerold B. Katz Interests. These companies are collectively referred to as the "Affiliated Entities" or "Employer". The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Plan Administration

The general administration of the Plan is performed by an administrative committee appointed by the Affiliated Entities. Fidelity Management Trust Company ("Trustee") serves as trustee of the Plan.

Members of the administrative committee receive no compensation for their services. The participants pay administrative fees related to investment transactions. The Affiliated Entities pay certain other general expenses related to the Plan's activities.

Contributions

Each year, participants may contribute from 1% to 50% of their pre-tax annual compensation not to exceed the limitation set forth in Section 402(g) (\$23,000 in 2024 and \$22,500 in 2023) of the Internal Revenue Code ("IRC"). Participants may make catch-up contributions, which are pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50th birthday. Participants' total catch-up contributions during 2024 and 2023 cannot exceed \$7,500. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Affiliated Entities made employer safe-harbor matching contributions on behalf of each participant of 100% of the participant's elective contribution up to 4.00% of the participant's compensation during 2024 and 2023 totaling \$3,591,988 and \$3,331,504, respectively. Additionally, the Plan provides for discretionary matching contributions of up to 2.00% of participants annual compensation. The employer discretionary matching contributions for the years ended December 31, 2024 and 2023 were \$1,108,847 and \$1,012,087, respectively. The employer matching contributions are invested directly in the various investment options, as directed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and, subject to eligibility requirements, an allocation of (1) the employers' contribution and (2) Plan earnings or losses. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

1. Description of Plan, continued

Vesting

Participants are vested immediately in their contributions and the Affiliated Entities' safe-harbor matching contributions plus actual earnings thereon. Participants vest in the Affiliated Entities' discretionary matching contributions and related investment income and appreciation or depreciation of the Plan investments as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant's vested account balance. Loan terms range from 1 to 5 years; or higher if for the purpose of a primary residence. Participants are allowed no more than two loans in a 12-month period. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest payments are made through payroll deductions according to the terms of the promissory note. Notes receivable from participants outstanding at December 31, 2024 and 2023 totaled \$6,065,318 and \$5,180,402, respectively. The loans bear interest at rates ranging from 3.25% to 8.50% for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefit payments are typically made in a lump-sum distribution to the participant upon termination of employment, disability or retirement or to the designated beneficiary in the event of death, equal to the balance of the participant's account. The Plan permits hardship withdrawals in the event of an immediate and heavy financial need, as defined by the Plan.

Forfeited Accounts

Forfeiture of part of the Affiliated Entities' discretionary matching contributions may occur if a participant terminates employment or withdraws contributions prior to the vesting period. At December 31, 2024 and 2023, forfeited non-vested accounts balance were \$45,853 and \$45,379. During the years ended December 2024 and 2023 employees forfeited non-vested account balances of \$46,614 and \$40,901, respectively. Forfeitures used in 2024 and 2023 to reduce employer contributions were \$59,341 and \$54,538, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options. These investment options are exposed to market risks, which generally mean the risk of loss in the value of certain investment securities due to changes in interest rates, security and commodity prices and general market conditions. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Money market funds are valued at amortized cost, which approximates fair value.

Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation of investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023, as the Plan administrator has determined the notes receivable had adequate collateral. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

3. Fair Value Measurements

FASB Accounting Standards Codification ("ASC"), Topic 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining the fair value of the assets and liabilities, the Plan generally uses two approaches, the market approach and the cost approach. The market approach uses prices and other relevant data based on market transactions involving identical or comparable assets. The cost approach is the amount that would be currently required to replace an asset and indicates the cost to the Plan to require a substitute asset.

The following is a description of the valuation methods used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued based on observable market quotations, traded in an active market, and are priced on a daily basis at the close of business. Thus, these investments are classified within level 1, of the valuation hierarchy. (Market approach)

Money market fund: Valued at amortized cost, which approximates fair value and is classified within level 2 of the valuation hierarchy. (Cost approach)

Self-directed brokerage account which includes mutual funds, money market accounts, certificates of deposit and government bonds: Investments in government bonds are valued using independent pricing services and investment managers. (Market Approach) Investments in certificates of deposit are valued at amortized cost which approximates fair value. (Cost Approach) The investments within the self-directed brokerage accounts are classified within level 1 and level 2 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, certain information related to the investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held, and net appreciation in fair value of investments, interest income from notes receivable from participants and interest and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Internal Revenue Service has determined and informed the Plan by letter dated May 29, 2015, that the Plan is designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if Plan management has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although they have not expressed any intent to do so, the Affiliated Entities have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in any previously non-vested account balances.

7. Party-in-Interest Transactions

Certain Plan investments are in accounts managed by the Plan trustee, and the Plan allows participants to borrow from their vested account balance. These transactions qualify as party-in-interest transactions, as defined by ERISA, however, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

8. Subsequent Events

Plan management has evaluated all subsequent events through July 30, 2025 which is the date the financial statements were available to be issued and has concluded that there are no significant events to be reported.
