### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Big R 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Big R 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Big R 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Basis of Accounting***

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Big R 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution 401(k) plan established January 1, 2017 and provides savings and retirement benefits to eligible employees of Big R Holdings, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

The Plan's custodian, Charles Schwab Trust Bank, was responsible for the custody and management of the Plan's assets as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Plan is administered by The Standard Insurance Company.

The U.S. Congress enacted the SECURE Act which includes provisions that impact benefit plans. Provisions of the SECURE Act are operationally available at this time but Plan documents will not require formal amendment until 2025. SECURE increased the RMD age from 70 ½ to 73, allows for long-term part-time employees to participate and allows for in service withdrawals for childbirth and adoption expense. The Plan is not currently operating according to these provisions and the Plan will be formally amended before the required 2025 deadline.

**Participation and Eligibility.** Through February 28, 2024, employees age 21 and over become eligible for coverage under the Plan on the first day of the plan year or the first day of July following one year after their date of hire. Effective March 1, 2024, the Plan was amended to allow employees age 21 and over to become eligible for coverage under the Plan on the first day of the month after three months of service.

**Participant Contributions.** Each year, eligible participants can contribute on either after-tax or on a tax-deferred basis a portion of their annual compensation, subject to statutory limitations. The maximum contribution allowed in 2024 was \$23,000 (\$30,500 for participants whose age was 50 or over by the end of 2024). Employees may also elect to contribute amounts representing distributions from other qualified plans.

**Employer Contributions.** The Plan permits a safe harbor employer matching contribution of 100% of the participant's first 4% of compensation deferred. The Plan also allows for a discretionary Employer match. There were no discretionary Employer matching contributions for the year ended December 31, 2024 and 2023.

Employer contributions are recorded when received by the Plan consistent with the modified cash basis of accounting as described in Note 2.

**Vesting.** Participants are immediately vested in their contributions and employer safe harbor contributions, including earnings thereon. All Employer's discretionary matching

contributions, including earnings thereon, become vested upon death, disability or attaining age 65 or according to the following schedule:

**Participant Accounts.** Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and, (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants.** Participants may borrow from their account up to a maximum of \$50,000 or 50% of their vested account balances, whichever is less. The loans are secured by the balance in the participant's account and bear interest based on the prevailing rates charged by lenders under similar circumstances as determined by the plan administrator as of the loan date. Principal and interest is paid ratably through bi-weekly payroll deductions. The rate on all loans outstanding as of December 31, 2024 was 3.25%-8.50%.

**Payment of Benefits.** Participants who terminate employment with the Employer prior to retirement receive a distribution of their account balance in the event their vested account balance is less than \$5,000. In the event their vested account balance is greater than \$5,000, the participants can elect to receive their distribution, to roll over the distribution, or to retain their account balance with the plan. Participants may request an in-service distribution once attaining age 59 ½ or for hardship as defined by the Plan.

Participants who retire or participants' beneficiaries, in the event of death, have several options available under which they may receive benefits. Such benefits include receiving payment in a lump sum or selecting from various periodic payment options which are

available to the participant and/or the participant's beneficiary as more fully described in the Plan documents.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The records of the Plan are kept on the modified cash basis of accounting, under which certain additions to net assets, including employer contributions, are recognized when received rather than when earned and certain deductions from net assets are recognized when paid rather than when the obligation is incurred.

Investment contracts held by a defined contribution plan are required to be reported at contract value. The Statement of Net Assets Available for Benefits presents the contract value of the fully-benefit responsive investment contracts.

**Estimates.** The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments in registered investment companies are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in guaranteed investment contracts are stated at contract value as described in Note 5. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 . If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits.** Benefits are recorded when paid.

**Fee Income.** In the event that recordkeeping revenue received in connection with plan services under revenue sharing arrangements exceeds agreed upon compensation levels, such excess revenue is deposited to a suspense account and to be used to pay plan expenses or to be allocated to accounts of eligible participants. Administrative expense refunds, and

the corresponding administrative expenses, are recognized on a gross basis on the statement of changes in net assets available for benefits.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and excluded from these financial statements. Management is not bound to pay such expenses in the future. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses and related revenue sharing amounts are included in net appreciation of fair value of investments.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (the custodian of the Plan assets).

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB 820 are described as follows:

Level 1— Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2— Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3— Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5- GUARANTEED INVESTMENT CONTRACT**

The Plan has entered into a fully benefit-responsive investment contract with Standard Insurance Company who maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments (principally longer term fixed-income securities) and charged for Plan withdrawals and transaction fees charged by the custodian. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. The crediting rate for the year ended December 31, 2024 was 3.04%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The custodian may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time.

**NOTE 6 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Standard Insurance Company. Standard Insurance Company is the plan administrator and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Certain registered investment company funds may make revenue sharing payments to the Standard Insurance Company which collects the funds for the benefit of the plan. The revenue sharing payments may reduce the plan expenses or be allocated among participants.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service approved a master prototype plan by a letter dated June 30, 2020, under which the Plan operates, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31,

2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9 - CONCENTRATIONS OF CREDIT RISK/RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balance and amounts reported in the accompanying statement of net assets available for benefits.

**NOTE 10 - OPERATIONAL ERROR**

During the plan year ended December 31, 2024, the Plan management identified an error in certain employees' eligibility dates and as a result certain eligible employees were not given the opportunity to enroll timely. Management corrected the error and made a corrective contribution of \$50,565 plus lost earnings of \$4,439 to impacted employees.

**NOTE 11 - SUBSEQUENT EVENTS**

Subsequent events were evaluated through date of the auditor's report, which is the date the financial statements were available to be issued and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on its financial statements.
