Opinion

NOTES TO FINANCIAL STATEMENTS

DESCRIPTION OF PLAN

The following description of the Guy C. Lee Manufacturing Company (Company) Employee Benefit Plan (Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General

The Plan provides certain medical, dental, short term disability and life insurance benefits to eligible employees of the Company and the following affiliated companies: Guy C. Lee Building Materials, LLC, Guy C. Lee Building Materials of Smithfield, Inc., Lampe Leasing, LLC, Lampe & Malphrus Lumber Company, Builder Finance Group, LLC, Vanir Installed Sales, LLC, Vanir Installed Sales of Wilmington, LLC, Vanir Installed Sales Corporate, LLC, Vanir Installed Sales of Charleston, LLC, Vanir Installed Sales of Greenville, LLC, Vanir Installed Sales of Greensboro, LLC, Vanir Installed Sales of Myrtle Beach, LLC, Vanir Installed Sales of Columbia, LLC, Guy C. Lee Headquarters, LLC and Vanir Installed Sales of Charlotte, LLC.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974, as amended (ERISA).

Benefits

The Plan provides health benefits (medical, dental and prescription drugs), life insurance and short-term disability benefits to full-time employees who have been employed by the Company on a basis for at least thirty hours per week and who have completed a sixty-day waiting period. The Plan also provides life insurance and dependent coverage for covered participants who make written request for such coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan uses a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company pays the full cost of basic life insurance for employees and their dependents and stop loss insurance. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payments of Benefits

Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Short-term disability payments are processed through the Company's payroll system and paid from the general assets of the Company. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$159,344 and \$726,501 have been netted with claims paid in the accompanying statements of changes in net assets for the years ended September 30, 2024 and 2023, respectively.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$327,690 and \$233,279 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023, respectively.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Concentrations of Credit Risk

At times, the Plan has on deposit with a bank an amount in excess of FDIC insurance limits. The Plan does not believe that they are exposed to significant credit risk in connection with cash. At September 30, 2024 and 2023 the Plan's uninsured cash balances totaled \$62,334 and \$395,045, respectively.

Subsequent Events

Management has evaluated subsequent events for the Plan through July 12, 2025, the date the financial statements were available to be issued.

CONTRACTS WITH INSURANCE COMPANIES

The Company provides death benefits for covered participants and dependents through monthly premium payments to an insurance company.

CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at September 30 for claims incurred but not reported are estimated by the third-party claims administrator based on the actual claims which have been reported since year end. These amounts are paid by the Plan only if claims are submitted and approved for payment.

FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Cash and cash equivalents include all deposits in banks and highly liquid investments with original maturity dates of less than three months. The carrying value of cash and cash equivalents approximate fair value because of the short maturities of those financial instruments.

TAX STATUS

The VEBA trust funding certain benefits of the Plan received an exemption letter from the IRS stating that the trust is tax exempt under the provisions of Section 501(c)9 of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

DOL REQUIRED SCHEDULES

The Plan has no information which is to be reported in additional supplemental schedules required by the Department of Labor.

RELATED PARTY TRANSACTIONS

The Plan sponsor absorbs certain administrative costs incurred on behalf of the Plan.

RISKS AND UNCERTAINTIES

The benefit obligation is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
