### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Organon US Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### 1. Description of Plan

The following description of the Organon US Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

#### General

The Plan was adopted effective June 2, 2021. The Plan is a defined contribution plan designed to help participants build a sound financial future. Regular full-time, part-time, and temporary employees as defined by the plan document are eligible to participate in the Plan on or after their date of hire or after they transfer into a U.S. benefits-eligible position. Organon LLC ("Organon") is the Plan sponsor (the "Company" or "Sponsor").

Fidelity Management Trust Company ("Fidelity" or the "Trustee") is the trustee and recordkeeper of the Plan. Fidelity holds all assets of the Plan in accordance with the service provider contract with the Company.

The Plan is administered by Management Benefits Investment Committee appointed by the Company's Chief Executive Officer, the Compensation and Benefits Committee of the Board of Directors of Organon or their delegates.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### Enrollment

Participants are automatically enrolled in the Plan 60 days after first becoming eligible with a before-tax base pay contribution rate of 6%. In addition, each participant with a before-tax base pay contribution rate of at least 1% may elect to participate in an annual automatic increase program, in whole percentages of at least 1% and not more than 3% per year. The automatic percentage increase may not cause a participant's before-tax base pay contribution rate to exceed 25%. This feature applies to before-tax bonuses and base pay contributions.

#### Contributions

Participants may contribute up to 25% of their annual eligible compensation through a combination of before-tax, Roth and after-tax contributions (in 1% increments), up to the combined statutory elective deferral limit (\$23,000 in 2024 and \$22,500 in 2023). Upon reaching the statutory elective deferral limit for combined before-tax and Roth contributions, the participant may elect to suspend contributions for the remainder of the year or elect to continue on an after-tax basis. The sum of before-tax, Roth, after-tax and catch-up contributions cannot exceed 100% of annual eligible compensation.

In addition, the Plan permits matched before-tax and Roth "catch-up contributions" of up to the statutory limit (\$7,500 in 2024 and in 2023) by participants who are at least age 50 by year-end.

The Company makes matching contributions of \$0.75 for every \$1.00 of an employee's contributions, up to 6% of such employee's eligible compensation (maximum match is 4.5% of eligible compensation) to the statutory limit. The combination of before-tax, Roth, after-tax and Company matching contributions may not exceed the statutory limit (\$69,000 in 2024 and \$66,000 in 2023). Participant and Company matching contributions are invested according to a participant's elections.

In certain circumstances, such as when participant contributions fall below 6% at any point during the year or are not made uniformly throughout the year, the Company Matching Contribution made each pay period may differ from the amount determined on an annual basis. The Plan's True-Up Match automatically corrects this to ensure participants receive the full match they are eligible for, regardless of how their contributions were structured.

In addition, the Company also makes an annual Retirement Contributions of between 4.5% and 10% of Total Pay based on the participant's age and years of service. Effective with the 2024 Plan Year, the Company will make True-Up Match and Retirement Contributions for participants only if they are employed by the Company on the last day of the calendar year. Exceptions apply for those who terminate employment with the Company prior to December 31 of the Plan Year after reaching age 55 and completing 10 years of Vesting Service, after reaching age 65, because of death, due to Workforce Restructuring or a Change in Control. Since this change became effective August 27, 2023, eligible terminated employees in 2023 received the True-Up Match and Retirement Contributions using the Compensation through August 27, 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

### Investment Options

Participants direct the investment of their contributions into any fund investment option available under the Plan. As of December 31, 2024, the Plan offered a three-tiered approach to investing:

- \* Retirement Portfolios – a custom set of target date retirement funds;
- \* Core Funds – a selection of investment options (passive) that span a range of asset classes;
- \* Fidelity Brokerage Link® - a self-directed brokerage account that provides access to more than 12,000 mutual funds.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of net Plan earnings or losses. The allocation is based on participants' account balances, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### Vesting

Participants are always vested in the contributions they make to the Plan and any earnings on these contributions. In addition, they are automatically 100% vested in any Company Matching Contributions made on their behalf to the Plan and in the earnings on these contributions.

With respect to the annual Retirement Contribution and any earnings on these contributions, participants become vested on the first of the following to occur:

- They have at least three years of Vesting Service with the Company or an Affiliate.
- They reach Normal Retirement Age (Age 65) while employed by the Company or an Affiliate.
- They become Disabled while employed by the Company or an Affiliate.
- They die while actively employed by the Company or an Affiliate.

### Notes Receivable from Participants

Participants may borrow from their account balances with interest charged at the prime rate plus 1%. Loan terms range from one to five years for a short-term loan or up to fifteen years for the purchase of a primary residence and bear interest at rates that range from 4.25% to 9.5%. The minimum loan is \$1,000 and the maximum for all outstanding loans combined is the lesser of the following:

- 50% of their vested account balance minus any current outstanding loan balance under the Plan, or
- \$50,000 minus their highest outstanding loan balance under the Plan, if any, during the prior 12-month period.

Principal and interest are paid ratably through payroll deductions. Loan terms are grandfathered into the Plan in accordance with the legacy plan guidelines, including loan terms for participants that transferred into the Plan from a legacy plan.

### Payment of Benefits

Participants are entitled to receive automatic, voluntary, in-service (which include hardship withdrawals), or mandatory distributions as provided in the applicable Plan provisions. A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$2,415,642 and \$550,882, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. No forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024 or 2023.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Management believes that these estimates are adequate. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

All investments are recorded at fair value in the accompanying financial statements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan document.

#### Contributions

Employee and Company matching contributions are recorded in the period in which the Company makes the payroll deductions from the participants' earnings.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Administrative expenses paid from plan assets include recordkeeping (for inactive participants), loan setup and other fees. Other administrative expenses are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Risks and Uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks and may decline in value for a number of reasons, including changes in prevailing interest rates and credit availability, increases in defaults, increases in voluntary prepayments for investments that are subject to prepayment risk under normal market conditions, widening of credit spreads and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 4. Related-Party Transactions

Certain Plan investments are shares of registered investment companies (mutual funds) and common/collective trusts managed by the Trustee. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant thereby affected would receive the entire value of his or her account as though he or she had retired as of the date of such termination.

### 6. Tax Status

The Plan has adopted a pre-approved profit sharing plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, indicating that the Plan is been designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Sponsor believes that the Plan is designed and currently operates in compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 7. Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Entities are required to use a fair value hierarchy that maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. There are three levels of inputs that may be used to measure fair value:

*Level 1* – Quoted prices in active markets for identical assets or liabilities.

*Level 2* – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

If the inputs used to measure the financial assets and liabilities fall within more than one level described above, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. There have been no changes in the valuation methodologies used on December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies (Mutual Funds)**

Registered investment companies (mutual funds) are valued at their respective net asset values. The net asset values are typically determined by the fund at the close of regular trading. Investments in registered investment companies (mutual funds) generally may be redeemed daily.

#### **Common/Collective Trusts**

The common/collective trusts are valued at net asset value, as a practical expedient for fair value. The fair value of investments in the common/collective trusts are determined by its trustee. The Plan's investments in common/collective trusts generally may be redeemed daily. There were no unfunded commitments to common/collective trusts.

## Notes to Financial Statements

### Self-Directed Brokerage Accounts

Self-directed brokerage accounts are comprised mainly of registered investment companies, rights/warrants, and interest-bearing cash which are valued at the net asset value reported by the managers of the funds, typically determined at the close of regular trading.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule H - Line 4i - Schedule of Asset (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of the Organon US Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

#### General

The Plan was adopted effective June 2, 2021. The Plan is a defined contribution plan designed to help participants build a sound financial future. Regular full-time, part-time, and temporary employees as defined by the plan document are eligible to participate in the Plan on or after their date of hire or after they transfer into a U.S. benefits-eligible position. Organon LLC ("Organon") is the Plan sponsor (the "Company" or "Sponsor").

Fidelity Management Trust Company ("Fidelity" or the "Trustee") is the trustee and recordkeeper of the Plan. Fidelity holds all assets of the Plan in accordance with the service provider contract with the Company.

The Plan is administered by Management Benefits Investment Committee appointed by the Company's Chief Executive Officer, the Compensation and Benefits Committee of the Board of Directors of Organon or their delegates.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### Enrollment

Participants are automatically enrolled in the Plan 60 days after first becoming eligible with a before-tax base pay contribution rate of 6%. In addition, each participant with a before-tax base pay contribution rate of at least 1% may elect to participate in an annual automatic increase program, in whole percentages of at least 1% and not more than 3% per year. The automatic percentage increase may not cause a participant's before-tax base pay contribution rate to exceed 25%. This feature applies to before-tax bonuses and base pay contributions.

#### Contributions

Participants may contribute up to 25% of their annual eligible compensation through a combination of before-tax, Roth and after-tax contributions (in 1% increments), up to the combined statutory elective deferral limit (\$23,000 in 2024 and \$22,500 in 2023). Upon reaching the statutory elective deferral limit for combined before-tax and Roth contributions, the participant may elect to suspend contributions for the remainder of the year or elect to continue on an after-tax basis. The sum of before-tax, Roth, after-tax and catch-up contributions cannot exceed 100% of annual eligible compensation.

In addition, the Plan permits matched before-tax and Roth "catch-up contributions" of up to the statutory limit (\$7,500 in 2024 and in 2023) by participants who are at least age 50 by year-end.

The Company makes matching contributions of \$0.75 for every \$1.00 of an employee's contributions, up to 6% of such employee's eligible compensation (maximum match is 4.5% of eligible compensation) to the statutory limit. The combination of before-tax, Roth, after-tax and Company matching contributions may not exceed the statutory limit (\$69,000 in 2024 and \$66,000 in 2023). Participant and Company matching contributions are invested according to a participant's elections.

In certain circumstances, such as when participant contributions fall below 6% at any point during the year or are not made uniformly throughout the year, the Company Matching Contribution made each pay period may differ from the amount determined on an annual basis. The Plan's True-Up Match automatically corrects this to ensure participants receive the full match they are eligible for, regardless of how their contributions were structured.

In addition, the Company also makes an annual Retirement Contributions of between 4.5% and 10% of Total Pay based on the participant's age and years of service. Effective with the 2024 Plan Year, the Company will make True-Up Match and Retirement Contributions for participants only if they are employed by the Company on the last day of the calendar year. Exceptions apply for those who terminate employment with the Company prior to December 31 of the Plan Year after reaching age 55 and completing 10 years of Vesting Service, after reaching age 65, because of death, due to Workforce Restructuring or a Change in Control. Since this change became effective August 27, 2023, eligible terminated employees in 2023 received the True-Up Match and Retirement Contributions using the Compensation through August 27, 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

### Investment Options

Participants direct the investment of their contributions into any fund investment option available under the Plan. As of December 31, 2024, the Plan offered a three-tiered approach to investing:

- \* Retirement Portfolios – a custom set of target date retirement funds;
- \* Core Funds – a selection of investment options (passive) that span a range of asset classes;
- \* Fidelity Brokerage Link® - a self-directed brokerage account that provides access to more than 12,000 mutual funds.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of net Plan earnings or losses. The allocation is based on participants' account balances, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### Vesting

Participants are always vested in the contributions they make to the Plan and any earnings on these contributions. In addition, they are automatically 100% vested in any Company Matching Contributions made on their behalf to the Plan and in the earnings on these contributions.

With respect to the annual Retirement Contribution and any earnings on these contributions, participants become vested on the first of the following to occur:

- They have at least three years of Vesting Service with the Company or an Affiliate.
- They reach Normal Retirement Age (Age 65) while employed by the Company or an Affiliate.
- They become Disabled while employed by the Company or an Affiliate.
- They die while actively employed by the Company or an Affiliate.

### Notes Receivable from Participants

Participants may borrow from their account balances with interest charged at the prime rate plus 1%. Loan terms range from one to five years for a short-term loan or up to fifteen years for the purchase of a primary residence and bear interest at rates that range from 4.25% to 9.5%. The minimum loan is \$1,000 and the maximum for all outstanding loans combined is the lesser of the following:

- 50% of their vested account balance minus any current outstanding loan balance under the Plan, or
- \$50,000 minus their highest outstanding loan balance under the Plan, if any, during the prior 12-month period.

Principal and interest are paid ratably through payroll deductions. Loan terms are grandfathered into the Plan in accordance with the legacy plan guidelines, including loan terms for participants that transferred into the Plan from a legacy plan.

### Payment of Benefits

Participants are entitled to receive automatic, voluntary, in-service (which include hardship withdrawals), or mandatory distributions as provided in the applicable Plan provisions. A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$2,415,642 and \$550,882, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. No forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024 or 2023.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Management believes that these estimates are adequate. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

All investments are recorded at fair value in the accompanying financial statements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan document.

#### Contributions

Employee and Company matching contributions are recorded in the period in which the Company makes the payroll deductions from the participants' earnings.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Administrative expenses paid from plan assets include recordkeeping (for inactive participants), loan setup and other fees. Other administrative expenses are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Risks and Uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks and may decline in value for a number of reasons, including changes in prevailing interest rates and credit availability, increases in defaults, increases in voluntary prepayments for investments that are subject to prepayment risk under normal market conditions, widening of credit spreads and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

### 4. Related-Party Transactions

Certain Plan investments are shares of registered investment companies (mutual funds) and common/collective trusts managed by the Trustee. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant thereby affected would receive the entire value of his or her account as though he or she had retired as of the date of such termination.

### 6. Tax Status

The Plan has adopted a pre-approved profit sharing plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, indicating that the Plan is been designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Sponsor believes that the Plan is designed and currently operates in compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 7. Fair Value Measurements

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. Entities are required to use a fair value hierarchy that maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. There are three levels of inputs that may be used to measure fair value:

*Level 1* – Quoted prices in active markets for identical assets or liabilities.

*Level 2* – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgment or estimation.

If the inputs used to measure the financial assets and liabilities fall within more than one level described above, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument. There have been no changes in the valuation methodologies used on December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies (Mutual Funds)**

Registered investment companies (mutual funds) are valued at their respective net asset values. The net asset values are typically determined by the fund at the close of regular trading. Investments in registered investment companies (mutual funds) generally may be redeemed daily.

#### **Common/Collective Trusts**

The common/collective trusts are valued at net asset value, as a practical expedient for fair value. The fair value of investments in the common/collective trusts are determined by its trustee. The Plan's investments in common/collective trusts generally may be redeemed daily. There were no unfunded commitments to common/collective trusts.

## Notes to Financial Statements

### Self-Directed Brokerage Accounts

Self-directed brokerage accounts are comprised mainly of registered investment companies, rights/warrants, and interest-bearing cash which are valued at the net asset value reported by the managers of the funds, typically determined at the close of regular trading.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
