### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Antelope Memorial Hospital Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule H, line 4i – schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Note 1 - Description of Plan**

The following brief description of the Antelope Memorial Hospital Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of Antelope Memorial Hospital (Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Employer is responsible for oversight of the Plan as well as determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed one year of service (at least 1,000 hours) and are 21 years of age.

### **Entry Date**

Employees may enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Employer contributions are discretionary and determined annually by the Employer. For the Plan year ended December 31, 2024, the Employer elected to contribute 3% of the eligible participating employee's compensation plus an additional 3% of compensation in excess of the Social Security taxable wage base. Participants may contribute amounts representing distributions from other qualified plans (rollovers). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

### **Participant Accounts**

Each participant's account is credited with the participant's rollover contributions, the Employer's contributions, and allocations of the Plan's earnings and administrative expenses. Allocations are based on account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment to the Plan, a participant may direct the Employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in any rollover contributions, plus actual earnings thereon. A participant is 100% vested in the Employer's contribution after three years of credited service. Separate provisions apply in the event of death or disability of the participant or when a participant reaches normal retirement age.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,405 and \$9,081. These accounts will be used to reduce future Employer contributions or pay Plan expenses. The Employer contribution that was received during the year ended December 31, 2024 was reduced by \$9,081 from forfeited non-vested accounts. The Employer contribution receivable as of December 31, 2024, was reduced by \$4,405 from forfeited non-vested accounts.

### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's account balance does not exceed \$5,000, the Plan can automatically cash out the account upon the participant's termination. In the event of a mandatory distribution greater than \$1,000, if the participant does not elect to have the distribution paid directly to an eligible plan specified by the participant or to receive the distribution directly, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement account. For account balances greater than \$5,000, a participant must elect to receive the distribution or the vested benefit will continue to be invested in the Plan's assets.

### **Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Management of the Employer determines the Plan's valuation policies utilizing information provided by the trustee.

The fair value of pooled separate accounts is determined by the net asset value (NAV) of the funds underlying investments held at year end adjusted for any dividends or distribution received by American United Life Insurance Company (AUL) and the daily equivalent of any fee charged by AUL pursuant to the contract. The NAV, as provided by AUL, is used as a practical expedient to estimate fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

The Employer's contributions are recorded in the year in which the related participant compensation is paid.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Expenses**

The Plan's expenses are paid by either the Plan or the Employer, as provided by the Plan document. Expenses that are paid directly by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### **Subsequent Events**

The Plan has evaluated subsequent events through July 31, 2025, the date which the financial statements were available to be issued.

**Note 3 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the trustee of the Plan).

**Note 4 - Fair Value of Investments in Certain Entities that Calculate Net Asset Value Per Share (or its Equivalent)**

- (a) This category seeks capital appreciation by investing primarily in large capitalization companies. Although it invests primarily in U.S. securities, investments in foreign companies may be made.
- (b) This category includes funds that are designed to seek a high total return relative to the participant's target retirement year. These funds invest in a mixture of stocks, bonds, and cash. Asset allocations become more conservative over time.
- (c) This category seeks long-term growth of capital and has few geographical limitations. These funds invest primarily in common stocks of well-established companies located around the world. These funds may also invest in issuers in developing countries.
- (d) This category seeks capital appreciation by investing primarily in small capitalization companies. These funds generally invest in companies with growth characteristics or those believed to be undervalued.
- (e) This category seeks highest level of total return consistent with its asset mix which consists of equity, fixed income and cash positions.

- (f) This category seeks long-term capital appreciation by investing in primarily mid-sized companies or smaller. Although it invests primarily in U.S. securities, investments in foreign companies may be made.
- (g) This category seeks long-term capital appreciation by investing in foreign market securities. These funds invest primarily in the common stock of companies in both developed and developing foreign markets.
- (h) This category seeks to provide a high level of current income with a secondary investment objective of capital appreciation. These funds invest primarily in higher yielding and generally lower quality debt securities (rated Ba1 or below or BB+ or below).
- (i) This category includes funds that invest in a portfolio of primarily corporate and other investment-grade U.S. fixed-income securities.
- (j) This category seeks to maximize current income to the extent consistent with the preservation of capital and the maintenance of liquidity by investing in high quality money market instruments.

#### **Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by OneAmerica Financial Partners Inc, which received an opinion letter from the Internal Revenue Service (IRS), dated September 27, 2022, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Contracts with Insurance Company**

The Plan entered into traditional fully benefit-responsive guaranteed investment contracts (GIC) with AUL. AUL maintains contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate for the AUL Fixed account is based on a formula agreed upon with the issuer but may not be less than 3%. The guaranteed interest rate for the AUL Stable Value account is subject to market rates but may not be less than 0%. Such interest rates are reviewed on an annual basis for resetting. The GIC do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan has entered into an agreement with AUL to freeze future contributions to the underlying AUL Fixed account and begin directing future contributions under this contract to the AUL Stable Value account.

Because the GIC are fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by AUL represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contracts at December 31, 2024 and 2023 was \$800,065 and \$1,026,492, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents; (2) changes to the Plan's prohibition on competing investment options; or (3) significant withdrawals from the Plan. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### **Note 7 - Party-in-Interest Transactions**

Certain Plan investments consist of traditional fully benefit-responsive investment contracts and pooled separate accounts managed by AUL, the trustee as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The investment options of the Plan include various portfolios within an AUL separate account. The separate account in turn invests in investment portfolios of certain open-end management investment companies. AUL receives indirect compensation from these investment companies for the services provided by AUL.

The compensation received by AUL is computed by each investment company by multiplying the daily account balance of the AUL separate account's interest in a particular portfolio by a predetermined percentage rate negotiated with the investment company. This indirect compensation is not charged to the plan or participants accounts but is paid directly by the investment company.

The investment company, the underlying investment portfolio, and the annual compensation percentages are shown below.
