Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the LimoLink, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of the LimoLink, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of LimoLink, Inc. (the Sponsor) who are age 18 or older and have completed three months of service with the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Employees of the Sponsor may contribute up to the maximum allowable amount of their compensation to the Plan not to exceed the limits of Code Sections 401(k), 404 and 415. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with their deferral rate set at 3% of eligible compensation unless they affirmatively elect otherwise. Employees who are auto-enrolled will have their deferral rate increased by 1% annually until their deferral rate is 8% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. At the discretion of the Sponsor's Board of Directors, the Sponsor may elect to make a matching contribution or additional discretionary contributions. The Sponsor made matching contributions equal to 25% of employee deferral contributions up to 2% of their eligible compensation for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations. Contributions from Plan participants and the matching contributions from the Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Participant accounts: Each participant's account is credited with their contributions, Sponsor contributions and an allocation of Plan earnings. Participant accounts are charged with withdrawals and allocations of administrative expenses paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct employee and Sponsor contributions into any of the investment options offered by the Plan. Participants may elect to change their allocation of contributions between fund options daily.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any contributions made by the Sponsor is based on a four-year graded vesting schedule. Participants vest 25% for each year of employment in which they work over 1,000 hours. A participant becomes fully vested after four years of service or upon retirement, death or permanent disability.

Forfeitures: Forfeited balances of terminated participants' nonvested accounts are used to reduce future Sponsor contributions or pay Plan administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures totaling \$4,688 and \$5,347, respectively, were used to reduce Sponsor contributions or pay Plan administrative expenses. Forfeited balances available for future use totaled \$698 and \$905 as of December 31, 2024 and 2023, respectively.

Payments of benefits: Upon retirement, participants receive the amount credited to their accounts. A similar benefit is paid upon disability or death. In the event of termination of employment, if the participant's account balance is greater than \$5,000, the participant may elect to receive a lump-sum amount or leave the balance of their account in the Plan until retirement. If the participant's account balance is less than \$5,000 but greater than \$1,000, the balance will automatically roll over into an individual retirement account. For participants with account balances of less than \$1,000, the participant will receive a lump-sum distribution. In-service distributions are allowed for active participants age 59½ and older. Participants are also allowed to withdraw benefits in the event of financial hardships.

Administrative expenses: The Plan paid administrative expenses of \$68,782 and \$59,470 for the years ended December 31, 2024 and 2023, respectively. All other expenses were paid by the Sponsor.

Notes to Financial Statements

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition: Investments are stated at fair value on the statements of net assets available for benefits. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payment of benefits: Benefit payments to participants are recorded when paid.

Subsequent events: Management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued based on the net asset value (NAV) of shares held by the Plan based on the market value of its underlying investments as determined by the third-party administrator. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Subtopic 820-10, certain investments that were measured at the NAV per share practical expedient have not been classified in the fair value hierarchy. There were no investments requiring classification in the fair value hierarchy as of December 31, 2024 and 2023.

Note 5. Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A.), who is also the Plan custodian. These transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants will become fully vested in their accounts.

Note 7. Income Tax Status

The Plan has adopted a pre-approved plan document by Qualified Plan Consultants LLC that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.
