## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Atlantic Power Services 401(k) and Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Atlantic Power Services 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO THE FINANCIAL STATEMENTS**  
**December 31, 2024 and 2023**

**1. Description of the Plan**

The following description of the Atlantic Power Services 401(k) and Profit Sharing Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 401(k) plan covering substantially all employees of Atlantic Power Services, LLC (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In December 2023, the Employer sold four of its plants. Employees terminated in conjunction with these sales were already fully vested under the Plan's safe harbor provisions.

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Workplace Services LLC (Fidelity) is the appointed trustee of the Plan and acts at the direction of the Plan Administrator.

***Contributions***

Eligible employees may contribute up to 90% of pretax and after-tax annual compensation, as defined in the Plan document. Participants may designate some or all of their elective deferrals as Roth 401(k) deferrals. Participants who have reached the age of 50 may contribute additional amounts in the form of catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for an automatic enrollment, whereby eligible employees are automatically enrolled to defer 3% of eligible earnings, as applicable, in the Plan. This rate is automatically increased by 1% each January 1, up to a maximum of 10%. Participants must submit an election, either by telephone or the internet, to opt out of the automatic enrollment provisions of the Plan.

The Employer makes safe harbor matching contributions of 100% of the amount a participant contributes to the Plan (excluding after-tax deferrals), up to a maximum of 5% of eligible compensation. The Employer may make additional discretionary and/or profit sharing contributions at the option of the Employer's Board of Directors. For the year ended December 31, 2024, the Employer contributed safe harbor matching contributions in the amount of \$646,462. No discretionary or profit sharing contributions were made during the Plan year ended December 31, 2024. Both participant and Employer contributions are subject to certain statutory limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contributions, (b) Plan earnings (losses), and (c) administrative revenue (expenses). Plan earnings (losses) and administrative revenue (expenses) are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and Employer contributions, plus the allocation of Plan earnings on those contributions at the time of allocation.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000, up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. Note terms range from one year to five years, or up to 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid ratably through payroll deductions. Participants can only have one loan outstanding at any given time.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant and/or designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or substantially equal installments over the participant's and/or designated beneficiary's lifetime, as defined in the Plan agreement. Upon termination of employment for reasons other than death, disability or retirement, the vested portion of the participant's account is distributed to the participant in a lump sum.

Participants who have reached the age of 59½ may elect to withdraw all or a portion of their account while still employed by the Employer. In addition, participants may request a financial hardship withdrawal from their employee deferral accounts, subject to limitations imposed by the Internal Revenue Code (IRC). Participant vested account balances that are \$1,000 or less upon termination will be paid in an immediate lump-sum distribution. If a participant's vested balance exceeds \$1,000 and is equal to or less than \$7,000 (increased from \$5,000 effective May 1, 2024), the amount will be rolled over to an individual retirement account designated by the Employer, unless otherwise directed by the participant.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Fully Benefit-responsive Investment Contract***

Authoritative guidance defines the circumstances in which an investment contract is considered fully benefit-responsive and provides certain reporting and disclosure requirements for fully benefit-responsive investment contracts held by defined contribution, health and welfare and pension plans.

The Plan had an investment in the Guaranteed Income Fund, a group annuity contract issued by Empower Annuity Insurance Company (Empower), which met this requirement. The Plan's investment in these funds, which represents contributions and reinvested interest income, less withdrawals and expenses, plus or minus net participant-directed transfer activity with the Plan's other investment funds, was recorded at contract value.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participants' account. Interest income on participant notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on terms of the Plan document.

***Contributions***

Participant and Employer safe harbor contributions are recorded bi-weekly, when the Employer remits the contributions for investment into the funds. Employer discretionary and profit sharing contributions are remitted annually.

***Administrative Revenue (Expenses)***

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits. Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues of \$17,698 and \$2,210 at December 31, 2024 and 2023, respectively.

***Payment of Benefits***

Benefits are recognized when paid to participants and/or designated beneficiaries.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities, including mutual funds, are exposed to various risks such as interest rate, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan held investments in two mutual funds that accounted for approximately 31% of total Plan investments as of December 31, 2024. The Plan held an investment in one mutual fund that accounted for approximately 16% of total Plan investments as of December 31, 2023.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through August 6, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Money Market Fund:* The carrying amount of the money market fund is the deposit amount plus accrued interest, as determined according to stated terms.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trust:* Valued at NAV of units held by the Plan. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities divided by the number of units outstanding. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There is no redemption notice period for this investment, though a redemption, once requested, may take up to 10 business days to process.

As of December 31, 2024 and 2023, the Plan's investments in the money market fund and mutual funds are reported at level 1 within the fair value hierarchy.

**4. Fully Benefit-responsive Investment Contract**

The Plan had an investment in the Guaranteed Income Fund, a group annuity contract, which is a traditional fully benefit-responsive investment contract. Contributions to this fund are deposited into Empower's general account, which primarily invests in public bonds, commercial mortgages, and private placement bonds. Effective May 1, 2024, the Plan discontinued the Guaranteed Income Fund as an investment option and all funds existing in the fund as of this date were transferred to the Vanguard Federal Money Market Fund. Upon completion of that transfer, participants could transfer funds in their account into other Plan investment options.

The account was credited with participant contributions, plus earnings, and charged for participant withdrawals and administrative expenses. The insurance company was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The minimum crediting rate under the contract was 1.50% and was reviewed on a semi-annual basis for resetting. The guarantee of values provided for investments made with Empower under the Plan's investment contract was based on the financial strength and claims-paying ability of Empower.

**5. Plan Termination**

The Employer expects to continue the Plan indefinitely. However, the Employer reserves the right to amend the Plan at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. In the event of Plan termination, the participants would be entitled to receive all amounts credited to their accounts.

**6. Income Tax Status**

The Plan has been designed using a volume submitter plan document designed by Fidelity Management and Research Co., who received an advisory letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Summary of Financial Data Certified by the Trustee**

The following is a summary of financial information and data certified by the trustee, Fidelity:

Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, except for employer contributions receivable;

Investment income and interest income from participant notes receivable on the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024; and

Investment information provided in the supplemental schedule, Schedule of Assets (Held at End of Year) at December 31, 2024.

**8. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items in the financial statements. Total Plan assets are in agreement.

**9. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Fidelity, the trustee of the Plan. The Plan also utilizes independent investment advisors. Therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments of \$19,813 to Fidelity and \$95,053 to its independent investment advisors. Participant notes receivable also qualify as party-in-interest transactions.

Fidelity provides certain administrative services to the Plan pursuant to a Fidelity Investments Retirement Plan Service Agreement (FIRSA) between the Employer and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the FIRSA, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. No amounts were allocated to participants for the year ended December 31, 2024.
