NOTE 1 – DESCRIPTION OF PLAN

The following description of the Cargomatic, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Cargomatic, Inc. and Atlas Marine, LLC (collectively, the “Company”) who have one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined by the Plan. Participants who attain the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company makes a safe harbor matching contribution equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan, not to exceed 4% of eligible compensation or \$5,400 for highly compensated employees. Additionally, the Company, at its discretion, may make a profit sharing contribution. There were no profit sharing contributions to the Plan in 2023.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Company’s contributions, and (b) Plan earnings, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in profit sharing contributions, plus earnings thereon, is based on years of continuous service and are subject to a 4 year graded schedule. Upon death or disability while an employee, a participant will immediately vest in his or her account balance.

Payment of Benefits: Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. Participants may elect to receive in-service withdrawals after reaching age 59½ from their contributions to the Plan. In the event of a hardship event participant may elect to receive a withdrawal.

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance. Additionally, the loan cannot exceed \$50,000 less the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans on the date the loan is made. Loans must be repaid within a 5 year term unless the loan proceeds are used to acquire a participant’s principal residence. The loans are secured by the balance in the participant’s account and generally bear interest at prime plus one percent. Participants may only have one loan outstanding at any time. All loans are repaid through payroll deductions.

Forfeitures: Forfeitures of employer contributions are used to offset future employer contributions or administrative expenses of the Plan. There were no forfeitures used to offset employer contributions during 2023. Plan forfeitures available to offset future employer contributions or administrative expenses totaled \$5,199 and \$4,755 as of December 31, 2023 and 2022, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from those estimates.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks as well as the risks related to global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant elected investment management services, notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their entire account.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2023 and 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are defined as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Following is a description of the valuation methods and assumptions used for assets measured at fair value.

Pooled Separate Sub-Accounts: The fair values of participation units held by the Plan in sub-accounts of Voya Retirement Insurance and Annuity Company's ("VRIAC") Variable Annuity Contract D, are based on the net asset values of separate accounts, as reported by the insurance company that manages the separate accounts and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. Each of the pooled separate sub-accounts invests in a single, open-ended mutual fund which is generally identified in the name of the pooled separate sub-account. The investment strategies of these pooled separate sub-accounts are consistent with each of the mutual funds identified in the name of the fund. Each pooled separate sub-account provides for daily redemptions by the Plan with no advance notice requirements, and has redemption prices that are determined by the fund's net asset value per unit.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (“VRIAC” or “Issuer”) totaling \$126,491 and \$47,953, at December 31, 2023 and 2022, respectively. VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The interest crediting rate is updated annually based upon contract provisions, and it may not be less than 1%.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the Plan’s fully benefit responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VRIAC, represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the Issuer’s ability to meet its financial obligations. The Issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract, but generally may only do so after the contract has been in place for at least 5 years, and subject to other terms of the contract. If this were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 7 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Plan management has determined there were certain operational errors related to the calculation of contributions during 2022 which has been corrected during 2023. Management is in the process of evaluating these errors and will be making contributions to the Plan to correct for these errors as soon as administratively feasible and in accordance with guidance from the IRS, and they do not believe this affects the qualified status of the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has concluded that as of December 31, 2023 and 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2020.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Parties in interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds units of pooled separate sub-accounts and a fixed income account managed by VRIAC, the recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan's payment of administrative expenses are party-in-interest transactions as well. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE 9 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through November 5, 2024, which is the date the financial statements were available to be issued.

Effective June 25, 2024, the Company acquired ITG. Participation terms for these employees has not yet been determined.

Plan Management plans to monitor terminations and it's impact to the Plan's status through the subsequent period's year-end as the Company had terminated an abundance of employees.
