Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Anthony Timberlands, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

Notes to Financial Statements

December 31, 2024 and 2023

1. Summary of Significant Plan Provisions

The following description of the Anthony Timberlands, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Anthony Timberlands, Inc., Anthony Wood Treating, Inc., Bank of Bearden, Anthony Hardwood Composites, Inc., Anthony Oak Flooring, Inc., and JEA Lands Limited Partnership (collectively, the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Employees who are not a nonresident alien or a member of a collective bargaining unit are eligible to participate in the Plan immediately after attaining age 18 and completing six months of service. Plan entry dates are the first day of the Plan year or first day of the 7th month of the Plan year coinciding with or next following the date the eligibility requirements are met.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and rollover contributions. Participants may defer amounts up to the Internal Revenue Service (“IRS”) elective deferral limit. The Employer may make discretionary matching contributions to the Plan. For the year ended December 31, 2024, no such Employer discretionary contributions were made.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – The benefits attributable to a participant shall be fully vested upon retirement, death, or disability. If a participant terminates employment other than because of their death, disability, or retirement, they are entitled to the total value of their own contributions and earnings/losses thereon, plus a vested percentage of Employer contributions and earnings/losses thereon. The Plan’s vesting schedule is as follows:

Less than 3 years	0%
3 years or more	100%

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions into the investment options offered under the Plan. Participants may change their investment selections at any time.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions (cont.)**

- g. **Notes receivable from participants** – Participants may borrow a minimum of \$500, up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding note receivable balance during the preceding year or one-half of the participant’s vested account on the date of the new loan is made. Note terms shall not extend beyond five years unless the loan is used for the purchase of a primary residence in which case loan terms can be extended up to 20 years. The notes are secured by the participant’s account. The interest rates for all loans will be equal to the Prime rate plus 2% and will be fixed for the duration of the loan.
- h. **Payment of benefits** – Upon retirement, death, disability, or termination, a participant may elect to have their account paid in a lump sum payment or in the form of an annuity. If the participant’s account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution equal to or less than \$5,000 that is made to a participant without the participant’s consent will be rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are available to participants who attain age 59½, who meet certain hardship requirements, or at any time from their rollover contribution account.
- i. **Corrective distributions** – The Plan failed the actual deferral percentage test for the years ended December 31, 2024 and 2023. As a result, corrective distributions in the amount of \$18,352 and \$34,005 are recorded as a liability on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, respectively, and as a reduction of participant contributions on the accompanying statement of changes in net assets available for benefits. These corrective distributions were refunded to the applicable participants in March 2025 and March 2024, respectively.
- j. **Termination of the Plan** – Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuations and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for disclosure of fair value measurements.

Notes to Financial Statements

December 31, 2024 and 2023

2. **Summary of Significant Accounting Policies (cont.)**

Purchases and sales of securities are recorded on a trade-date basis. Interest on notes receivable from participants and investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Administrative expenses charged to the Plan are allocated to the participants' accounts. Fees related to loans and distributions are charged directly to the participants' accounts. Certain other administrative expenses paid by the Employer are excluded from these financial statements.

3. **Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive guaranteed investment contract ("GIC") with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include any Employer originated transfer or distribution out of the contract. Any Employer originated transfer or distribution, including termination of the contract, will be subject to either 12 months advance notice or a 5% surrender charge.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan, and was not subject to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$18,491,789 and \$16,038,861 as of December 31, 2024 and 2023, respectively.
- b. Total investment income as shown on the accompanying statement of changes in net assets available for benefits of \$2,166,587 for the year ended December 31, 2024.
- c. All investment transactions that occurred during the year ended December 31, 2024.
- d. All information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

5. Fair Value Measurements (cont.)

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Common collective trust funds: These investments are stated at fair value based on the net asset value ("NAV") of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the "Plan Document"), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Notes to Financial Statements**December 31, 2024 and 2023****7. Parties-in-Interest Transactions**

The Plan is invested in a GIC with Empower Annuity Insurance Company of America who serves as trustee of the Plan, and the Plan pays for their services. Nova 401(k) Associates Inc. provides third-party administrative services to the Plan, and the Plan pays for their services. Stephens Group Asset Management, LLC and LeafHouse Financial Advisors, LLC serve as investment advisors to the Plan, and the Plan pays for their services. These service providers are by definition parties-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through August 4, 2025, which is the financial statement issuance date.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Anthony Timberlands, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institutions").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audits of the Financial Statements section of our report. Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audits does not affect management’s responsibility for the financial statements.

1. Summary of Significant Plan Provisions

The following description of the Anthony Timberlands, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Anthony Timberlands, Inc., Anthony Wood Treating, Inc., Bank of Bearden, Anthony Hardwood Composites, Inc., Anthony Oak Flooring, Inc., and JEA Lands Limited Partnership (collectively, the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Employees who are not a nonresident alien or a member of a collective bargaining unit are eligible to participate in the Plan immediately after attaining age 18 and completing six months of service. Plan entry dates are the first day of the Plan year or first day of the 7th month of the Plan year coinciding with or next following the date the eligibility requirements are met.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and rollover contributions. Participants may defer amounts up to the Internal Revenue Service (“IRS”) elective deferral limit. The Employer may make discretionary matching contributions to the Plan. For the year ended December 31, 2024, no such Employer discretionary contributions were made.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – The benefits attributable to a participant shall be fully vested upon retirement, death, or disability. If a participant terminates employment other than because of their death, disability, or retirement, they are entitled to the total value of their own contributions and earnings/losses thereon, plus a vested percentage of Employer contributions and earnings/losses thereon. The Plan’s vesting schedule is as follows:

- f. **Investment options** – Upon enrollment in the Plan, a participant may direct contributions into the investment options offered under the Plan. Participants may change their investment selections at any time.

- g. **Notes receivable from participants** – Participants may borrow a minimum of \$500, up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding note receivable balance during the preceding year or one-half of the participant’s vested account on the date of the new loan is made. Note terms shall not extend beyond five years unless the loan is used for the purchase of a primary residence in which case loan terms can be extended up to 20 years. The notes are secured by the participant’s account. The interest rates for all loans will be equal to the Prime rate plus 2% and will be fixed for the duration of the loan.
- h. **Payment of benefits** – Upon retirement, death, disability, or termination, a participant may elect to have their account paid in a lump sum payment or in the form of an annuity. If the participant’s account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution equal to or less than \$5,000 that is made to a participant without the participant’s consent will be rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are available to participants who attain age 59½, who meet certain hardship requirements, or at any time from their rollover contribution account.
- i. **Corrective distributions** – The Plan failed the actual deferral percentage test for the years ended December 31, 2024 and 2023. As a result, corrective distributions in the amount of \$18,352 and \$34,005 are recorded as a liability on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, respectively, and as a reduction of participant contributions on the accompanying statement of changes in net assets available for benefits. These corrective distributions were refunded to the applicable participants in March 2025 and March 2024, respectively.
- j. **Termination of the Plan** – Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuations and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value as disclosed in Note 3. See Note 5 for disclosure of fair value measurements.

2. **Summary of Significant Accounting Policies (cont.)**

Purchases and sales of securities are recorded on a trade-date basis. Interest on notes receivable from participants and investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Administrative expenses charged to the Plan are allocated to the participants' accounts. Fees related to loans and distributions are charged directly to the participants' accounts. Certain other administrative expenses paid by the Employer are excluded from these financial statements.

3. **Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive guaranteed investment contract ("GIC") with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower Annuity Insurance Company of America is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include any Employer originated transfer or distribution out of the contract. Any Employer originated transfer or distribution, including termination of the contract, will be subject to either 12 months advance notice or a 5% surrender charge.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan, and was not subject to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$18,491,789 and \$16,038,861 as of December 31, 2024 and 2023, respectively.
- b. Total investment income as shown on the accompanying statement of changes in net assets available for benefits of \$2,166,587 for the year ended December 31, 2024.
- c. All investment transactions that occurred during the year ended December 31, 2024.
- d. All information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

5. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

5. Fair Value Measurements (cont.)

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

Common collective trust funds: These investments are stated at fair value based on the net asset value ("NAV") of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. **Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the "Plan Document"), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Notes to Financial Statements**December 31, 2024 and 2023****7. Parties-in-Interest Transactions**

The Plan is invested in a GIC with Empower Annuity Insurance Company of America who serves as trustee of the Plan, and the Plan pays for their services. Nova 401(k) Associates Inc. provides third-party administrative services to the Plan, and the Plan pays for their services. Stephens Group Asset Management, LLC and LeafHouse Financial Advisors, LLC serve as investment advisors to the Plan, and the Plan pays for their services. These service providers are by definition parties-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through August 4, 2025, which is the financial statement issuance date.
