## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
Crestwood Operations LLC 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Crestwood Operations LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of November 14, 2024, and December 31, 2023, the related statement of changes in net assets available for benefits (in liquidation), for the year ended November 14, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 14, 2024, and December 31, 2023, and for the year ended November 14, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

### ***Basis for Opinion***

#### NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Crestwood Operations LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan’s provisions, which is available from Plan management.

##### ***General***

The Plan is a defined contribution plan that provides eligible employees of Crestwood Operations LLC (the “Plan Sponsor”) with future retirement benefits through a tax-deferred savings program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### ***Contributions***

Each year, participants may make pre-tax contributions up to 90% of compensation, subject to the current year’s statutory limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans, as defined in the Plan. Participants direct the investment of their contributions as well as the Plan Sponsor’s contributions into various investment options offered by the Plan. For eligible non-union employees, the Plan Sponsor contributes 100% of the employees’ elective deferrals, and for eligible union employees the Plan Sponsor contributes 25% of employees’ elective deferrals, in both cases not to exceed 6% of eligible compensation that a participant contributes to the Plan. At the discretion of the Plan Sponsor there may be certain additional Non-Elective Contributions subject to a vesting schedule. Contributions are subject to certain limitations. There were no participant contributions to the Plan for the plan year ended November 14, 2024.

##### ***Participant Accounts***

Each participant account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are 100% vested immediately in their contributions, rollover contributions, the Plan Sponsor’s safe harbor and Qualified Non-Elective (QNEC) contributions and allocated earnings or losses thereon. For union employees, the Plan Sponsor’s contributions are fully vested after one year of service. See Plan Termination note.

##### ***Forfeited Accounts***

The Plan allows the forfeitures of nonvested additional and nonelective Plan Sponsor matching contributions from terminated participant accounts to be used to offset future Plan Sponsor matching contributions or to pay certain administrative expenses.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

#### ***Payment of Benefits***

Distributions to participants or their beneficiaries are made in a lump sum payment upon separation of service due to death, disability, retirement or termination of employment.

#### ***Expenses of the Plan***

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants account and are included in administrative expenses. Investment related expenses are reflected as a reduction in investment returns. The Plan has entered into a revenue sharing agreement related to certain investments offered by the Trustee.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP). Effective November 2, 2023, the Crestwood Operations, LLC Board of Directors adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of November 14, 2024, have been prepared on the liquidation basis, in accordance with US GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimate net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of November 14, 2024, would be fair value. There were no material changes to the 2024 financial statements as a result of the change under the liquidation basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of November 14, 2024,

and December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits paid directly to participants are recorded when paid.

#### ***Subsequent Events***

In preparing the accompanying financial statements, Plan management has reviewed all known events that have occurred after November 14, 2024, and through July 10, 2025, which is the date the financial statements were available to be issued, for inclusion in the financial statements and footnotes.

### **NOTE 3: INVESTMENTS AND RELATED INVESTMENT INCOME (CERTIFIED BY THE TRUSTEE)**

Information presented in the accompanying financial statements and supplementary information, including investments held as of November 14, 2024, and December 31, 2023, and related investment income for the year ended November 14, 2024, was obtained or derived from the information certified by Empower Trust Company, LLC, the trustee of the Plan (Trustee), as permitted by the election made by the Plan Administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, (FASB ASC 820) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023. There were no investments at November 14, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable income fund:* Valued at the NAV of the underlying fund determined on the valuation date. Redemptions from the underlying funds may be made each business day, subject to certain restrictions by the Trustee. The stable income fund consists of The Columbia Trust Stable Income Fund that is a common collective trust fund investing in fixed income instruments, stable income investment contracts issued by various banks, life insurance companies and other financial institutions and in units of collective investment funds with investment objectives similar to those of the Fund. The underlying fund's investment objective is to preserve principal while maximizing current income. The Fund does not have unfunded commitments or significant restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

The Plan does not hold any notes receivable on participant loans as of November 14, 2024, which qualify as party-in-interest transactions. The Plan was terminated effective November 2, 2023.

#### NOTE 7: PLAN TAX STATUS

The Plan has adopted a prototype 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, in which the IRS stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code (IRC) and therefore not subject to tax. Plan management believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan was terminated effective November 2, 2023.

#### NOTE 8: PLAN TERMINATION

By action of its Board of Directors, Crestwood Operations, LLC terminated the Plan effective November 2, 2023. Upon termination, all participant accounts became 100% vested. The net assets were fully distributed to participants by November 14, 2024. Participants elected a lump sum payment or an individual retirement account rollover.
